Note by the Secretary-General

- 1. At its eighty-fifth session, the Committee on the Elimination of Racial Discrimination considered copies of reports and other documentation relating to Trust and Non-Self-Governing Territories submitted to it in 2014 in accordance with decisions of the Trusteeship Council and the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples, in conformity with article 15 of the International Convention on the Elimination of All Forms of Racial Discrimination. The Committee's expressions of opinion and recommendations¹ were submitted to the General Assembly at its seventieth session in accordance with article 15 (3) of the Convention, as well as to the United Nations bodies concerned.
- 2. At its 2014 session, the Special Committee continued to follow the work of the Committee on the Elimination of Racial Discrimination and to monitor related developments in the territories, having regard to the relevant provisions of article 15 of the Convention.²
