

Note by the Secretary-General *

Annotations

1. Opening of the session

The representative of the Secretary-General will open the thirteenth session of the Committee on the Rights of Persons with Disabilities.

2. Solemn declaration by the newly elected members of the Committee

In accordance with rule 14 of the rules of procedure, new members of the Committee shall make the following solemn declaration:

"I solemnly declare that I will perform my duties and exercise my powers as a member of the Committee on the Rights of Persons with Disabilities honourably, faithfully, impartially and conscientiously."

3. Election of the Chairperson and other officers of the Committee

In accordance with rule 15 of the rules of procedure, the Committee shall elect from amongst its members a chairperson, three vice-chairpersons and a rapporteur. In accordance with rules 16 and 17, the officers of the Committee shall be elected for a term of two years

and elections shall be held by secret ballot, unless the Committee decides otherwise in the case of an election to fill a place for which there is only one candidate.

4. Adoption of the agenda

Under rule 9 of the Committee's rules of procedure, the first item on the agenda of any session shall be the adoption of the agenda, unless the election of officers is required under rule 20. In accordance with rule 10, the Committee may revise the agenda during a session and may, as appropriate, add, defer or delete items.

5. Report of the Chairperson on activities undertaken between the twelfth and thirteenth sessions of the Committee

Under this item, the Committee will hear the report of the Chairperson on activities undertaken between the twelfth and thirteenth sessions.

6. Organizational matters

Under this item, the Committee will consider matters concerning the organization of the current session, in particular the adoption of its programme of work, a draft of which is contained in the annex.

7. Submission of reports by States parties under article 35 of the Convention

Under this item, the Committee will be updated on the reports received from States parties under article 35 of the Convention. As of the issuance of the present provisional agenda, the following initial reports have been received and are pending consideration by the Committee:

8. Adoption of the biennial report (2013-2014) to the General Assembly and to the Economic and Social Council

Under this item and in accordance with rule 35 of its rules of procedure, the Committee will adopt the biennial report to the General Assembly and to the Economic and Social Council.

Consideration of reports submitted by States parties under article 35 of the Convention

At its thirteenth session, the Committee will consider the initial reports received from the following States parties: Cook Islands, Croatia, Czech Republic, Dominican Republic, Germany, Mongolia and Turkmenistan.

In pursuance of established practice and in conformity with rule 41 of the rules of procedure, the Secretary-General has informed the States parties concerned of the tentative dates on which their reports have been scheduled for consideration by the Committee. A schedule for the consideration of reports submitted is set forth in the tentative programme of work annexed hereto.

10. Adoption of lists of issues on State party reports

The Committee will adopt lists of issues on initial reports.

11. Cooperation with other United Nations bodies, specialized agencies, organizations of persons with disabilities and other competent bodies

The Committee will discuss how to strengthen cooperation with United Nations bodies, specialized agencies, non-governmental organizations, including organizations of persons with disabilities and other competent bodies, in order to enhance the promotion and protection of the rights of persons with disabilities. Representatives of such organizations and bodies may seek to address the Committee under this item.

12. General comments and days of general discussion

The Committee will review the progress of work of the working groups established to draft the general comments decided by the Committee. The Committee has decided to establish working groups on women with disabilities (art. 6), the right to independent living and to be included in the community (art. 19) and the right to education (art. 24). Also under this item, the Committee will hold a day of general discussion on the right to education.

13. Methods of work of the Committee

Under this item, the Committee will further consider its working methods.

14. Future meetings

The Committee will be informed of any developments relating to its future meetings. It will also consider the organization of its future work.

15. Treaty body strengthening: implementation of General Assembly resolution 68/268

Under this item, the Committee will further consider the implementation of General Assembly resolution 68/268 on strengthening and enhancing the effective functioning of the human rights treaty body system.

16. Activities under the Optional Protocol

The Committee will consider the complaints submitted under the Optional Protocol to the Convention and the conduct of inquiries.

17. Adoption of the report on the thirteenth session

Under this item and pursuant to rule 38 bis of the Committee's rules of procedure, the Committee may consider and proceed to adopt the report on the thirteenth session of the Committee.
