At its organizational session for 2006, the Council approved the provisional agenda for its substantive session (Council decision 2006/208).

In accordance with General Assembly resolution 50/227, annex I, the Council will have before it a note by the Secretary-General on the proposed theme for the high-level segment of the substantive session of 2007 of the Council.

A. High-level segment

In accordance with General Assembly resolution 48/162, the Council will devote the first day of the high-level segment to a high-level policy dialogue with the executive heads of international trade and finance institutions on key issues of the global economy (see also General Assembly resolution 50/227).

2. Creating an environment at the national and international levels conducive to generating full and productive employment and decent work for all, and its impact on sustainable development

The Council will have before it a report of the Secretary-General on the theme (Council decision 2005/313). The report, prepared in collaboration with the International Labour Organization (ILO), will incorporate inputs from a number of other relevant United Nations organizations and draw upon the outcomes of the special preparatory round tables of the Council, held on 4 and 5 April 2006, and of the "NGO Forum", sponsored by the NGO Section of the Department of Economic and Social Affairs, held on 6 and 7 April 2006.

The Council will also have before it the *World Economic and Social Survey, 2006*, prepared pursuant to General Assembly resolutions 118 (II) and 52/180 and Council resolution 1983/50, and the relevant part of the report of the Committee for Development Policy on its eighth session (Council resolution/decision 2005/306).

The Council will have before it the relevant part of the report of the Secretary-General on regional cooperation (Council decision 2004/323)

B. Operational activities of the United Nations for international development cooperation segment

3. Operational activities of the United Nations for international development cooperation

(a) Follow-up to policy recommendations of the General Assembly and the Council¹

At its fifty-ninth session, in paragraph 22 of its resolution 59/250, the Assembly requested the Secretary-General to improve the *annual* statistical compendium to the operational activities segment of the Council by adding a multi-year perspective, fully incorporating available information and statistics.

At its substantive session of 2005, the Council also requested the Secretary-General to make use of the *annual* statistical compendium on operational activities for development submitted to the Council at its operational activities segment of its substantive session in its new format, adopted in accordance with paragraph 22 of General Assembly resolution 59/250. The compendium will include a better distinction between contributions made for humanitarian assistance and long-term development cooperation (Council resolution 2005/7, para. 9).

Also at its fifty-ninth session, in paragraph 23 of its resolution 59/250, the General Assembly requested the Council to undertake triennially, as of 2006, a comprehensive review of trends and perspectives in funding for development cooperation.

At its substantive session of 2005, the Council requested the Secretary-General, in response to paragraph 102 of General Assembly resolution 59/250, to update the matrix contained in the report of the Secretary-General (E/2005/58) on the management process for the implementation of the above resolution, including analytical reporting on results and outcomes achieved through the implementation of all actions outlined in the management process (Council resolution 2005/7, para. 3).

At its organizational session for 2006, the Council decided that the work of the operational activities segment of its substantive session of 2006 should be devoted to examining the operational activities of the United Nations system in order to evaluate implementation of General Assembly resolution 59/250, with a view to ensuring its full implementation, including through a comprehensive review of

trends and perspectives in funding for development cooperation, and in this context decided to apply Assembly decision 60/545 (Council decision 2006/215).

At its substantive session of 1998, the Council invited the Secretary-General to arrange for the submission by the executive heads of the United Nations funds and programmes, in consultation with the United Nations Development Group, to the Council at its *annual* substantive session, of a concise consolidated list of issues that are central to the improved coordination of operational activities and on which the funds and programmes seek consideration by and guidance from the Council, in particular in regard to the triennial policy review, and to include in the list recommendations whenever possible (Council resolution 1998/27, para. 4).

(b) Reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund, the United Nations Children's Fund and the World Food Programme

The Council will also have before it the reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund, the United Nations Children's Fund and the World Food Programme, as well as the annual reports of the four funds and programmes. The reports include a thorough analysis of problems encountered and lessons learned, with emphasis on issues arising from the implementation of the Secretary-General's reform programme, the triennial comprehensive policy review and the follow-up to international conferences, so as to allow the Council to fulfil its coordinating role (General Assembly resolutions 48/162 and 53/192 and Council resolutions 1994/33 and 1995/51).

At its fifty-ninth session, the General Assembly invited the executive boards and governing bodies of the funds, programmes and the specialized agencies to assess regularly the progress achieved in the area of simplification and harmonization of rules and procedures, and requested the funds and programmes to provide, in their annual reports to the Council, specific information on the progress achieved in that area (General Assembly resolution 59/250, paras. 38 and 39).

4. Sustained economic growth for social development, including the eradication of poverty and hunger

At its substantive session of 2005, in its decision 2005/221, the Council adopted the following theme for its 2006 coordination segment: "Sustained economic growth for social development, including the eradication of poverty and hunger". The Council further decided to continue consultations on a multi-year work programme for the coordination segment, with a view to finalizing the work programme before the beginning of its substantive session of 2006.

The Council will have before it the report of the Secretary-General on the mandated theme.

D. Humanitarian affairs segment

5. Special economic, humanitarian and disaster relief assistance

At its organizational session for 2006, the Council decided that the theme of the humanitarian affairs segment of its substantive session of 2006 would be, "Strengthening of the coordination of United Nations humanitarian assistance: implementing improved humanitarian response at all levels, including strengthening capacity, with particular attention to recent humanitarian emergencies, including severe natural disasters", and that it would convene two panels, the themes of

which would be, "Gender-based violence in humanitarian emergencies" and "Chronically underfunded emergencies" (Council decision 2006/214).

At its sixtieth session, the General Assembly:

- By its resolution 60/13, requested the Secretary-General to report to it on strengthening emergency relief, rehabilitation, reconstruction and prevention in the aftermath of the South Asian earthquake disaster Pakistan, under the item entitled "Strengthening of the coordination of humanitarian and disaster relief assistance of the United Nations, including special economic assistance" and to report to the Council at its substantive session in 2006;
- By its resolution 60/15, requested the Secretary-General to report to it at its sixty-first session on strengthening emergency relief, rehabilitation, reconstruction and prevention in the aftermath of the Indian Ocean tsunami disaster under the item entitled "Strengthening of the coordination of humanitarian and disaster relief assistance of the United Nations, including special economic assistance", through the Council at its substantive session in 2006;
- By its resolution 60/124, decided to upgrade the current Central Emergency Revolving Fund into the Central Emergency Response Fund, encouraged the Council to discuss implementation of the Fund and requested the Secretary-General to report to it and to the Council on the detailed use of the Fund. In the same resolution, the Assembly requested the Secretary-General to report to it at its sixty-first session, through the Council at its substantive session of 2006, on progress made in strengthening the coordination of emergency humanitarian assistance of the United Nations. See also Council resolution 2005/4;
- By its resolution 60/220, requested the Secretary-General to report to it, through the Council, at the humanitarian affairs segment of its substantive session of 2006, on humanitarian assistance and rehabilitation for El Salvador and Guatemala and on progress made in the relief, rehabilitation and reconstruction efforts of the affected countries.

In accordance with Council resolution 1983/46, the Secretary-General orally apprises the Council *annually* on the status of the assistance to the drought-stricken areas of Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Uganda.

At its substantive session of 2005, the Council took note of the report of the Secretary-General on the role of the Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits (E/2005/61) and decided to continue to take the necessary steps for the effective implementation of the provisions of General Assembly resolutions 50/227, 52/12 B and 57/270 B, which are relevant to the work of the Council and its subsidiary machinery. The Council will have before it the report of the Secretary-General on the progress made in the implementation of Assembly resolutions 50/227, 52/12 B and 57/270 B (Council resolution 2005/48). See also under item 8 and chapeau of items 13 and 14.

The Council will have before it the report of the Secretary-General on the modalities of the inter-agency coordination of the implementation of the outcomes of the World Summit on the Information Society, including recommendations on the follow-up process (see Tunis Agenda for the Information Society (WSIS-05/TUNIS/DOC/6 (Rev.1)-E, para. 104), adopted at the World Summit on the Information Society, held in Tunis, 16-18 November 2005).

At its sixtieth session, the General Assembly resolved to continue to make full use of the existing institutional arrangements for reviewing the implementation of the Monterrey Consensus as set out in paragraph 69 of the Consensus and in line with General Assembly resolution 57/270 B, including the high-level dialogues convened by the Assembly and the spring meetings of the Council with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development (New York, 24 April 2006) (General Assembly resolution 60/188).

The report is submitted to the General Assembly, through the Council in response to paragraph 111 of the Programme of Action for the Least Developed Countries for the Decade 2001-2010 (see Council decision 2001/320).

At its sixty-first session, the General Assembly will convene a high-level meeting on the midterm comprehensive global review of the implementation of the Programme of Action in New York on 19 and 20 September 2006. In a separate report, the Secretary-General will report on the midterm comprehensive global review to the Assembly at its sixty-first session (General Assembly resolution 60/228).

7. Coordination, programme and other questions

(a) Reports of coordination bodies

The Council will consider the relevant sections of the proposed strategic framework for the biennium 2008-2009 (Council resolution 1988/77 and General Assembly resolution 58/269).

(c) International cooperation in the field of informatics

At its substantive session of 2005, the Council requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one more year to enable it to carry out, from within existing resources, the due fulfilment of the provisions of the Council resolutions on that item, to facilitate the successful implementation of the initiatives being taken by the Secretary-General with regard to the use of information technology and to continue the implementation of measures required to achieve its objectives, and requested the Secretary-General to report to the Council at its substantive session of 2006 on the action taken to follow up on the need to harmonize and improve United Nations informatics systems for optimal utilization and accessibility by all States, including the findings of the Working Group and an assessment of its work and mandate (Council resolution 2005/12).

The report will be submitted to the General Assembly through the Commission on the Status of Woman and the Council, in response to Council resolution 2005/31 and General Assembly resolution 60/140. The Council will also have before it a separate report of the Secretary-General on progress made and further steps in gender mainstreaming in the United Nations system (Council resolution 2005/31).

At its substantive session of 2004, the Council decided to undertake a further assessment of lessons learned from the experience of the ad hoc advisory groups, including progress made in the implementation of their mandate, during the substantive session of 2006, and requested the Secretary-General to report to it in this regard (Council resolution 2004/59).

At its substantive session of 2005, the Council decided, in the light of the current situation in Guinea-Bissau, to extend the mandate of the Ad Hoc Advisory Group on Guinea-Bissau until the substantive session of 2006, with the understanding that the decision on whether to renew its mandate will be based on the Council's consideration of the report of the Ad Hoc Advisory Group, which should be submitted no later than six weeks before the start of the 2006 substantive session, and the situation prevailing in Guinea-Bissau at that time (Council resolution 2005/32).

Also, at its substantive session of 2005, the Council requested the Ad Hoc Advisory Group on Burundi to report to it at its substantive session in 2006. The Council also decided that the work of the Ad Hoc Advisory Group will be reviewed at the substantive session of 2006, with a view to considering whether to continue the mandate of the Advisory Group, based on the Council's consideration of its report, which should be submitted no later than six weeks before the start of the substantive session of 2006, and of the situation prevailing in Burundi at that time (Council resolution 2005/33).

10. Regional cooperation
