Chapter I

Matters calling for action by the Economic and Social Council or brought to its attention

A. Draft resolution for adoption by the Council

1. The Statistical Commission recommends to the Economic and Social Council the adoption of the following draft resolution:

Strengthening statistical capacity*

The Economic and Social Council,

Deeply concerned that (a) there still exists in many countries a lack of adequate data to (i) assess national trends in the context of monitoring progress towards the realization of all the internationally agreed development goals, including the Millennium Development Goals, and (ii) inform and monitor the implementation of national development policies and strategies, and (b) in many countries where data do exist, there is lack of capacity to use them and, in certain cases where country data are available, they are not used to the extent possible,

Affirming that without a coordinated effort to enhance and sustain statistical capability in many developing countries and countries with economies in transition, effective monitoring of progress towards national as well as internationally agreed development goals, including the Millennium Development Goals, is being compromised,

Recognizing the fundamental importance of sustainable national statistical capacity to produce reliable and timely indicators of a country's progress,

Expressing its concern about the validity of the use by international agencies of imputed data, particularly when there is a lack of transparency in their methodology,

Recalling its resolution 2000/27 of 28 July 2000, in which it reaffirmed the importance of national efforts to build statistical capacity in all countries, including through statistical training, and of effective international support in this context for developing countries and countries with economies in transition,

Further recalling its resolution 2005/13 of 22 July 2005, in which it noted the critical importance of the 2010 round of population and housing censuses for meeting data needs for the follow-up activities to the international conferences and summits, including the Millennium Summit,

Stressing that all review and follow-up processes of the major United Nations conferences and summits in the economic, social and related fields must focus on the progress made in the implementation of commitments,

Reiterating the need for continued efforts by the Statistical Commission to further improve the list of indicators on implementation of the outcomes of the major United Nations conferences and summits in the economic, social and related fields, including by means of methodological and technical refinement of the existing indicators,

Further reiterating the need to apply and further develop indicators on means of implementation to evaluate progress towards conference goals in creating an enabling environment for development,

- 1. Calls on Member States to intensify their efforts to strengthen national statistical capacity in order to produce reliable and timely statistics and indicators for the monitoring of:
 - (i) National development policies and strategies;
 - (ii) The implementation of commitments and the achievement of all development goals at the national, regional and international levels;
- 2. Calls upon the United Nations system, including the United Nations Statistics Division and the regional commissions and international agencies to support national efforts in building and strengthening national statistical capacity, in particular of developing countries;
- 3. *Encourages* the strengthening of statistical capacity of the relevant international agencies;
- 4. *Urges* donor countries and organizations and the international and regional statistical community to support developing countries and countries with economies in transition in strengthening statistical capacity in support of development. They should largely build upon existing national, regional and international initiatives in a coordinated manner and encourage other initiatives to address significant gaps that might emerge;
- 5. Calls on all international agencies, through the Inter-Agency and Expert Group on Millennium Development Goals Indicators, under the coordination of the United Nations Statistics Division and in accordance with the guidance provided by Member States through the Statistical Commission, to improve the coverage, transparency, and reporting on all indicators in order to enhance the database on all Millennium Development Goals, including through:
- (a) Defining priorities and developing a strategy to improve data for all indicators:
- (b) Identifying ways, including through capacity-building where needed to improve countries' reporting on all MDGs;
- (c) Avoiding imputation unless specific country data are available for reliable imputations following consultations with concerned countries and through transparent methodologies;

- (d) Ensuring that the supporting metadata complies with guidelines developed by an expert panel constituted by the Statistical Commission for that purpose, and in this regard requests the Secretariat to forward recommendations to the Statistical Commission for consideration and adoption;
- 6. Requests the Secretary-General to report on the implementation of the present resolution in the context of the regular report on statistical capacity-building to be presented under the relevant agenda item for discussion by the Statistical Commission at its thirty-eighth session.

C. Decisions brought to the attention of the Council

3. The following decisions adopted by the Commission are brought to the attention of the Council:

37/101

Programme review: industrial statistics

- (a) Welcomed the report of the programme reviewer on industrial statistics¹ and noted its appreciation of the work carried out by Japan;
- (b) Agreed with the recommendations set out in the report relating to data collection standards, data dissemination standards, training and capacity-building and international coordination;
- (c) Endorsed the work carried out by the United Nations Statistics Division on the revision of statistical standards, for the recommendations for industrial statistics and index numbers of industrial production;
- (d) Requested the Division to prepare a position paper on the abovementioned recommendations, describing institutional arrangements, deliverables, timetables and consequences of implementing the recommendations, and to submit the paper to the Statistical Commission at its thirty-eighth session;

(e) Noted that the integration of industrial statistics with other statistics, such as services statistics, needed to be improved in that process, and supported the creation of an integrated economic statistics programme and, as a first step, proposed the preparation of a concept paper for further discussion under item 3 (c) of the agenda.

Distributive trade statistics

The Statistical Commission:

- (a) Took note of the report of the Secretary-General on distributive-trade statistics,² endorsed broadly the initiative and strategy of the United Nations Statistics Division to revise the existing recommendations in that area of statistics, and advised that the revision process be carried out in close consultation with national statistical offices in order to reflect fully the specific needs and circumstances of various groups of countries in general and the needs of countries with a substantial informal sector in particular;
- (b) While endorsing the plans of the Division to compile distributive-trade statistics on a worldwide basis and to build a corresponding database on distributive-trade statistics, cautioned that the level of detail requested for international reporting should be commensurate with country needs and capacity to compile and requested the Division to review existing international databases in that area of statistics to avoid creating an additional reporting burden on countries and duplication of work among international organizations;
- (c) Advised the Division to develop practical guidance on compilation of distributive-trade statistics, including description of good practices, and conduct technical assistance activities in that area as a matter of priority;
- (d) Requested the Division to submit a progress report to the Commission at its thirty-eighth session and revised draft recommendations at its thirty-ninth session for approval.

Integrated economic statistics

- (a) Welcomed the report of the Secretary-General on integrated economic statistics³ and endorsed strongly the concept of an integrated economic statistics approach as the appropriate strategy for the development of national and international economic and financial statistics programmes from both user and producer perspectives;
- (b) Recommended that the concept of an integrated approach to national economic statistics programmes be operationalized, including by:

- (i) Identifying the building blocks, such as business registers, economic censuses, structural and short-term business statistics across economic activities and class sizes, collections through business and household surveys, use of administrative sources, area sampling, classifications, data processing and institutional aspects;
- (ii) Formulating priorities reflecting country and regional policy needs;
- (iii) Developing appropriate institutional arrangements to ensure necessary coordination among national and regional organizations involved in the compilation of economic statistics;
- (c) Recommended also the establishment of a friends of the chair, consisting of Member States and international organizations, to prepare a concept paper on the modalities of the integrated approach to economic statistics, including the feasibility of establishing a mechanism for improving coordination among international organizations and work groups engaged in economic statistics.

National accounts

- (a) Commended the progress made in the updating of the *System of National Accounts, 1993* in the issues-oriented phase of the update process, as reflected in the report of the Intersessional Working Group on National Accounts,⁴ acknowledged the focused contributions and expertise provided by a wide range of countries and organizations to the work of that phase and expressed confidence in the Working Group in maintaining the momentum in the drafting and review phases of the update process in 2006 and 2007;
- (b) Attributed the commendable progress in the update of the *System of National Accounts, 1993* to the adoption of the project management approach and the extensive use of a transparent interactive website, and recommended that approach and technology in similar statistical projects and programmes;
- (c) Welcomed the inclusion of a chapter on the measurement of informal sector activities in the revision of the *System of National Accounts*, 1993;
- (d) Took note of the concerns on the treatment of unfunded government pension schemes and the need for continuing consultations on the recommendation of the Advisory Group on National Accounts on that issue, and expressed its positive outlook on a timely resolution within the existing governance structure of the Working Group;
- (e) Recommended that the Working Group continue to include the treatment of social services of government in its research agenda;
- (f) Recognized the need for adequate response to requests from Member States for assistance in capacity-building for the implementation of the revision of the *System of National Accounts*, 1993, and accepted the proposal by the Working

Group to prepare a programme of implementation to be available to the Commission by 2008.

37/105

International economic and social classifications

- (a) Took note of the report of the Secretary-General on international economic and social classifications,⁵ adopted the structures of the International Standard Industrial Classification of All Economic Activities, Revision 4 and the Central Product Classification, Version 2, as presented to the Commission, recommended that those classifications be recognized as the international standards for economic activity and product classifications respectively, and commended the work by the Expert Group on International Economic and Social Classifications, its Technical Subgroup and the United Nations Statistics Division in revising those classifications:
- (b) Agreed with the recommendation that countries should adapt their national classifications so as to be able to report data at least at the two-digit level of the International Standard Industrial Classification of All Economic Activities without loss of information;
- (c) Requested further elaboration on the plan for implementing the International Standard Industrial Classification of All Economic Activities and the Central Product Classification and its resource implication and requested also that the United Nations Statistics Division formulate a plan of work for presentation to the Commission at its thirty-eighth session;
- (d) Noted the explanation of the processes required by the International Labour Organization for approval of the International Standard Classification of Occupations, which was planned for completion in 2008, reaffirmed its confidence in those processes, as implied in its decisions at its thirty-fourth, thirty-fifth and thirty-sixth sessions, welcomed the reassurance that, prior to its finalization, the new version of the International Standard Classification of Occupations, would be brought back to the Commission for consultation and advice, and noted also that that had been the essence of its recommendations made at its thirtieth session, held in 1999, by which it had instructed the Expert Group on International Economic and Social Classifications to review all statistical classifications for their adherence to best practice in classifications development prior to presenting them to the Commission, and agreed that the International Labour Organization should work collaboratively with the Expert Group, while respecting each other's mandates, to ensure the soundness of the new version of the International Standard Classification of Occupations;
- (e) Agreed not to pursue the creation of a correspondence between the Central Product Classification and the United Nations Standard Product and Services Code and recognized that further work needed to be done to assess the potential of the Central Product Classification for satisfying the statistical needs with regard to price statistics of the Ottawa Group on Price Indexes.

International Comparison Programme

The Statistical Commission:

- (a) Took note of the report of the World Bank on the International Comparison Programme⁶ and expressed appreciation of the significant progress in the Programme due to the leadership of the Executive Board of the Programme, the World Bank, the regional coordinating organizations and the dedication of participating national statistical offices;
- (b) Recommended that, for the purposes of transparency and data quality, the price and survey data from each region be subjected to review by the other regional coordinators;
- (c) Recommended that the estimation of purchasing power parities and the publication plans involve full consultation with the countries, without allowing restrictions for releasing the results;
- (d) Advised that the regional coordinators and the International Comparison Programme Global Office of the World Bank be cautious about the level of detail to be published in the preliminary reports. Several representatives stressed the importance of national policies and laws relating to the access of microdata;
- (e) Supported the continuation of the Programme as an ongoing programme to utilize the improved capacity in price data compilation and the established infrastructure and agreed with the recommendation of the Executive Board of the Programme that an evaluation of the 2005 round and a plan on the future of the Programme be submitted to the Commission at its thirty-eighth session;
- (f) Requested that efforts be increased for expanding the country coverage of the Programme, particularly in subregions where there had been low or no participation in the current round.

Environmental accounting

- (a) Took note of the report of the Secretary-General on environmental accounting⁷ and endorsed the long-term objectives, the programme of work and the governance structure of the United Nations Committee of Experts on Environmental-Economic Accounting;
- (b) Encouraged the Committee of Experts to establish a website, hosted by the United Nations Statistics Division, that would serve as a knowledge-based platform so as to facilitate exchanges of best practices and the use of environmentaleconomic accounts;
- (c) Requested the Committee of Experts to focus on the development and promotion of environmental accounting and to refine its working relationship with

the various groups responsible for the development of environmental, energy and related statistics.

37/108

Energy statistics

The Statistical Commission:

- (a) Took note of the following documents:
- (i) Report of the Secretary-General on energy statistics;⁸
- (ii) Report of Statistics Norway on quality components of oil statistics;⁹ and commended the progress made in the area of energy statistics;
- (b) Recognized the significance of energy statistics, recommended their development as part of official statistics, including consideration of the need for greater transparency in the documentation of metadata and emphasized the need for capacity-building and training of statisticians;
- (c) Supported the establishment and mandate of the Oslo Group on Energy Statistics and the Intersecretariat Working Group on Energy Statistics and requested proper coordination mechanisms between them;
- (d) Supported the review of the United Nations manuals on energy statistics and requested that the review be based on all relevant methodological work in energy statistics;
- (e) Emphasized the urgent need for harmonization of energy definitions and compilation methodologies and for the development of international standards in energy statistics;
- (f) Supported the establishment of a broadly based review team to propose common concepts and definitions, and requested that the United Nations Statistics Division submit the modalities of that review team to the Bureau of the Statistical Commission for approval.

Social statistics

The Statistical Commission, having welcomed the report of the Secretary-General on social statistics¹⁰ and endorsed the actions and strategies proposed in paragraphs 12 and 13 therein:

- (a) Emphasized the importance of statistical capacity-building and technical assistance as vehicles for improving gender statistics at the national level;
- (b) Requested that a follow-up be made to evaluate progress in the national production and reporting of gender statistics, recommended that such analysis and presentation of national statistical capacity display official national statistics to

better reveal data gaps, and requested also that the Millennium Development Goals indicators take that perspective into consideration;

- (c) Noted the importance of analysing trends in the situation of women and men and requested the Division to continue with that work;
- (d) Recognized that gender statistics units played an important role in promoting gender statistics in national statistical systems, but that many other approaches existed to advance gender statistics and, in all cases, it was important to ensure, inter alia:
 - (i) Better dialogue between users and producers of statistics;
 - (ii) Collaboration with agencies responsible for the advancement of women;
 - (iii) Training for both producers and users in the area of gender statistics;
- (e) Reiterated the importance of developing and improving basic sources of reliable data, such as civil registration and vital statistics systems, in countries or areas where they were deficient;
- (f) Underscored the need for development of concepts and methods relating to the assessment of gender differences in poverty and the measurement of domestic violence and violence against women.

Principles governing international statistical activities

- (a) Welcomed with appreciation the principles governing international statistical activities as presented in the report of the Secretary-General¹¹ and commended the work carried out by the international organizations involved in their elaboration:
- (b) Expressed its appreciation of the fact that, owing to data sharing among agencies, the implementation of the principles might reduce the burden on national statistical offices:
- (c) Noted that the Committee for the Coordination of Statistical Activities had recognized the importance of the principles in guiding the professional statistical activities of international agencies;
- (d) Noted also that the Committee had agreed that the principles could be used in different ways by agencies depending on their specific mandate and governance (legal framework);
 - (e) Requested the Committee to:
 - (i) Assess the implementation of the principles by organizations and report the results of the assessment to the Statistical Commission at its thirty-ninth session;

- (ii) Include in the preamble of the principles the description of the role of international organizations in the global statistical system and expand the best practices associated with the principles, in particular principle 6;
- (iii) Extend the adoption of the principles to subregional organizations.

Development indicators

- (a) Took note of the following documents:
- (i) Report of the Secretary-General on development indicators;¹²
- (ii) Report by the Friends of the Chair on Millennium Development Goal indicators; 13
- (b) Took note with appreciation of the efforts by the Inter-agency and Expert Group to improve the Millennium Development Goal indicators on an ongoing basis;
- (c) Took note also of the relevant recommendations of the Friends of the Chair, as contained in paragraphs 55-61 of the report, and stressed the importance of addressing those issues in the context of strengthening the statistical capacity-building of Member States, in particular of developing countries;
- (d) Recommended that international agencies turn to data imputation only when country data were not available and that should be done in consultation with countries and through a fully transparent methodology;
- (e) Recognized that the mechanisms for reporting data from national to international statistical systems should be improved;
- (f) Agreed that statistical capacity-building was the key step in improving the availability of data necessary for the monitoring of the Millennium Development Goals:
- (g) Agreed that the strengthening of statistical capacity be extended to subregional institutions;
- (h) Agreed that the process of assessing and supporting the building of country capacities to monitor the Millennium Development Goals was important and should continue;
- (i) Requested the Inter-agency and Expert Group to take into account the relevant recommendations of the Friends of the Chair to improve further the compilation of all the indicators and the monitoring of all the Millennium Development Goals and report back to the Commission at its thirty-eighth session;
- (j) Agreed that full consideration should be given to issues related to the production of indicators that were produced regularly by the national statistical systems for all the Millennium Development Goals.

 - (i) Expressed the need for greater data harmonization and enhanced collaboration with national statistical offices in the Survey;
 - (ii) Expressed the concern that the data collection methods of the Survey should be more sensitive to the different cultural circumstances of countries;
- (d) With reference to the Intersecretariat Working Group on Health Statistics:
 - (i) Took note of the special circumstances under which the first meeting of the Group had been organized and requested the World Health Organization to hold a second meeting with adequate representation of countries and agencies;
 - (ii) Recommended that the terms of reference of the Group be redrafted and submitted to the Statistical Commission at its thirty-eighth session for its approval;
 - (iii) Recommended that a workplan be developed taking into consideration the Budapest Initiative.

"Affirming that without a coordinated effort to enhance and sustain statistical capability in many developing countries and countries with economies in transition, effective monitoring of progress towards national as well as internationally agreed development goals, including the Millennium Development Goals, is being compromised,

"Recognizing the fundamental importance of sustainable national statistical capacity to produce reliable and timely indicators of a country's progress,

"Expressing its concern about the validity of the use by international agencies of imputed data, particularly when there is a lack of transparency in their methodology,

"Recalling its resolution 2000/27 of 28 July 2000, in which it reaffirmed the importance of national efforts to build statistical capacity in all countries, including through statistical training, and of effective international support in this context for developing countries and countries with economies in transition,

"Further recalling its resolution 2005/13 of 22 July 2005, in which it recognized the increasing importance of the 2010 round of population and housing censuses for meeting data needs for the follow-up activities to the international conferences and summits, including the Millennium Summit,

- "1. Calls upon Member States to intensify their efforts to strengthen national statistical capacity in order to produce reliable and timely statistics and indicators for the monitoring of national development policies and strategies and the internationally agreed development goals, including the Millennium Development Goals, as well as the fulfilment of commitments towards global cooperation for development;
- "2. Urges the United Nations system, including the Statistics Division of the Department of Economic and Social Affairs and the regional commissions and international agencies to support national efforts in building and strengthening national statistical capacity, in particular that of developing countries;

- "3. *Encourages* the strengthening of statistical capacity of international agencies involved in data compilation, analysis and dissemination;
- "4. *Urges* donor countries and organizations and the international and regional statistical community to support developing countries and countries with economies in transition in strengthening statistical capacity in support of development; they should build upon new and existing national, regional and international initiatives, in a coordinated manner, and also address significant gaps that might emerge;
- "5. Calls upon all international agencies, through the Inter-Agency and Expert Group on Millennium Development Goal Indicators, under the leadership of the Statistics Division and in accordance with guidance provided by Member States through the Statistical Commission, to improve the coverage and transparency of the existing Millennium Development Goal database, including on Goal 8, by (a) defining priorities and developing a strategy to improve data for indicators where data weaknesses are greatest, (b) identifying ways to improve countries' reporting to the international statistical system, (c) avoiding imputation unless specific country data are available to support reliable imputations through transparent methodologies, and (d) ensuring that the supporting metadata comply with guidelines developed by a panel of experts constituted for that purpose;
- "6. Requests the Secretary-General to report on the implementation of the present resolution in the context of the regular report on statistical capacity-building to be submitted under the relevant agenda item for discussion at the next session of the Statistical Commission."
- 79. At the 7th meeting, on 10 March, the representative of South Africa introduced a revised draft resolution, entitled "Strengthening statistical capacity", which was circulated in an informal paper.
