II. Annotations

1. Adoption of the agenda and other organizational matters

At its organizational session for 2007, the Council approved the provisional agenda for its substantive session (Council decision 2007/209).

At its organizational session for 2007, the Council decided to further defer its consideration of the draft annex on the privileges and immunities of the specialized agencies with respect to the World Tourism Organization to its substantive session of 2007 (Council decision 2007/205).

A. High-level segment

In accordance with General Assembly resolutions 48/162 and 61/16, the Council will hold a high-level policy dialogue with the executive heads of international financial and trade institutions during its high-level segment.

2. (a) Thematic discussion:

Strengthening efforts at all levels to promote pro-poor sustained economic growth, including through equitable macroeconomic policies;

(b) Annual ministerial review:

Strengthening efforts to eradicate poverty and hunger, including through the global partnership for development.

The Council will have before it the report of the Secretary-General on strengthening efforts at all levels to promote pro-poor sustained economic growth, including through equitable macroeconomic policies for the thematic discussion at the 2007 substantive session (Council decision 2007/206). The report will incorporate relevant inputs from a number of United Nations organizations with the aim of providing conceptual and policy background for deliberations on the theme.

In pursuance of paragraphs 155 and 156 of the 2005 World Summit Outcome, the General Assembly, in its resolution 61/16, decided that the Economic and Social Council should continue to promote global dialogue, inter alia, through strengthening existing arrangements, including a thematic discussion on a theme from economic, social and related fields to be decided by the Council and informed by a report of the Secretary-General. The Council will have before it a note by the Secretary-General on the theme for the thematic discussion of the high-level segment of the Economic and Social Council.

The Council will also have before it the report of the Secretary-General on strengthening efforts to eradicate poverty and hunger, including through the global partnership for development for the annual ministerial review (Council decision 2007/207), in pursuance of paragraph 155 of the 2005 World Summit Outcome (General Assembly resolution 60/1) and paragraph 8 of General Assembly resolution 61/16 on strengthening of the Economic and Social Council. The report will incorporate inputs from a number of relevant United Nations organizations and draw upon the outcome of the special preparatory round-table meeting of the Council to be held on 2 April 2007. The report will also provide policy recommendations for consideration by the Council.

The Council will also have before it the *World Economic and Social Survey 2007*, prepared pursuant to General Assembly resolutions 118 (II) and 52/180 and Council resolution 1983/50, and the relevant part of the report of the Committee for Development Policy on its ninth session (Council resolution 2006/1).

The Council will have before it the relevant part of the report of the Secretary-General on regional cooperation (Council decisions 2004/323 and 2007/217).

In paragraph 155 of the 2005 World Summit Outcome, the Council was mandated to hold a biennial high-level Development Cooperation Forum to review trends in international development cooperation. In paragraph 5 of its resolution 61/16, the General Assembly further requested the Council to consider launching the Forum during the high-level segment of its substantive session of 2007 and thereafter meeting in New York, starting in 2008.

B. Operational activities of the United Nations for international development cooperation segment

3. Operational activities of the United Nations for international development cooperation

(a) Follow-up to policy recommendations of the General Assembly and the Council

The General Assembly, in paragraph 103 of its resolution 59/250, requested the Secretary-General to submit to it at its sixty-second session, through the Council, a comprehensive analysis of implementation of the resolution in the context of the triennial policy review and to make appropriate recommendations.

The Council, at its substantive session of 2006, in paragraph 51 of its resolution 2006/14, requested the Secretary-General to focus the analysis of the triennial comprehensive policy review of 2007, within the context of the implementation of the internationally agreed development goals, including the Millennium Development Goals.

The General Assembly, in paragraph 22 of its resolution 59/250, requested the Secretary-General to improve the annual statistical compendium to the operational activities segment of the Council by adding a multi-year perspective, fully incorporating available information and statistics.

At its substantive session of 2006, the Council requested the Secretary-General, in order to enhance understanding of funding trends in the United Nations development system and humanitarian field, to further refine comprehensive statistical data on operational activities for development of the United Nations system contained in his annual report, with a view to promoting a concerted effort by entities of the United system to standardize data and statistical practices that reflect funding for operational activities for development, including a better distinction between funding for humanitarian assistance and for long-term development cooperation channelled through the funds, programmes and specialized agencies of the United Nations system and the United Nations Secretariat, in collaboration with organizations repository of relevant information and statistics, as appropriate (Council resolution 2006/14, para. 11).

At its substantive session of 1998, the Council invited the Secretary-General to arrange for the submission by the executive heads of the United Nations funds and programmes, in consultation with the United Nations Development Group, to the Council at its annual substantive session, of a concise consolidated list of issues that are central to the improved coordination of operational activities and on which the funds and programmes seek consideration by and guidance from the Council, in particular in regard to the triennial policy review, and to include in the list recommendations whenever possible (Council resolution 1998/27, para. 4).

(b) Reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund, the United Nations Children's Fund and the World Food Programme

The Council will also have before it the annual reports of the Executive Boards of the United Nations Development Programme/United Nations Population Fund, the United Nations Children's Fund and the World Food Programme.

The Council requested the funds and programmes, through their executive boards, to include in their annual reports to the Council: (a) a section outlining measures taken in the implementation of the provisions of the triennial policy review of operational activities; and (b) a section on the activities and measures undertaken within the designated theme of the high-level meeting of the operational activities segment (Council resolution 1994/33).

The reports include a thorough analysis of problems encountered and lessons learned, with emphasis on issues arising from the implementation of the Secretary-General's reform programme, the triennial comprehensive policy review and the follow-up to international conferences, so as to allow the Council to fulfil its coordinating role (General Assembly resolutions 48/162 and 53/192 and Council resolution 1995/51).

At its fifty-ninth session, the General Assembly invited the executive boards and governing bodies of the funds, programmes and the specialized agencies to assess regularly the progress achieved in the area of simplification and harmonization of rules and procedures and requested the funds and programmes to provide, in their annual reports to the Council, specific information on the progress achieved in that area (General Assembly resolution 59/250, paras. 36, 38 and 39).

C. Coordination segment

4. The role of the United Nations system in promoting full and productive employment and decent work for all

The Council, at its resumed substantive session of 2006, in its decision 2006/274, adopted the following theme for its coordination segment of its substantive session of 2007: "The role of the United Nations system in promoting full and productive employment and decent work for all".

The Council, at its substantive session of 2006, in its resolution 2006/46 on the follow-up to the World Summit on the Information Society and review of the Commission on Science and Technology for Development, decided to carry out its responsibilities for overseeing the system-wide follow-up to the Summit outcomes in the context of its annual consideration of the integrated and coordinated implementation of and follow-up to major United Nations conferences and summits in its coordination segment on the basis of a thematic approach and a multi-year programme, in accordance with General Assembly resolution 57/270 B.

D. Humanitarian affairs segment

5. Special economic, humanitarian and disaster relief assistance

At its organizational session for 2007, the Council decided: (a) that the theme of the humanitarian affairs segment of its substantive session of 2007 would be

"Strengthening of the coordination of United Nations humanitarian assistance through enhancing the effectiveness of needs-based humanitarian assistance"; and (b) that it would convene two panels, the topics of which would be: (i) "The use of military assets in natural disaster relief"; (ii) "Needs-based humanitarian financing, including the Central Emergency Response Fund" (Council decision 2007/211).

At its sixty-first session, the General Assembly:

- In its resolution 61/132, requested the Secretary-General to report to the Assembly at its sixty-second session on strengthening emergency relief, rehabilitation, reconstruction and prevention in the aftermath of the Indian Ocean tsunami disaster through the Council at its substantive session of 2007.
- In its resolution 61/134, requested the Secretary-General to report to the Assembly at its sixty-second session, through the Council at its substantive session of 2007, on progress made in strengthening the coordination of emergency humanitarian assistance of the United Nations (see also Council resolution 2006/5).
- Also in its resolution 61/134, requested the Secretary-General to submit a report to the Assembly through the Council on the detailed use of the Central Emergency Response Fund.

In accordance with Council resolution 1983/46, the Secretary-General orally apprises the Council annually on the status of the assistance to the drought-stricken areas of Djibouti, Ethiopia, Kenya, Somalia, the Sudan and Uganda.

E. General segment

6. Implementation of and follow-up to major United Nations conferences and summits

At its substantive session of 2006, the Council requested the Secretary-General to submit a report on its role in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits, in the light of General Assembly resolutions 50/227, 52/12 B, 57/270 B and 60/265, which should also adequately reflect the work of the functional commissions in 2007, including actions taken to follow up on its resolution 2006/44, for consideration by the Council at its substantive session in 2007 (Council resolution 2006/44). The

report will also contain a section on the implementation of Council decision 2006/251 on the initiative of the Secretary-General to launch the Global Alliance for Information and Communication Technologies and Development (see also under chapeau of items 4, 7 (f), 8, 13 and 14).

At its organizational session for 1999, the Council invited the Director-General of the Food and Agriculture Organization of the United Nations to transmit to the Council every four years, starting in 1999, a report prepared by its Committee on World Food Security on progress in the implementation of the World Food Summit Plan of Action, highlighting its linkages with the coordinated and integrated followup to major United Nations conferences and summits undertaken by the United Nations system (Council decision 1999/212).

The General Assembly, in its resolution 58/230, requested the President of the Council to enhance the Council's interactions through regular exchanges with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development on organizational matters related to the follow-up to the International Conference on Financing for Development, within the context of the preparations for the high-level meeting with these institutions (New York, 16 April 2007), bearing in mind General Assembly resolutions 57/270 B and Council resolution 2003/47, and to report thereon to the Council (see also Council resolution 2006/45).

(b) Review and coordination of the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010

The Council, at its substantive session of 2006, in its resolution 2006/41, requested the Secretary-General to submit an annual progress report on the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010. The report is submitted to the General Assembly, through the Council, in response to paragraph 111 of the Programme of Action (see also Council decision 2001/320).

At its sixty-first session, in the declaration of the high-level meeting on the midterm comprehensive global review of the implementation of the Programme of Action, the General Assembly invited the Council to continue to ensure the annual review of the implementation of the Programme of Action, taking into account the concrete and quantifiable achievements produced in the realization of the agreed objectives (General Assembly resolution 61/1).

7. Coordination, programme and other questions

(a) **Reports of coordination bodies**

The United Nations System Chief Executives Board for Coordination will submit an annual overview report to the Council (Council resolution 13 (III)), which will provide the Council with a summary of the work carried out by the Board machinery in 2006.

The report of the Committee for Programme and Coordination on its forty-seventh session (New York, 11 June-6 July 2007) will include the Committee's views on its consideration of the report of the United Nations System Chief Executives Board for Coordination.

(b) Proposed programme budget for the biennium 2008-2009

The Council will consider the relevant sections of the proposed programme budget for the biennium 2008-2009 (Council resolution 1988/77 and General Assembly resolution 58/269).

(c) International cooperation in the field of informatics

At its substantive session of 2006, the Council requested the President of the Council to convene the Ad Hoc Open-ended Working Group on Informatics for one more year and requested the Working Group to continue its efforts to act as a bridge between the evolving needs of Member States and the actions of the Secretariat. The Council also requested the Secretary-General to report to the Council at its substantive session of 2007 on action taken to follow up on the need to harmonize

and improve United Nations informatics systems for optimal utilization and accessibility by all States, including the findings of the Working Group and an assessment of its work and mandate (Council resolution 2006/35).

At its substantive session of 2006, the Council decided to extend the mandate of the Ad Hoc Advisory Group on Haiti until the substantive session of the Council in 2007 and requested the Ad Hoc Advisory Group to submit a report on its work, with recommendations, as appropriate, to the Council at its substantive session of 2007 and decided that the work of the Advisory Group will be reviewed at the substantive session of 2007, with a view to considering whether to continue its mandate, based on the Council's consideration of the report, and the situation then prevailing in Haiti, with due account being taken of the creation of the Peacebuilding Commission (Council resolution 2006/10).

(e) Mainstreaming a gender perspective into all policies and programmes in the United Nations system

At its substantive session of 2006, the Council requested the Secretary-General to report to it at its substantive session of 2007 on mainstreaming a gender perspective into all policies and programmes in the United Nations system (Council resolutions 2006/9 and 2006/36).

At its sixty-first session, the General Assembly encouraged the Council to continue its efforts to ensure that gender mainstreaming is an integral part of its work and that of its subsidiary bodies, through, inter alia, implementation of its agreed conclusions 1997/2 and its resolution 2004/4, and welcomed the ministerial declaration of the high-level segment of the Council's substantive session of 2006, which, inter alia, underlined the need for the consistent use of a gender mainstreaming strategy for the creation of an enabling environment for women's participation in development, and called upon all stakeholders to work to ensure the full incorporation of gender perspectives in the implementation of the declaration (General Assembly resolution 61/145) (see also under chapeau of item 14 (a)).

At its substantive session of 2006, the Council requested the Secretary-General to submit a report on the role of the Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits, in the light of General Assembly resolutions 50/227, 52/12 B, 57/270 B and 60/265, specifying that the report should also adequately reflect the work of the functional commissions in 2007, including actions taken to follow up on that resolution (Council resolution 2006/44) (see also under chapeau of items 4, 6, 13 and 14).
