At its 47th plenary meeting, on 15 December 2009, the Economic and Social Council took the following action with regard to vacancies in its subsidiary and related bodies:

Committee on Economic, Social and Cultural Rights

The Council elected Aslan Khuseinovich **Abashidze** (Russian Federation) for a term beginning on the date of election and expiring on 31 December 2010 to fill a vacancy arising from the resignation of Yuri Kolosov (Russian Federation).

Committee for the United Nations Population Award

The Council elected **Bangladesh** and the **Czech Republic** for a three-year term beginning on 1 January 2010.

The Council further postponed the election of two members from African States, one member from Asian States and one member from Western European and other States for a three-year term beginning on 1 January 2010.

Programme Coordinating Board of the Joint United Nations Programme on HIV/AIDS (UNAIDS)

The Council elected **China** for a three-year term beginning on 1 January 2010.

The Council further postponed the election of one member from African States for a three-year term beginning on 1 January 2010.

Governing Council of the United Nations Human Settlements Programme

The Council elected **Afghanistan** to fill a postponed vacancy on the Governing Council for a term beginning on the date of election and expiring on 31 December 2012.

The Council further postponed the election of four members from Western European and other States for a term beginning on the date of election, two members for a term expiring on 31 December 2011 and two members for a term expiring on 31 December 2012.

Organizational Committee of the Peacebuilding Commission

The Council elected **Australia**, **Brazil** and **Egypt** for a term beginning on 1 January 2010 and expiring on 31 December 2010 to fill vacancies arising from the expiration of the terms of three members of the Economic and Social Council (**Luxembourg**, **El Salvador** and **Algeria**, respectively) that were elected to the Organizational Committee.

The Council appointed Patrick **Plane** (France) to the Committee for a three-year term beginning on 1 January 2010.

Appointment of an additional member of the Ad Hoc Advisory Group on Haiti
