Chapter _____ Organizational and other matters

A. Opening and duration of the session

1. The Commission on Sustainable Development held its thirteenth session on 30 April 2004 and from 11 to 22 April 2005. The Commission held ___ meetings, as well as a number of informal meetings and associated activities.
2. At the 2nd meeting, on 11 April 2005, the Chairman opened the session and made an opening statement.
3. At the same meeting, the Under-Secretary-General for Economic and Social Affairs made an introductory statement.
4. Also at the same meeting, the Under-Secretary-General and High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States addressed the Commission.
5. At the same meeting, statements were made by the Executive Director of the United Nations Human Settlements Programme, and the representative of the United Nations Environment Programme on behalf of its Executive Director.
