# Draft programme of work for the biennium 2010-2011 for the Division for Sustainable Development of the Department of Economic and Social Affairs

### **Note by the Secretariat**

- 1. The draft programme of work in the field of sustainable development for the biennium 2010-2011, which is contained in the annex to the present note, is submitted for the consideration of the Commission on Sustainable Development in compliance with the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, Monitoring of Implementation and Methods of Evaluation (ST/SGB/2000/8).
- 2. In its resolution 63/247, the General Assembly approved the biennial programme plan for the period 2010-2011, which includes the elements of the programme narrative, namely, the objectives, expected accomplishments and indicators of achievement of the sustainable development subprogramme.
- 3. The draft programme of work contained in the annex to the present note includes, in addition to the programme narrative, a list of outputs formulated within the framework of subprogramme 4 (Sustainable development) of programme 7 (Economic and social affairs) of the biennial programme plan for the period 2010-2011.
- 4. The Commission is invited to take note of the programme narrative and to review the proposed outputs to be included in the proposed programme budget for the biennium 2010-2011, which will be submitted to the Advisory Committee on Administrative and Budgetary Questions and to the General Assembly at its sixty-fourth session.

# Draft programme of work for the biennium 2010-2011 for the Division for Sustainable Development of the Department of Economic and Social Affairs

# Objectives, expected accomplishments and indicators of achievement

**Objective of the Organization**: to accelerate the implementation of sustainable development goals, targets and commitments in accordance with internationally agreed development goals, including those contained in the United Nations Millennium Declaration and the outcomes of major United Nations conferences and summits, in particular the World Summit on Sustainable Development.

### **Expected accomplishments of the Secretariat**

# (a) Effective review of and agreement on key sustainable development challenges and priority actions of the multi-year programme of work to advance implementation in the areas of transport, chemicals, waste management, mining and the 10-year framework of programmes on sustainable consumption and production patterns

- (b) Increased accessibility of information and knowledge on policy options, practical measures and concrete actions needed for the adoption and implementation of sustainable development at the local, national, regional and international levels
- (c) Enhanced technical, human and institutional capacities of developing countries and countries with economies in transition to implement actions and national strategies for sustainable development in energy, water, natural resources and sustainable consumption and production

### Indicators of achievement

- (a) Increased level of satisfaction by Member States with the support and servicing for the intergovernmental process, including activities related to consensus-building, the functioning of the Bureau of the Commission on Sustainable Development, the partnership fair, the Learning Centre and the participation of major groups
- (b) (i) Increased number of inputs by Member States into databases on case studies, partnerships, best practices and lessons learned
  - (ii) Increased number of visits to and downloads from the website of the Division for Sustainable Development
- (c) (i) Increased number of countries expressing satisfaction with advisory, technical cooperation and capacity-building services to achieve their sustainable development goals
  - (ii) Increased number of national staff trained, resulting in enhanced knowledge and skills

### **External factors**

(vi) Substantive servicing of inter-agency meetings: inter-agency meetings for coordinating the work of the United Nations in the area of sustainable development: (i) UN-Water (4); (ii) UN-Energy (4); and (iii) UN-Oceans (2);

#### (c) Technical cooperation (regular budget/extrabudgetary)

- (i) Advisory services: expert advisory services, at the request of Governments and in cooperation with United Nations agencies and regional commissions, will be provided to developing countries, small island developing States and countries with economies in transition, for capacity-building and/or strengthening in such areas as national sustainable development strategies, indicators for sustainable development, devising and implementing action plans and policies for sustainable consumption and production, facilitating partnerships for sustainable development, strengthening of institutions and providing support to multi-stakeholder consultative processes that promote sustainable development, as well as processes related to sustainable management of freshwater and energy for sustainable development, with a focus on energy efficiency and new and renewable energy resources and advanced fossil fuel technologies, as well as, inter alia, natural resources development;
- (ii) Training courses, seminars and workshops: training seminars and/or workshops for and with national policymakers in developing countries, small island developing States and countries with economies in transition, with a view to strengthening national capabilities in all areas of sustainable development. These include toolkits for sustainable consumption and production, integrated water resources management and energy for sustainable development;
- (iii) Field projects: provision of technical services to Member States under country, regional and interregional technical cooperation projects in the area of sustainable development supported from all sources of funding.
