## B. Decisions brought to the attention of the Council

2. The following decisions adopted by the Commission are brought to the attention of the Council:

#### 40/101

## Programme review: climate change and official statistics

The Statistical Commission:

- (a) Welcomed the high-quality programme review on climate change and official statistics prepared by the Australian Bureau of Statistics, which took into consideration the recommendations of the two conferences held on this subject, in Oslo, from 14 to 16 April 2008, and in Seoul, on 11 and 12 December 2008;
- (b) Recognized that climate change is an important global issue with social, economic and environmental impacts and that official statistics have an important role to contribute to closing data gaps;
- (c) Acknowledged that climate change is a new area of official statistics, and noted that work in this field should be approached with caution as countries are at different levels of statistical development and have different national governance arrangements with respect to production of statistics related to climate change;
- (d) Noted that current negotiations under the United Nations Framework Convention on Climate Change are of paramount importance and that any potential interference with these processes should be avoided;
- (e) Agreed that there is a need to understand the data needs of various stakeholders, including the United Nations Framework Convention on Climate Change and the Intergovernmental Panel on Climate Change, and to engage them in

identifying the areas where the official statistical community can make the best contribution, including statistical classification issues;

- (f) Recognized that many of the statistics already being produced by national statistical systems can be used for the calculation of emissions and the measurement and analysis of the drivers and the impacts of climate change and that work should therefore focus on utilizing existing statistics before embarking on new areas;
- (g) Emphasized the importance of coordination among the various stakeholders at the national level which are engaged in climate change-related statistics, with the aim of producing high-quality statistics;
- (h) Noted the interest of some countries to develop a framework of environmental statistics at the national level to facilitate the understanding of the phenomenon of environmental and climate change;
- (i) Stressed the importance of training and capacity-building, in particular for the developing countries, and expressed the need for appropriate training material and the development of a knowledge base in this new area of official statistics;
- (j) Noted that there were differing views regarding the proposed expansion of the mandate of the Committee of Experts on Environmental-Economic Accounting to cover the area of climate change-related statistics, and requested the Committee to prepare new terms of reference and a priority list of its work programme, including statistics related to climate change, for further consultation with the Bureau prior to a decision by the Commission at its forty-first session, in 2010.

## **Agricultural statistics**

The Statistical Commission:

- (a) Welcomed with appreciation the report of the Working Group on Agricultural Statistics<sup>2</sup> on global initiatives to improve agricultural and rural statistics;
- (b) Stressed that agricultural and rural statistics are essential for policymaking and that strategic direction is needed to meet the increasing demand for information at both the international and country levels, especially in the light of the recent food crisis;
- (c) Emphasized the important role of agricultural ministries and other institutions in the compilation of agricultural statistics, as well as the coordination role of national statistical offices and national statistical councils;
- (d) Supported the development of a strategic plan based on the recommendations and road map as set out in the report;

- (e) Agreed that the main lines of action should be:
- (i) To identify a minimum set of indicators that reflect current core agricultural statistical needs and emerging requirements, including those from neighbouring domains;
- (ii) To provide a blueprint for a better integration of agricultural statistics in the national statistical system;
- (iii) To advocate for national statistical organizations and ministries of agriculture to obtain funding to meet the agreed international requirements;
- (iv) To establish a basis for statistical capacity-building by identifying a set of methodological tools;
- (v) To establish coordination of donor efforts to improve agricultural and rural statistics;
- (f) Recognized the important role of the Food and Agriculture Organization of the United Nations, as the specialized agency in this field, and welcomed the commitment and effort of the Food and Agriculture Organization of the United Nations to involve the ministries of agriculture through its governing bodies in the development of the strategic plan and the implementation plan;
- (g) Agreed with the creation of a Friends of the Chair group to steer the process, with the Food and Agriculture Organization of the United Nations and the United Nations Statistics Division serving as secretariat, stressed the importance of proper representation of countries from all regions and at different levels of development, and welcomed the interested countries to participate in the group to ensure ownership of the process by countries;
- (h) Requested the Friends of the Chair group to report back to the Commission at its forty-first session on progress in the development of the strategic plan to improve agricultural and rural statistics.

## **Energy statistics**

The Statistical Commission:

- (a) Welcomed the report of the Secretary-General on the preparation of the revised and updated international recommendations for energy statistics<sup>3</sup> and expressed its appreciation for the work accomplished so far by the United Nations Statistics Division, the Oslo Group on Energy Statistics, the Intersecretariat Working Group on Energy Statistics and other stakeholders;
- (b) Endorsed the United Nations Statistics Division strategy to prepare the international recommendations for energy statistics, and suggested that the preparation of the recommendations be considered a matter of high priority;
- (c) Emphasized that the revised recommendations should provide a firm foundation for the long-term development of official energy statistics based on the Fundamental Principles of Official Statistics and contain the necessary guidance on

the underlying concepts, definition and classifications as well as on data compilation and data dissemination in the context of an integrated approach to economic statistics:

- (d) Stressed the importance of close cooperation in the development of the recommendations of all relevant international, supranational and regional organizations to avoid overlap of activities and to ensure consistency of concepts and methodologies;
- (e) Stressed the importance of the involvement of countries in the preparation of the recommendations, and encouraged countries to actively participate in the drafting process by providing their contributions.

## **Environmental-economic accounting**

The Statistical Commission:

- (a) Welcomed the report of the Committee of Experts on Environmental-Economic Accounting,<sup>4</sup> and expressed its appreciation for the progress of work carried out by the Committee;
- (b) Expressed its full support for the project on the revision of the System of Environmental-Economic Accounting, acknowledged with appreciation the work done by the London Group on Environmental Accounting, the Oslo Group and others, and recognized the urgency to complete the System of Environmental-Economic Accounting handbook as soon as possible;
- (c) Noted that there were differing views regarding the proposed expansion of the mandate of the Committee to include environment and climate change statistics, and requested the Committee to review its mandate, terms of reference and governance structure to reflect the focus of its work on environmental-economic accounting and its role in environment and climate change statistics;
- (d) Considered the establishment of an advisory group on environmental-economic accounting and environment statistics not necessary at this stage, agreed that the Committee would need to receive advice on substantive issues, and recommended that technical panels be convened when necessary on an ad hoc basis;
- (e) Requested the Committee to submit the revised mandate, governance and terms of reference to the Bureau of the Commission for review and to the Commission for further consideration at its forty-first session;
- (f) Also requested the Committee to develop a programme of work outlining its priorities and to disseminate it widely;
- (g) Reconfirmed that the revision of the System of Environmental-Economic Accounting is the highest priority of the Committee;
- (h) Noted the central role of national statistical offices in the coordination and production of environmental-economic accounts, but also recognized the need

for countries to work with other agencies of Government that may be the main collectors of data on particular topics;

- (i) Took note of the resource constraints of the project on the revision of the System of Environmental-Economic Accounting, appreciated the offers made by Member States and international organizations, and encouraged all Member States to contribute to the project in cash and/or in kind;
- (j) Noted the request from countries to translate the System of Environmental-Economic Accounting for Water, the System of Environmental-Economic Accounting for Energy and the System of Environmental-Economic Accounting for Material Flow Accounts, as soon as they become available, into the official languages of the United Nations as quickly as possible;
- (k) Encouraged the Committee to develop a strategy for capacity-building in the field of environmental-economic accounting.

#### **National accounts**

The Statistical Commission:

- (a) Congratulated the member organizations of the Intersecretariat Working Group on National Accounts, consisting of the Statistical Office of the European Community, the International Monetary Fund, the Organization for Economic Cooperation and Development, the United Nations and the World Bank, for bringing the multi-year project of updating of the *System of National Accounts*, 1993, to conclusion, and commended the Working Group for conducting its work on the update in a transparent manner;
- (b) Expressed its appreciation to countries, the members of the Advisory Expert Group on National Accounts and other expert groups, organizations and individuals for their in kind and financial contributions to the finalization of the *System of National Accounts*, 2008, and recognized the significant contributions of the Editor, Anne Harrison, and the Project Managers, Carol Carson and Paul McCarthy;
- (c) Adopted the *System of National Accounts*, 2008, volume 2, which, combined with volume 1, provides the international statistical standard for national accounts, and encouraged Member States, regional and subregional organizations to implement the standard and support all aspects of the implementation of the updated System of National Accounts, including the national and international reporting of national accounts statistics;
- (d) Requested the secretariat and the members of the Intersecretariat Working Group on National Accounts to finalize the *System of National Accounts*, 2008, as described in the report to the Commission<sup>5</sup> and to proceed with the publication of the *System of National Accounts*, 2008, in all six official languages of the United Nations as rapidly as possible and to promote its wide dissemination, in a single volume, in print and online;

- (e) Supported the proposed implementation strategy for the *System of National Accounts*, 2008, based on the principles of strategic planning, coordination, monitoring and reporting, and for improving statistical systems, and requested the Working Group to pay particular attention to improving basic economic statistics and to the need for consistency and harmonization across sectoral statistics from other macroeconomic frameworks with the national accounts and to recognize the particular circumstances of countries by introducing flexibility in the implementation programme;
- (f) Emphasized the advocacy element of the implementation strategy and the importance of a global communication strategy in disseminating knowledge about the System of National Accounts, more specifically the System of National Accounts, 2008, and to promote its implementation;
- (g) Recognized the importance of the role of the regional commissions and their advisory committees on the System of National Accounts to facilitate coordination and regional cooperation on the implementation programme, and welcomed the initiatives of the regional commissions and other development partners in collaborating on the implementation process of the System of National Accounts;
- (h) Requested a coordinated effort by the Working Group on the development of manuals, implementation guides, data collection tools and standardized training material, and in the use of modern and innovative tools, such as distance learning and knowledge bases, to provide easy access on a range of information, including best practices, to facilitate the implementation of the System of National Accounts;
- (i) Took note of the outcome of the high-level forum on the future direction of the System of National Accounts confirming that the macroeconomic accounts embodied in the *System of National Accounts*, 2008 provide a sound basis for articulating economic developments of a globally interconnected nature;
- (j) Noted that processes need to be established to ensure that the System of National Accounts remains relevant and that the programme of work of the high-level forum needs to be precise and elaborated;
- (k) Requested the Working Group to report to the Commission at its forty-first session on progress with the implementation programme and the research agenda of the *System of National Accounts*, 2008, taking into account the views expressed by the Commission.

## 40/106 Social statistics

The Statistical Commission:

(a) Welcomed the report of the Secretary-General on social statistics<sup>6</sup> and expressed appreciation for the work of the Expert Group Meeting on the Scope and Content of Social Statistics;

- (b) Endorsed the recommendations pertaining to the activities of the international plan of action;
- (c) Recognized that the content, scope and profile of social statistics vary from country to country due to economic circumstances, cultural and traditional differences and different policy objectives, making the harmonization of those statistics a particular challenge, in areas where they need to be harmonized;
- (d) Emphasized the importance of developing a substantive inventory of social statistics to identify methodological gaps and to facilitate sharing of best practices in an efficient manner;
- (e) Urged the United Nations Statistics Division to undertake the development of the social statistics inventory on a priority basis and to release components as they become available, without waiting for the completion of the whole project;
- (f) Requested the United Nations Statistics Division to develop an appropriate information technology platform, such as a website and other accompanying tools, to ensure continuous and effective dissemination of information pertaining to the work on social statistics;
- (g) Also requested the United Nations Statistics Division to interact closely, in the course of the activities listed above, with all relevant stakeholders at international and regional levels, thus creating a mechanism for sharing experiences and methodology with all national statistical authorities;
- (h) Further requested the United Nations Statistics Division to explore the best mechanism for meeting the needs of developing countries in the sharing of experiences and for providing training in the field of social statistics;
- (i) Requested the United Nations Statistics Division to report to the Commission periodically on the progress made.

## 40/107 Health statistics

The Statistical Commission:

- (a) Welcomed the report of the Intersecretariat Working Group on Health Statistics,<sup>7</sup> and expressed appreciation for the efforts of the Working Group in developing the framework for health statistics;
- (b) Agreed with the Working Group and encouraged it to finalize the framework of health statistics, as proposed in the report;
- (c) Recognized the complexity of developing such a framework and urged the Working Group to ensure that the framework:
  - (i) Is easy to use and identifies areas of priority;
  - (ii) Contributes to the enhanced comparability of health statistics and indicators that should be internationally comparable;

- (iii) Is of practical utility;
- (iv) Is synchronized with international standards;
- (v) Is developed in coordination with all relevant stakeholders;
- (vi) Takes into account the different circumstances in different countries;
- (d) Urged the Working Group to be as inclusive as possible and to expand its membership accordingly;
- (e) Welcomed the offer of support of the World Health Organization in developing the framework for health statistics, especially its work on compiling the registry of health indicators;
- (f) Requested the United Nations Statistics Division to fully support, where possible, the work of the Working Group in completing the framework for health statistics, and urged other organizations to provide full support as well.

#### **Education statistics**

The Statistical Commission:

- (a) Welcomed the report of the Task Force on Education Statistics,<sup>8</sup> and expressed its appreciation for the work carried out by the Task Force;
- (b) Endorsed the establishment of an expert group on the revision and implementation of the International Standard Classification of Education, taking into account work that has already been done in this area and available materials and existing frameworks;
- (c) Agreed, in principle, with the establishment of an intersecretariat working group on education statistics, led by the UNESCO Institute for Statistics, to improve coordination mechanisms, maintain and promote the development of international standards and minimize duplicative efforts among international agencies, concerning aspects not covered by existing mechanisms;
- (d) Requested the UNESCO Institute for Statistics to clarify the mandate of the group and explore working modalities in such a way that the existing coordination mechanisms be fully embedded into the scope of the intersecretariat working group;
- (e) Welcomed the proposal of many developing countries to be part of the expert group on the revision and implementation of the International Standard Classification of Education as this would enhance the improvement of educational statistics in the developing world.

## **Employment statistics**

The Statistical Commission:

- (a) Welcomed with appreciation the report of the International Labour Organization on labour statistics, 9 the outcomes of the eighteenth International Conference of Labour Statisticians and the actions taken to implement the recommendations contained in the programme review report considered by the Commission at its thirty-ninth session;
- (b) Took note of the resolutions on working time and child labour adopted by the eighteenth International Conference of Labour Statisticians and the recommendations made by the Conference to the International Labour Organization Governing Body regarding the organization, frequency and duration of the Conference. In particular, the Commission welcomed the recommendation on increasing the frequency of the Conference;
- (c) Agreed with the list of priority issues, as listed in the International Labour Organization report, as well as the road map put forward to work on those issues. In particular, the Commission agreed with the need to address the issues of the changing structure of the labour force, including ageing and the definition and measurement of employment and unemployment, including underutilization of labour and work on the measurement of productivity, where feasible to do so;
- (d) Strongly stressed the need to increase efforts to assist countries in improving their employment statistics, especially in view of the current global economic circumstances, and took note of the plans of the International Labour Organization for a technical cooperation programme in this area;
- (e) Welcomed the offer of the United Kingdom of Great Britain and Northern Ireland to take the lead on the work to extend the labour statistics framework, especially to deal better with the dynamics of the labour force;
- (f) Endorsed the proposal that dedicated working groups take up specific identified priority issues and that the International Labour Organization provide the overall coordination for those efforts. In order to facilitate the launch and work of the dedicated working groups, the Commission invited member States and international organizations that had not already done so to inform the International Labour Organization on the topics to which they would be able and willing to contribute, and, in this regard, noted the offer of Canada to take the lead for one of the working groups;
- (g) Invited the International Labour Organization to submit a progress report to the Commission at its forty-first session, in 2010.

## 40/110 Gender statistics

The Statistical Commission:

- (a) Welcomed the report of the Friends of the Chair on indicators on violence against women, <sup>10</sup> and commended the work of the Friends of the Chair;
  - (b) Adopted the proposed set of indicators as an interim set and the first step;
- (c) Requested that the Friends of the Chair, under the continuing leadership of Mexico, proceed with its work and report back to the Commission accordingly;
- (d) Recognized the substantial cultural differences on the issue of violence against women, and urged the Friends of the Chair to expand its composition to ensure that different perspectives and sensitivities are taken into consideration in future work;
- (e) Requested the United Nations Statistics Division and other stakeholders, including the World Health Organization, the United Nations Office on Drugs and Crime and the regional commissions, to draw upon and further elaborate existing methodological guidelines for measuring violence against women;
- (f) Also requested the United Nations Statistics Division to initiate a trial compilation of national statistics based on the interim set of indicators in order to determine their feasibility and relevance;
- (g) Took note of the suggestion to include a general consideration of gender statistics in the agenda of the Commission.

## **International Comparison Programme**

The Statistical Commission:

- (a) Welcomed the report of the World Bank setting out a proposal for the governance structure and work programme for the 2011 round of the International Comparison Programme;<sup>11</sup>
- (b) Expressed its appreciation for the excellent work done in the last twelve months by the:
  - (i) Interim Executive Board created pursuant to a recommendation of the Commission at its thirty-ninth session for oversight of the 2005 round and preparations for the 2011 round;
  - (ii) Interim Technical Advisory Group that recommended research priorities and technical improvements for the next round;
  - (iii) Regional coordination agencies that have maintained their International Comparison Programme coordination roles for the interim period;

- (iv) World Bank for accepting to continue to host the Global Office for the 2011 round and for coordinating the preparation for the 2011 round;
- (c) Took note of the increasing use of purchasing power parity data from the 2005 round by academics, researchers and international organizations and their useful feedback on areas to improve data quality for the 2011 round;
- (d) Endorsed the proposed governance structure and work programme for the 2011 round and recommended that particular attention be paid to the following:
  - (i) Broadening participation and country coverage, giving particular attention to the involvement of Caribbean and Pacific island countries and regional institutions;
  - (ii) Elaborating on suitable strategies for addressing issues for countries for which the 2011 benchmark year may be a problem due to overlap with the timing of the population census;
  - (iii) The statistical capacity-building needs of participating countries;
  - (iv) Ensuring operational links between the International Comparison Programme and the System of National Accounts implementation plans;
  - (v) Mobilizing needed resources as soon as possible and moving quickly on implementing the work programme;
- (e) Drew attention to expediting the research programme with a focus on such priority areas as data quality assessment, ring comparison and compilation software;
- (f) Encouraged the further development of advocacy strategies, and welcomed the plan for holding an International Comparison Programme data users conference in 2010 and, if possible, earlier;
- (g) Urged that the new Executive Board be established as soon as possible, based on the recommended membership structure, which would include the stakeholders, representatives from partner agencies and rotating members representing groups of countries. The list of members of the Board will be reviewed by the Bureau of the Commission;
- (h) Requested that the subcommittee of the interim Executive Board in charge of handling operational matters for the preparations of the 2011 round continue its work until the new Executive Board became fully functional;
- (i) Also requested that a status report on the start of the 2011 round be submitted to the Commission at its forty-first session.

## Regional statistical development in Asia and the Pacific

The Statistical Commission:

- (a) Welcomed the comprehensive and highly informative report prepared by the secretariat of the Economic and Social Commission for Asia and the Pacific, <sup>12</sup> and expressed appreciation for the work done;
- (b) Congratulated the region for holding the first session of the re-established Committee on Statistics, and recognized that the Committee on Statistics can function as a bridge to the global statistical system and that it has an important role in the promotion and implementation of the international statistical standards in the region taking into account, where relevant, regional and subregional circumstances:
- (c) Noted the rapid progress in statistical development in the region, including improvements in the Pacific, but recognized that some countries still require significant assistance in capacity development, especially the small island developing States, landlocked and least developed countries;

- (e) Noted with appreciation the support expressed by countries to assist the secretariat of the Economic and Social Commission for Asia and the Pacific in steering statistical development in the region, and urged the secretariat to strengthen and coordinate the work on statistical capacity-building to improve sharing of best practices and to increase advocacy activities to assist countries in securing political support from their Governments on statistical development;
- (f) Requested the Economic and Social Commission for Asia and the Pacific to establish an informal mechanism for donor coordination for statistical development in the region, taking into account existing mechanism, roles and responsibilities;
- (g) Recognized with appreciation the excellent work done by the Statistical Institute for Asia and the Pacific in the region, and requested the Statistical Institute to intensify its efforts in statistical capacity-building, including for small island developing States, landlocked and least developed countries, and its coordination of training activities in the region, and to assist in building a regional training network involving national training institutes;
- (h) Noted with appreciation the strong support of the Government of Japan for the Statistical Institute, and encouraged other countries to increase financial support to the Institute and other regional training activities;
- (i) Welcomed the offer of technical assistance on statistical development by some countries through a variety of modalities, including South-South cooperation, long-term training through twinning arrangements and short-term consultancies;

(j) Took note of the contributions that had been made in the region by the Development Account projects of the Department of Economic and Social Affairs of the United Nations Secretariat, and welcomed the new interregional component in recent projects, which allowed the sharing of expertise across regions.

The Statistical Commission:

- (a) Took note of the report of the Secretary-General on the indicators for monitoring the Millennium Development Goals, <sup>13</sup> and expressed its appreciation for the work done by the Inter-Agency and Expert Group on Millennium Development Goals Indicators and the United Nations Statistics Division to improve the monitoring of the Millennium Development Goals;

- (f) Noted with appreciation the work done to date by the Inter-Agency and Expert Group and the United Nations Statistics Division to explain and resolve discrepancies between national and international data sets, and requested that the work continue;
- (g) Recognized that the population and housing census is an important source of data for the production of Millennium Development Goals indicators, and urged countries that had not yet done so to undertake their 2010 round of the census;
- (h) Also recognized the importance of improving the coordination of Millennium Development Goals monitoring at the national level and requested that the Inter-Agency and Expert Group address the issue at its next meeting and develop a strategy to address the requests by many member countries for support;
- (i) Agreed with the need to strengthen training in the analysis of Millennium Development Goals indicators, and requested the Inter-Agency and Expert Group and the United Nations Statistics Division to widely distribute the manual of
