# **Human rights and thematic procedures**

## Note by the secretariat

- 1. In paragraph 10 (a) of resolution 2000/86, adopted on 27 April 2000, the Commission on Human Rights requested the Secretary-General, in close collaboration with the thematic special rapporteurs, representatives, experts and working groups, to issue annually and sufficiently early their conclusions and recommendations, so as to enable further discussion of their implementation at subsequent sessions of the Commission.
- 2. Pursuant to this request, the annex to the present document contains the references to the pertinent chapters containing the conclusions and recommendations of the reports submitted to the Commission on Human Rights at its fifty-seventh session by the thematic special rapporteurs and working groups.
- 3. Moreover, in paragraph 7 of resolution 2000/86, the Commission requested the Secretary-General to convene further periodic meetings of all the thematic special rapporteurs, representatives, experts and chairpersons of working groups of the Commission, in order to enable them to continue to exchange views, cooperate and coordinate more closely and make recommendations. In this regard, it may be noted that a meeting of special rapporteurs/representatives, experts and chairpersons of working groups of the special procedures of the Commission and of the advisory services programme was held from 5 to 9 June 2000, the report of which has been submitted to the Commission at its fifty-seventh session (E/CN.4/2001/6).
