## Letter dated 9 March 2001 from the Deputy Secretary-General of Amnesty International addressed to the United Nations High Commissioner for Human Rights\*

In your letter of 26 February 2001, you transmitted to us the comments of the Government of Togo concerning the report of the Organization of African Unity/United Nations International Commission of Inquiry for Togo.

Since then, intimidation of witnesses has continued, as indicated in our report (attached)\*\*. Since the beginning of 2001, Amnesty International has identified at least 10 cases where persons living in Togo, Ghana and Benin have been harassed by the Togolese security forces or by persons close to the Government of Togo, some for having approached the International Commission of Inquiry. All have had to flee the place where they had been living.

Moreover, it now appears that the letter of the handwriting expert, attached to the comments of the Government of Togo, is a forgery, as are the two letters attributed to Mr. Gilchrist Olympio. The expert, Ms. Beverley East, was contacted by the lawyers hired by Amnesty International, and replied to us as follows:

- "... this letter is not mine.
- (1) It is not addressed to the person with [to] whom I originally addressed it to.
- (2) It is not signed by me.
- (3) It is not on my letterhead."

In view of the libellous implications for our Secretary-General of the letters attributed to Mr. Olympio, who stated that they were forgeries, it appears to us to be indispensable for this latest information to be given the same circulation as the report and its addenda. We ask you in particular to make it available to the Commission on Human Rights and to publish it on your Internet Web site: in our view the High Commissioner cannot knowingly continue to circulate documents which Mr. Olympio and Ms. East have stated to be forgeries, without simultaneously informing the members of the Commission and the public of the latest information received concerning their lack of authenticity.
