I. ANNUAL REPORTS

1. In conformity with arrangements adopted by the General Assembly for the management of the United Nations Voluntary Fund for the Victims of Torture, the Secretary-General draws up an annual report to the Assembly, indicating the funds available, pledges made and contributions received, together with disbursements from the Fund (resolution 36/151). The annual report prepared on 12 July 2001 (A/56/181) was submitted to the Assembly at its fifty-sixth session. The Assembly took note of this report. At its fifty-seventh session it will examine the Secretary-General's next report, in accordance with resolution 56/143 of 19 December 2001.

2. The Commission on Human Rights, in its resolution 2001/62 adopted at its fifty-seventh session on 25 April 2001, took note (para. 39) of the Secretary-General's previous reports on the Fund (A/55/178 and E/CN.4/2001/59 and Corr.1 and Add.1), and (para. 46) requested the Secretary-General to continue to keep it informed of the operations of the Fund on an annual basis. The Secretary-General's last report to the Assembly on the Fund (A/56/181) and Assembly resolution 56/143 will be available to the Commission at its fifty-eighth session. The present report, drawn up on 25 January 2002, complements and updates the annual report mentioned above. An addendum will be submitted to the Commission in March or April 2002 for the purpose of keeping it informed of new contributions received in time for the twenty-first session of the Fund's Board of Trustees.

II. FINANCIAL STATUS

A. Grants paid, pending or allocated for urgent assistance

3. At its twentieth session (18 May-1 June 2001), the Board of Trustees of the Fund, an advisory body to the Secretary-General, recommended that, for the period June 2001-May 2002, grants of a little over US\$ 8 million (A/56/181, para. 10, and press release HR/01/58 of 22 June 2001) should be awarded to medical, psychological, economic, social, legal, humanitarian and other assistance programmes around the world for victims of torture and members of their families. On 15 June 2001, the United Nations High Commissioner for Human Rights approved these grants on behalf of the Secretary-General. On 29 June 2001, in keeping with the Board's recommendations, total payments of US\$ 5,786,000 were made to cover all the grants which could be paid without delay. Since that time, payments totalling US\$ 1,531,000 have been requested for grants which had been withheld pending additional information. Some US\$ 700,000, allocated for grants still pending, could be paid before the Board's next session (13-27 May 2002) if the additional information requested by the Board or the Fund secretariat has been received from the organizations concerned and deemed to be satisfactory by the secretariat. A list of organizations financed by the Fund in 2001 is annexed to the annual report to the General Assembly (A/56/181, annex I). In addition, the Board recommended that an amount of approximately US\$ 175,000 should be set aside to meet requests made, in the period up to the next Board session in May 2002, for urgent assistance to projects financed by the Fund which might be experiencing financial difficulties, or to meet requests for urgent care from victims of torture in regions where there are no projects financed by the Fund (*ibid.*, para. 14).

B. Contributions available for the twenty-first session of the Board

4. The contributions received in time (before 18 May 2001) for allocation at the twentieth session of the Board are shown in the Secretary-General's report to the General Assembly (A/56/181, para. 11, table 1). Contributions that had not been officially recorded by the Treasurer of the United Nations before the twentieth session and were recorded afterwards are shown in table 1 below, drawn up on 25 January 2002 using information available to the Office of the High Commissioner. The Board will take them into consideration at its twenty-first session, together with any others that are duly recorded before Monday, 13 May 2002. Contributions paid and recorded by the Treasurer after 25 January 2002 will be mentioned in an addendum to the present report.

C. Pledges

5. Most donors pay their voluntary contributions directly to the Fund, without prior pledges. Some make pledges: (a) directly by letter to the Office of the High Commissioner, copied to the secretariat of the Fund (for details, see paras. 22-25 below); (b) at the meeting between donors and members of the Board, held on the last day of the annual session in May (the next meeting should take place on 27 May 2002); (c) at the United Nations Pledging Conference for Development Activities held in New York in the first week of each November; (d) at the briefings for regular donors organized by the Fund secretariat. Donors that so wish may also

make pledges at the annual session of the Commission or when a State party to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment submits a report to the Committee against Torture.

6. As on 25 January 2002, according to information available to the Office of the High Commissioner, the following pledges had been made:

7. Any contribution officially recorded by the Treasurer of the United Nations after 13 May 2002 will be reflected in the accounts for the twenty-second session (May 2003). The Board adopts its funding recommendations on the basis of the contributions actually paid and duly recorded in the Fund's account by the Treasurer, and actually available for allocation as grants; it does not take pledges into consideration.

III. FUND-RAISING

8. The General Assembly, by its resolution 56/143 of 19 December 2001, and the Commission, by its resolution 2001/62 (para. 40) of 25 April 2001, expressed their appreciation and gratitude to the Governments, organizations and individuals that had contributed to the Fund. They also encouraged donors that had already contributed to the Fund to continue to do so, if possible with a substantial increase, so that the ever more numerous requests for assistance could be addressed. In addition, they appealed to all Governments and organizations to contribute annually to the Fund, preferably by 1 March, so that their contributions could be duly recorded and made available for allocation at the Board's following session or, in any event, before the Board's annual meeting (i.e., for 2002, before 13 May). The Board of Trustees of the Fund, the Committee against Torture, the Special Rapporteur of the Commission on Human Rights on the question of torture and the United Nations High Commissioner for Human Rights have confirmed to all donors that their contributions are properly used to provide medical, psychological, economic, social, legal, humanitarian and other assistance to the victims of torture and their families, and that they are highly appreciated not only by the victims of torture themselves but also by their families and human rights defenders and organizations (see the Joint Declaration issued on the occasion of the United Nations International Day in Support of Victims of Torture, on 26 June 2002 - A/56/181, annex II).

9. The Secretary-General was requested to transmit these appeals to all Governments. In her letter of 4 December 2001, the High Commissioner drew the attention of all Governments to the appeals for contributions launched by the General Assembly, the Commission, the sponsors of the Joint Declaration and the Board. She estimated that requests for grants which might be made to the Fund in 2002 would amount to US\$ 12 million (see A/56/181, para. 27). She urged Governments in a position to do so to contribute to the Fund and, if possible, substantially to increase their contributions, preferably by 1 March 2002, before the next session of the Board.

10. At the end of each year, the secretariat of the Fund organizes a technical briefing for interested regular donors in Geneva, to provide them with up-to-date information on the amounts available, payments received, pledges and disbursements, and answer their questions. A briefing was held on 12 December 2001.

11. In its resolution 36/151, by which it established the Fund, the General Assembly authorized the Board to promote and solicit contributions and pledges. It also requested the Secretary-General to give the Board all the assistance it might require. The Board currently comprises Mr. Jaap Walkate (Chair), Mr. Ribot Hatano, Ms. Elizabeth Odio-Benito, Mr. Ivan Tosevski and Mr. Amos Wako. The Board members have the opportunity to solicit contributions at their annual meeting with donors held on the last day of the Board's annual session in Geneva. The Commission has introduced the practice of inviting the Chair or a Board

member, if he or she is present in Geneva during the Commission's session in March/April, to submit to the Commission, under the relevant agenda item, an update on the financial situation of the Fund and to encourage participants to pay their contributions before the Board meeting in May; this was done by Mr. Ivan Tosevski on 4 April 2001. The Chair of the Board, when making field visits to projects, also endeavours to meet the appropriate foreign ministry officials and to encourage them to contribute to the Fund.

12. If, in the opinion of the Chair of the Board, the level of total contributions paid and recorded by 1 March does not allow the Board to fulfil its functions by responding adequately to the grant requests received, the Chair could, in keeping with established practice, request the High Commissioner to forward to all Governments an urgent appeal from the Chair to pay new voluntary contributions to the Fund before 13 May 2002 (see E/CN.4/2001/59/Add.1, annex). The Assembly, in resolution 56/143, stressed the importance of the Board's work and requested the Secretary-General to assist the Board in its appeal for contributions (paras. 25 and 27).

13. In the same resolution, the Assembly also requested the Board to assist it in its efforts to make better known the existence of the Fund and the financial means available to it, and for that purpose to make use of all existing possibilities, in particular the preparation, production and dissemination of information materials (para. 27). The Assembly also requested the Secretary-General to make available adequate staff and facilities for the operations of the Board and the Fund, commensurate with the strong support expressed by Member States for such activities (para. 28).

IV. NEEDS ASSESSMENT FOR 2002

A. Requests received and grants awarded (1993-2001)

14. In order to take into account the difference between the requests for grants and the available resources which could be allocated for such grants (see table 3 below), as well as the constant upgrading of the projects submitted for funding and the increasing amount of grant funding allocated each year, the Board has recommended for several years that virtually the total amount should be awarded. As a result, all that is left for the following year is the compulsory reserve, which, in accordance with the United Nations rules applicable to voluntary funds for humanitarian purposes, is set at 15 per cent of expected annual expenditure (see A/56/181, para. 10).

B. Estimated needs for 2002

15. In assessing the needs of the Fund for 2002, the secretariat has followed the practice adopted by the Board and approved by the Secretary-General that the assessment should be realistic and based on, first, admissible requests for grants submitted to the Fund for 2002; second, resources available for the twenty-first session; third, the total grants awarded in the previous year; fourth, pledges made; and, fifth, new contributions expected from regular donors which have not yet been paid or pledged.

16. If the upward trend observed since 1997 continued (see table 3 above), the Board estimated that the total amount requested from the Fund in 2002 would reach almost US\$ 12 million (see A/56/181, para. 27). The increase in requests from 2000 to 2001 is approximately US\$ 1 million.

17. As on 25 January 2002, total new contributions paid since 18 May 2001 amounted to a mere US\$ 539,114 (see table 1 above). Total pledges received by the same date - which donors are urged to pay before 13 May 2002 - stood at US\$ 144,562 (see table 2 above).

18. In the light of its experience since 1982, the Board believes that regular appeals to donors and a steady increase in contributions will enable the Fund to perform its activities effectively.

19. In paragraph 45 of its resolution 2001/62, the Commission called on the Board to present an updated assessment of the need for international funding of rehabilitation services for victims of torture. The Board took note of this request at its twentieth session. It felt that it did not have the necessary information to make a realistic assessment of global funding needs for rehabilitation services for victims of torture, other than those which it had submitted to the Fund (see paras. 15-17 above). As, however, the Board's guidelines provide that the Fund should not in principle finance more than one third of the budget of any project submitted to it, the Board might respond that, if the above trend continues in 2002, organizations which have submitted a request to the Fund should approach other donors for the approximately US\$ 22 million needed to finance the remaining two thirds. The Board also noted that the Fund finances medical, psychological, social, economic, legal, humanitarian or direct emergency assistance programmes for victims of torture and members of their families, as well as certain vocational training programmes, and not only rehabilitation programmes.

20. The Commission also called upon the Board, in the same paragraph of its resolution, to present to it an assessment of lessons and best practices learned from the activities of the Fund. The Board draws lessons from the results of each completed year and formalizes its best practice, where necessary, at each of its closed sessions, when it adopts or reviews its procedures and guidelines. This constitutes a separate item on its annual agenda. The Board presented the lessons learnt from the activities of the Fund to donors at its annual meeting with them, on the last day of its twentieth session. In May 2000, it also presented these lessons at a meeting with all permanent missions to the United Nations Office at Geneva. The secretariat of the Fund also informs the Board, when necessary, of the relevant procedures, guidelines and best practice adopted by other boards of trustees of funds for humanitarian assistance established by the General Assembly and administered by the Secretary-General which engage in comparable activities. Salient points of the lessons drawn by the Board from the activities of the Fund over the last few years are highlighted in the "Procedures and guidelines of the United Nations Voluntary Fund for Victims of Torture for the use of organizations", as revised by the Board on 26 May 2000 (A/55/178, annex II), but not revised at the twentieth session.

21. Addressing the International Association for Humanitarian Medicine at Palermo, Italy, on 18 November 2000, the Chair of the Board, Mr. Walkate, said that the number of victims of torture and members of their families needing assistance was, of course, unknown, but probably measured hundreds of thousands across the world. The vast majority of those were not receiving any treatment at all. They only had the chance of treatment if they were able to find specialized rehabilitation centres, which were mostly being established in Western countries, because of the increasing number of refugees. The exact amount necessary to fund the assistance that they needed was not known.
