RIGHTS OF THE CHILD

Status of the Convention on the Rights of the Child

Report of the Secretary-General

- 1. The General Assembly, in its resolution 44/25 of 20 November 1989, adopted the Convention on the Rights of the Child and expressed the hope that it would come into force at an early date. The Convention was opened for signature in New York on 26 January 1990 and, in accordance with article 49 thereof, entered into force on 2 September 1990, on the thirtieth day after the date of the deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.
- 2. The General Assembly, in its resolution 54/263 of 25 May 2000, adopted two optional protocols to the Convention on the Rights of the Child: the Optional Protocol to the Convention on the involvement of children in armed conflict and the Optional Protocol to the Convention on the sale of children, child prostitution and child pornography. The two optional protocols to the Convention were opened for signature in New York on 5 June 2000. The Optional Protocol to the Convention on the sale of children, child prostitution and child pornography, in accordance with article 14.1 thereof, will enter into force on 18 January 2002, three months after the date of the deposit with the Secretary-General of the United Nations of the tenth instrument of ratification or accession. The Optional Protocol on the involvement of children in armed conflict, in accordance with article 10.1 thereof, will enter into force on 12 February 2002, three months after the date of the deposit with the Secretary-General of the United Nations of the tenth instrument of ratification or accession.

- 3. As at 20 November 2001, the Convention had received 140 signatures which were followed by ratification. In addition, 45 States had acceded to the Convention and six had succeeded to it, bringing the total of ratifications and accessions to the Convention to 191. A list of States that have ratified or acceded to the Convention, and the dates of their signature, ratification or accession, appears in annex I to the present report.
- 4. As at 20 November 2001, the Optional Protocol to the Convention on the involvement of children in armed conflict had been signed by 89 States and ratified by 10 States. As at the same date, the Optional Protocol to the Convention on the sale of children, child prostitution and child pornography had been signed by 84 States and ratified by 12 States. A list of States that have signed or ratified the two optional protocols to the Convention, and the dates of their signature, or ratification appear in annexes II and III to the present report.
- 5. The Committee on the Rights of the Child held its twenty-sixth session from 8 to 26 January 2001 at the United Nations Office at Geneva. At that session the Committee considered reports submitted by nine States parties to the Convention. The Committee also adopted General Comment No. 1 on the aims of education (article 29.1 of the Convention). In addition, the Committee reviewed its cooperation with United Nations bodies and agencies and other competent bodies, including non-governmental organizations. The Committee adopted a report on its twenty-sixth session (CRC/C/103).
- 6. The Committee on the Rights of the Child held its twenty-seventh session from 21 May to 8 June 2001 at the United Nations Office at Geneva. During that session, the Committee considered reports submitted by eight States parties to the Convention. The Committee adopted the report on the session (CRC/C/108).
- 7. The Committee on the Rights of the Child held its twenty-eighth session from 24 September to 12 October 2001 at the United Nations Office at Geneva. At that session, the Committee considered the reports submitted by 10 States parties to the Convention. The Committee also held a day of discussion on "Violence against children in the family and in schools" on 28 September 2001 and adopted a set of recommendations. The Committee adopted the report on the session (CRC/C/111).
- 8. The twenty-ninth session of the Committee on the Rights of the Child will be held from 14 January to 1 February 2002 at the United Nations Office at Geneva.
