#### **Executive summary**

The present addendum contains the recommendations adopted by the Board of Trustees of the United Nations Voluntary Trust Fund on Contemporary Forms of Slavery at its eighth session, held in Geneva from 20 to 24 January 2003, which were approved by the United Nations High Commissioner for Human Rights on behalf of the Secretary-General on 3 February 2003 concerning: the financial status of the Fund; the review by the Board of the reports by beneficiaries on previous grants paid from 1999 to 2002; new travel and project grants for 2003; and the Board's needs assessment for 2004. It updates the reports of the Secretary-General to the Commission on Human Rights at its fifty-ninth session (E/CN.4/2003/83) and to the General Assembly at its fifty-seventh session (A/57/308).

#### I. FINANCIAL STATUS OF THE FUND

1. According to information received from the Programme Planning and Budget Section of the United Nations Office at Geneva, US\$ 153,000 was available from new contributions paid since the seventh session of the Board of Trustees (see annex I) at the beginning of the eighth session. The Board had been informed by the United Nations Treasurer that, in addition, contributions were paid to the Fund by Israel, Saudi Arabia, students of the Archway School (Gloucester, United Kingdom), students and teachers of Scelem (Italy) and Mr. Sandro Spinelli (Italy). A total amount of US\$ 186,000 was therefore available from new contributions at the end of the session.

#### II. EIGHTH SESSION OF THE BOARD OF TRUSTEES

2. During the 10 meetings of its eighth session held in Geneva from 20 to 24 January 2003, the Board of Trustees examined information concerning: (a) the financial status of the Fund, including new contributions received (see annex I); (b) narrative and financial reports on the use of previous grants paid from 1999 to 2002; (c) applications for new travel and project grants in 2003; and (d) the implementation of recommendations approved in 2002. The Board met with representatives of donor and other interested Governments; the Chief of the Forced Labour and Child Labour Section, Department of International Labour Standards, at the International Labour Organization; and staff members of the Office of the United Nations High Commissioner for Human Rights (OHCHR) working on relevant activities. The Board also met with the High Commissioner for Human Rights, Mr. Sergio Vieira de Mello, the Deputy High Commissioner for Human Rights, Mr. Bertrand Ramcharan, and the Chief of the Support Services Branch, Ms. Maria Francisca Ize-Charrin.

#### Review of reports on previous project grants

3. The Board reviewed the narrative and financial reports received on the use of travel and project grants paid in 1999, 2000, 2001 and 2002.

#### Review of the relevant guidelines on travel grants

- 4. The Board recommended that should a victim, beneficiary of a travel grant, be accompanied by a project leader, the latter be requested to give priority to the testimony of the victim, as recommended by the Working Group on Contemporary Forms of Slavery. The Board recommended that, for security reasons, the beneficiaries of travel grants who are former victims should be asked, in advance, if they would prefer to be referred to by surnames in the reports on the Fund.
- 5. In order to further disseminate information on the possibility for victims to apply for travel grants, the Board recommended that the information note on the Fund, the application forms, the selection criteria and the guidelines of the Fund be made available at the annual session of the Working Group as conference room papers.

- 6. The Board underlined that it always takes into consideration the gender dimension, when considering applications for travel grants and revising the application forms and the guidelines of the Board.
- 7. Upon consultation with OHCHR Administration, the Board took into consideration the increase in the cost of living in Geneva in the DSA (daily subsistence allowance) and therefore recommended to also increase the stipend for beneficiaries of travel grants from 150 to 175 Swiss francs.

#### Recommendations for travel and project grants

- 8. The Board examined 37 admissible applications for travel grants amounting to about US\$ 85,800 and 55 admissible applications for project grants amounting to approximately US\$ 745,000 (see charts 1 and 2 in annex II).
- 9. The project and travel grants, recommended at the eighth session, will assist non-governmental organizations (NGOs) in 24 countries in Africa, America, Asia and Europe. In accordance with the mandate of the Fund, the Board's recommendations focused on assisting representatives of NGOs from different regions, dealing with issues of contemporary forms of slavery, to participate in the deliberations of the Working Group on Contemporary Forms of Slavery, as well as on extending, through established channels of assistance, humanitarian, legal and financial aid to individuals whose human rights have been severely violated as a result of contemporary forms of slavery.
- 10. When making recommendations for new travel grants, the Board took into consideration that the main theme approved by the Working Group for its twenty-eighth session, scheduled to take place from 16 to 20 June 2003, is "contemporary forms of slavery related to and generated by discrimination, in particular gender discrimination (such as forced marriage, child marriage, sale of wives)".
- 11. The Board recommended that US\$ 21,995 (25.63 per cent of the total amount requested) be allocated to eight travel grants (see annex III, sect. A). Provided that all conditions attached to the grants have been met, all travel grants should be paid before the twenty-eighth session of the Working Group.
- 12. The Board also recommended that US\$ 101,420 be allocated to 17 project grants in a priority list (see annex III, sect. B) and US\$ 29,500 for 11 projects in a second priority list (ibid., sect. C). The Board therefore recommended 28 project grants for a total of US\$ 152,915.
- 13. In accordance with United Nations rules and regulations governing general trust funds for humanitarian assistance, 13 per cent of the estimated annual expenditures in 2003 had to be set aside for programme support costs related to the servicing of the Fund and 15 per cent of estimated annual expenditures also had to be set aside as a reserve for 2004, in case no new contributions would be received.

#### **Cooperation with the Working Group**

- 14. The Board recommended that travel costs be authorized to enable the Chairperson or another member of the Board of Trustees to participate in the twenty-eighth session of the Working Group, to be held from 16 to 20 June 2003 in Geneva, to introduce the report on the Fund under the relevant agenda item, to meet the beneficiaries of travel grants of the Fund attending the session and introduce them to the Working Group, and to inform the Working Group about the project grants approved and the financial situation of the Fund.
- 15. The Board recommended that the secretariat of the Working Group continue to inform the Board about priority areas that the Working Group will identify, so that the Board could take them into consideration in its selection of applications for travel grants.

#### Recommendations of the Board for the intersessional period

- 16. The Board recommended that provisions be made in the Fund's cost plan for 2004, within proper limits, to enable members of the Board in their geographical region and the secretariat of the Fund to visit projects subsidized by the Fund in order to better evaluate the work carried out and planned. A report on any such visit should be prepared by the Board or a secretariat member for consideration by the Board at its next session.
- 17. The Board recommended that a fact sheet on the activities of the Fund be prepared by OHCHR for information purposes, in a sufficient number of copies for wide dissemination. The Board also recommended that the Office's Fact Sheet No. 14 on contemporary forms of slavery should be revised to include, inter alia, references to the activities of the Fund and the Board. The Board also recommended to its secretariat to prepare a leaflet or brochure for fund-raising and information purposes on the model of the one prepared on the Fund for the International Decade of the World's Indigenous People. The Board would appreciate if the brochure could be ready by or before 2 December 2003 so that the same could be used for creating awareness on the occasion of the International Day for the Abolition of Slavery.
- 18. The Board continued to consider issues of contemporary forms of slavery, taking into consideration the Durban Declaration and Programme of Action adopted at the World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance. The Board underlined that when adopting recommendations for grants it had always taken into consideration, among other violations of human rights, the fact that victims of contemporary forms of slavery were often victims of racial discrimination.
- 19. The Board recommended that a non-discrimination clause be included among the guidelines of the Fund and in the application forms, mentioning that organizations applying to the Fund should demonstrate that assistance is provided to victims and their family members without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status.
- 20. The Board recommended that it issue a statement on the occasion of the International Day for the Abolition of Slavery, appealing for new contributions to the Fund, if possible together with relevant United Nations organs and other partners such as schools.

21. In view of the additional workload caused by the increase in the number of applications received and to be analysed, the Board recommended that additional professional and general service staff and facilities be provided for its secretariat, in order for the Fund and Board to be adequately serviced.

#### III. NEEDS ASSESSMENT FOR THE NINTH SESSION

22. Applications for grants received in 2003 amounted to approximately US\$ 831,000. The Board was only able to recommend about US\$ 175,000 (less than 20 per cent of the total amount requested). In the Board's view, in order to be able to satisfy the new applications envisaged for 2004 and fulfil its mandate satisfactorily, and taking also into consideration that the Board recommended for expenditure almost all money available at its eighth session, the Fund would need new contributions amounting to at least US\$ 300,000 before the ninth session of the Board, scheduled to be held from 19 to 23 January 2004.

#### IV. FUND-RAISING

- The Board held its annual meeting with regular and new donor Governments and other interested Governments on 24 January. The level of participation was encouraging and frank. High-level exchanges took place. The representative of Japan informed the Board about a pledge for 2003 (see annex I), which was about to be paid.
- 24. The Board very much appreciated the fact that more and more school students, NGOs and other private entities and individuals are becoming regular donors to the Fund.
- 25. The Board also very much appreciated that the High Commissioner for Human Rights had expressed his willingness to support the Board in its fund-raising mandate.

#### V. NINTH SESSION

26. The Board recommended that its next session be held, if possible, from 19 to 23 January 2004 at the Palais Wilson in Geneva.



(a) Applications for travel grants to attend the twenty-eighth session of the Working Group on Contemporary Forms of Slavery


(16-20 June 2003)
