**Записка секретариата**

1. Межправительственная рабочая группа по эффективному осуществлению Дурбанской декларации и Программы действий на своей первой сессии просила Управление Верховного комиссара по правам человека представить ей на ее следующей сессии информацию об имеющихся координационных центрах по осуществлению Дурбанской декларации и Программы действий в системе Организации Объединенных Наций и предложила программам, органам и специализированным учреждениям Организации Объединенных Наций, в настоящее время не располагающим такими координационными центрами, назначить их и согласовывать их деятельность с Управлением Верховного комиссара по правам человека, включая их активное участие в будущих сессиях Рабочей группы (E/CN.4/2003/20, пункт 33, рекомендация 14).

2. Управление Верховного комиссара по правам человека в вербальной ноте от 17 ноября 2003 года запросило эту информацию у программ, органов и специализированных учреждений Организации Объединенных Наций, а также у международных и региональных организаций. В настоящей записке содержится полученная информация о координационных центрах<sup>a</sup>.
