Nota de la secretaría

1. El Grupo de Trabajo Intergubernamental sobre la aplicación efectiva de la Declaración y Programa de Acción de Durban en su primer período de sesiones pidió a la Oficina del Alto Comisionado para los Derechos Humanos que facilitara al Grupo de Trabajo, en su siguiente período de sesiones, información sobre los centros de coordinación existentes dentro del sistema de las Naciones Unidas para la aplicación de la Declaración y Programa de Acción de Durban, e invitó a los programas, órganos y organismos especializados de las Naciones Unidas que no disponían de centros de coordinación a que los designaran y a que coordinaran sus actividades con la Oficina del Alto Comisionado para los Derechos Humanos, incluida su participación activa en los futuros períodos de sesiones del Grupo de Trabajo (E/CN.4/2003/20, párr. 33, recomendación 14).

2. La Oficina del Alto Comisionado para los Derechos Humanos pidió esa información mediante nota verbal de 17 de noviembre de 2003 a los programas, órganos y organismos especializados de las Naciones Unidas y a las organizaciones internacionales y regionales.
