### RATIONALIZATION OF THE WORK OF THE COMMISSION

### **Note by the Secretariat**

On 16 December 2004, the President of the Economic and Social Council addressed a letter to the Chairperson of the sixtieth session of the Commission on Human Rights drawing the attention of the Commission to some of the important decisions adopted by the Council at its substantive session of 2004 concerning functional commissions. Attached to the letter was a list of resolutions adopted by the Council specifically calling for action by its functional commissions. The President of the Council requested that the issues raised in her letter be brought to the attention of the Commission for consideration and action. Pursuant to that request, the letter of the President of the Economic and Social Council is reproduced in the annex below.\*

### The President of the Economic and Social Council

16 December 2004

Excellency,

The 2004 substantive session of the Council reconfirmed the role of the Council as the central forum of the UN system to address key issues of development cooperation. The theme of this year's high-level segment, "Resources mobilization and enabling environment for poverty eradication in the context of the implementation of the Programme of Action for the Least Developed Countries for the Decade 2001-2010" provided us with the timely opportunity to renew commitment to the development of LDCs and to identify practical measures that could enable these countries to embark on a path of sustained economic growth.

I am confident that the Ministerial Declaration adopted at the end of the high level segment will contribute to the efforts to give new impetus to the implementation of the Brussels Programme of Action by Member States and by the UN system, particularly the ECOSOC subsidiary bodies.

At its coordination segment, the Council addressed gender mainstreaming and integrated rural development. While addressing mainstreaming the gender perspective into all policies and programmes in the United Nations system, the Council in its resolution 2004/4 calls upon its functional commissions to take further measures to incorporate recommendations provided by the Commission on the Status of Women and to fully integrate gender perspectives into their work. I request you to take into account these considerations in your future programme of work.

I should also like to reflect on some of the other important proposals made by the Council concerning functional commissions. A list of these resolutions adopted by the Council specifically calling for action by functional commissions is attached for ease of reference (see annex).

Among those, I should like to draw your particular attention to resolution 2004/44 on the role of the Economic and Social Council in the integrated and coordinated implementation of the outcomes of and follow-up to major United Nations conferences and summits. In this resolution, the Council decided to continue to take the necessary steps for the effective implementation of the provisions of GA resolutions 50/227, 52/12B and 57/270 B that are relevant to the work of the Council and its subsidiary machinery.

H.E. Mr. Mike Smith Chairperson Commission on Human Rights Resolution 2004/44 requests the functional commissions and other relevant subsidiary bodies to continue to examine their methods of work as mandated in GA resolution 57/270B and to submit their reports to the Council in 2005. In addition, the resolution requests the functional commissions to contribute to the preparation of the input of the Council to the high-level plenary meeting of the General Assembly.

The Council, in its resolution 2004/63 requests its functional commissions, in their review of conference implementation in 2005, to promote complementarity in their work and to follow the guidance of the Council as well as the Assembly. It also requests its commissions, in their reports, to clearly identify the operational implications of their work for consideration and appropriate action by the governing bodies of the United Nations funds and programmes.

I would also like to take this opportunity to inform you that the council has selected "Achieving the internationally agreed development goals, including those contained in the Millennium Declaration, as well as implementing the outcomes of the major United Nations conferences and summits: progress made, challenges and opportunities" as the theme for its High-Level Segment next year. As the theme for its Coordination Segment, the council has selected: "Towards achieving internationally agreed development goals, including those contained in the Millennium Declaration."

I would greatly appreciate it if the issues raised above could be brought to the attention of your functional commission for consideration and action. I thank you for your active and continued collaboration and hope that this would lead to further strengthening of the interactions among the functional commissions and the Council.
