During the sixtieth session of the Commission on Human Rights:

- 32.7% of all interventions were made by Asian States (482 out of 1,472 interventions);
- 23.4% of all interventions were made by Western European and other States (344 out of 1,472 interventions);
- 19.6% of all interventions were made by Latin American and Caribbean States (288 out of 1,472 interventions);
- 17.1% of all interventions were made by African States (252 out of 1,472 interventions);
- 7.2% of all interventions were made by Eastern European States (106 out of 1,472 interventions).
