Note of the Secretary-General

Summary

In accordance with Commission on Human Rights resolution 2005/39, the present note provides updated information on the activities of the Fund since the publication of the report of the Secretary-General to the General Assembly (A/60/215) on 10 August 2005. It also describes the financial needs of the Fund for 2006 and 2007.

I. BOARD OF TRUSTEES

A. Renewal of the Board

1. On 17 August 2005, the Secretary-General appointed the following members to the Board of Trustees of the Fund for a three-year term renewable once: Mr. Krassimir Kanev (Bulgaria), Ms. Sonia Picado (Costa Rica), Ms. Savitri Goonesekere (Sri Lanka), Mr. Joseph Oloka-Onyango (Uganda), and Mr. Derrick Pounder (United Kingdom of Great Britain and Northern Ireland). The Board will hold its twenty-fifth session from 5 to 11 April 2006. The recommendations of the Board adopted by the Secretary-General will be available in the report of the Secretary-General to the sixty-first session of the General Assembly.

B. Change in the funding cycle

2. At its twenty-fourth session, the Board of Trustees decided to implement recommendation 10 of the Office of Internal Oversight Services (OIOS) following its evaluation of the Fund (E/CN.4/2005/55), whereby "support from the Fund should be for a *future* period, rather than one that has largely passed and the funding cycle should be changed accordingly". Consequently, the Board recommended that the implementation period for the grants awarded for 2005 should be extended until 30 June 2006. In this regard, organizations received payment in two instalments: the first instalment to cover the year 2005; and the second the first six months of 2006. At its next session, the Board will also make recommendations for grants for an 18-month period to cover the second semester of 2006 and the year 2007. Thereafter, the Board will meet in October to allocate grants for the following year.

II. IMPLEMENTATION OF THE RECOMMENDATIONS OF THE OFFICE OF INTERNAL OVERSIGHT SERVICES

- 3. The implementation of the recommendations of the OIOS, following its evaluation of the Fund, is still ongoing. Their status is reviewed by the OIOS every six months. Since the publication of the report of the Secretary-General to the General Assembly, which provided information on the measures taken by the secretariat of the Fund to implement the recommendations, 7 out of the 19 recommendations that remain open have been updated. For instance, as indicated above, the Secretary-General has appointed a new Board of Trustees, giving particular attention to gender balance and diversity of professional experience and expertise. In addition, as recommended by the OIOS, the mandate of the new members is limited to a three-year period renewable only once. With regard to increased staffing, a staff member with a strong management and fund-raising background was recruited in September 2005, as well as an information and technology programmer who is currently developing a grants management system. It is expected that a prototype will be available to be shown to the Board of Trustees at its twenty-fifth session, in April 2006.
- 4. A grant has been provided to the University of Bern to prepare the book to commemorate the twenty-fifth anniversary of the Fund and work is well under way. The book will be launched on 26 June 2006, International Day in Support of Victims of Torture. New public information materials and a new website will be derived from the book and will be available by the end of 2006.

5. Other recommendations requiring policy decisions by the Board of Trustees, such as a clearer definition of family members of torture victims as beneficiaries of the Fund, multi-year project approval and a more strategic funding formula, will be put to the Board at its next session. Concept papers are being prepared by the secretariat on the different topics to be discussed.

III. TWENTY-FIFTH SESSION

A. Estimated needs for 2006/2007

6. On the basis of the requests received for 2005 (amounting to US\$ 14.1 million), the Board estimated that at least US\$ 14 million would be needed at its next session if it were to cover all new requests envisaged for a 12-month period. Taking into account the fact that grants will need to cover an 18-month period, from July 2006 through to December 2007, an additional amount of US\$ 7 million would consequently be needed to fully meet all admissible requests during the period indicated.

V. CONCLUSIONS AND RECOMMENDATIONS

- 9. Pursuant to the appeals by the General Assembly, the Commission on Human Rights and the Board of Trustees of the Fund, donors are invited to pay their contributions to the Fund before March 2006 to enable the Board to take them into account at its twenty-fifth session, in April 2006.
- 10. The General Assembly, the Commission and the Board have also urged regular donors to increase their contributions if possible in order to provide the Board with the resources to meet the growing needs of torture victims and the members of their families.
- 11. The Board strongly encourages Governments that have not yet contributed to the Fund to do so for the first time, preferably before March 2006.
