**RAPPORT DE LA SOUS-COMMISSION DE LA PROMOTION ET  
DE LA PROTECTION DES DROITS DE L'HOMME:  
ÉLECTION DES MEMBRES**

**Note du Secrétaire général\***

1. Conformément aux résolutions 1334 (XLIV) et 1986/35 du Conseil économique et social, en date du 31 mai 1968 et du 23 mai 1986 respectivement, et aux décisions 1978/21 et 1987/102 du Conseil, en date du 5 mai 1978 et du 6 février 1987 respectivement, la Commission des droits de l'homme a élu au scrutin secret, à sa quarante-quatrième session, les 26 membres de la Sous-Commission de la lutte contre les mesures discriminatoires et de la protection des minorités, rebaptisée en 1999 Sous-Commission de la promotion et de la protection des droits de l'homme, parmi les experts dont les États Membres de l'Organisation des Nations Unies avaient proposé la candidature sur la base suivante: a) sept membres parmi les États d'Afrique; b) cinq membres parmi les États d'Asie; c) trois membres parmi les États d'Europe orientale; d) cinq membres parmi les États d'Amérique latine; e) six membres parmi les États d'Europe occidentale et autres États.

2. Conformément à la résolution 1986/35 du Conseil, les membres de la Sous-Commission sont élus pour un mandat de quatre ans et l'élection de la moitié d'entre eux et, le cas échéant, de leurs suppléants a lieu tous les deux ans. Le Président de la quarante-quatrième session de la Commission des droits de l'homme a procédé à un tirage au sort pour désigner les membres et, le cas échéant, leurs suppléants dont le mandat expirera au bout de deux ans sur la base suivante: trois membres parmi les États d'Afrique; trois membres parmi les États d'Asie; un membre parmi les États d'Europe orientale; trois membres parmi les États d'Amérique latine; et trois membres parmi les États d'Europe occidentale et autres États.

3. En 1990, 1992, 1994, 1996, 1998, 2000, 2002 **et 2004**, le mandat de la moitié des membres de la Sous-Commission ayant expiré, la Commission des droits de l'homme, à ses quarante-sixième, quarante-huitième, cinquantième, cinquante-deuxième, cinquante-quatrième, cinquante-sixième, cinquante-huitième **et soixantième** sessions, a élu les nouveaux membres de la Sous-Commission et leurs suppléants\*.

4. La liste des membres actuels de la Sous-Commission est présentée à l'annexe II.

5. Le mandat de la moitié des membres de la Sous-Commission ayant expiré, la Commission des droits de l'homme est appelée, à sa **soixante-deuxième** session, à élire de nouveau des membres de la Sous-Commission et leurs suppléants sur la base suivante: **trois** membres parmi les États d'Afrique; **trois** membres parmi les États d'Asie; **un** membre parmi les États d'Europe orientale; **trois** membres parmi les États d'Amérique latine; et trois membres parmi les États d'Europe occidentale et autres États.

6. Dans sa résolution **2005/53 en date du 20 avril 2005**, la Commission des droits de l'homme a demandé aux États, lorsqu'ils présentent des candidats et élisent des membres de la Sous-Commission et leurs suppléants:

a) D'être conscients qu'il importe particulièrement que cet organe soit indépendant et qu'il soit perçu comme tel et, **notamment, de veiller à ce que les candidats à la qualité de membre de la Sous-Commission soient impartiaux et indépendants, que ces candidats échappent à tout conflit d'intérêts et que, s'ils sont élus, les États ayant présenté leur candidature ne cherchent pas à exercer sur eux une influence indue, dans l'accomplissement de leurs tâches;**

b) D'avoir à l'esprit la nécessité **de témoigner d'un souci d'universalité, d'assurer une représentation équilibrée et de tenir compte à la fois des vertus de la continuité et de l'importance du renouvellement;**

c) D'élire des membres ayant une compétence reconnue dans le domaine des droits de l'homme;

d) De présenter des candidats, si possible, au moins deux mois avant le début de la session à laquelle ils seront élus, pour permettre aux membres de la Commission d'évaluer de manière approfondie les qualifications et l'indépendance des intéressés.

**e) De s'abstenir de chercher à exercer une influence indue sur ceux qui sont déjà membres de la Sous-Commission ou leurs suppléants.**

On se souviendra que, dans sa résolution 1987/32, la Sous-Commission avait porté à la connaissance de la Commission des droits de l'homme la recommandation du Groupe de travail des formes contemporaines d'esclavage tendant à ce que la Commission s'efforce d'amener tous les gouvernements à désigner davantage de femmes pour être élues à la Sous-Commission.

7. En ce qui concerne la désignation des suppléants, le Conseil économique et social a décidé, dans sa résolution 1983/32, que:

«... nonobstant le paragraphe 2 de l'article 13 du règlement intérieur des commissions techniques du Conseil économique et social, les règles suivantes s'appliqueront désormais à la Sous-Commission [de la promotion et de la protection des droits de l'homme]:

a) Lors de la désignation d'un candidat à un siège à la Sous-Commission, il est loisible de désigner en même temps un expert de la même nationalité qui sera élu simultanément avec lui et pourra le suppléer temporairement dans ses fonctions en cas d'empêchement;

b) Les qualifications requises sont les mêmes pour les suppléants que pour les membres;

c) Est seul habilité à suppléer un membre dans ses fonctions l'expert qui a été élu suppléant, conformément aux dispositions de l'alinéa *a* ci-dessus.».

8. Au **12 décembre 2005**, le Secrétaire général avait reçu des propositions de candidature à la Sous-Commission des pays suivants: **Brésil, Chine, Fédération de Russie, Grèce, Lettonie, Inde, Iraq, Pakistan, Suisse et Togo.**

9. Les autres communications et propositions de candidature qui seront reçues de gouvernements seront distribuées en tant qu'additifs au présent document.

10. On trouvera ci-après la liste des propositions de candidature reçues des gouvernements à ce jour; le curriculum vitae des candidats est présenté dans l'annexe.

An active member of the Sub-Commission on the Promotion and Protection of Human Rights in 2002-2005, Mr. Abdul Sattar is currently a commentator with a weekly column in a daily newspaper on topical international and domestic issues. Earlier, he served as foreign minister, ambassador to several countries and representative to IAEA. He was a Distinguished Fellow of the United States Institute of Peace in 1993-1994, and was associated with the International Bureau on Humanitarian Issues in 1995-1996. He is author of a history of Pakistan's foreign policy, research papers on Reducing Nuclear Dangers in South Asia and Shimla Agreement, and numerous articles in Pakistani and foreign newspapers.

As member of the Sub-Commission he promoted greater attention on economic, social and cultural rights, played an active part in the Social Forum, sponsored recognition of corruption as a violation of human rights and served on the Working Group on Slavery. He was Ambassador to Austria and Representative to IAEA in 1975-1978, to India in 1978-1982 and 1990-1992, and USSR, 1988-1990.

At the United States Institute of Peace he wrote a research paper on "Reducing Nuclear Dangers in South Asia" which was published in the prestigious journal *The Non-proliferation Review* of Monterey, California, and in *Dawn*, Karachi. Another paper on "Shimla Agreement" was published in *Regional Studies*, Islamabad, and a journal in New Delhi in 1995. Also he wrote numerous columns in *Dawn* and *The News* during 1995-1999.

His book "Concise History of Pakistan's Foreign Policy" is under process for publication by Oxford University Press in early 2006.

He holds M.A. degree in International Law and Diplomacy from Fletcher School of Tufts University, Medford (USA). Earlier he studied in Pakistan at Punjab University, Forman Christian College and Islamia School.
