Annotations to the provisional agenda

Item 1. Opening of the informal meeting

1. The Chairperson of the fifty-seventh session of the Commission will make an introductory statement.

2. A statement will also be made by the High Commissioner for Human Rights.

3. The Chairperson of the fifty-seventh session of the Commission will then deliver a substantive statement.

Item 2. Implementation of Commission decision 2000/109

Legislative authority

4. At its fifty-sixth session, in decision 2000/109 of 26 April 2000, the Commission decided to approve and implement comprehensively and in its entirety the report of its inter-sessional open-ended working group on enhancing the effectiveness of the mechanisms of the Commission (E/CN.4/2000/112).

5. The attention of the Commission is drawn to paragraphs 33 and 34 of the above-mentioned report, which read as follows:

"The cycle of meetings (the Commission session in spring; the United Nations General Assembly in autumn) is such that the Third Committee of the General Assembly is well placed to consider developments in the interim since the Commission session. Given the significant overlap both in agenda and in attendance between the Commission and the Third Committee, the Working Group considers that there is scope for a more dynamic sense of connection between the two. In particular, the Group recognizes the rationale for some form of enhanced preparation in Geneva so as to ensure that all delegations have relevant information available to them in their preparations for the Third Committee." "The Working Group therefore recommends that the Chairperson of the Commission should convene a one-day informal meeting of the Commission in late September each year specifically to facilitate exchange of information in advance of the General Assembly. The meeting, which would not have a formal outcome, would have an agenda comprising those issues which had been dealt with at the previous Commission session and which were also on the provisional agenda for the Third Committee. Each item would be focused on briefly, with information from the Secretariat on any developments since the Commission session, and an opportunity for comment by government representatives, including any indication of intentions for tabling resolutions in the Third Committee." Informal one-day meeting of the Commission in 2000

6. At its post-sessional meetings in October and November 2000, the Bureau of the fifty-sixth session of the Commission had before it an information note on the first informal one-day meeting of the Commission held on 15 September 2000. The Bureau discussed the note and agreed that it could be used for information purposes. The text of the note is reproduced in paragraphs 7 to 12 below.

7. The first informal one-day meeting of the Commission on Human Rights convened pursuant to Commission decision 2000/109 was held in Conference Room XVII of the Palais des Nations on 15 September 2000. Over 220 participants representing Governments and intergovernmental and non-governmental organizations took part in this meeting, the main task of which was to facilitate the exchange of information in advance of the General Assembly.

8. Prior to the informal meeting, on 12 September 2000, a briefing was organized by the Office of the High Commissioner for Human Rights (OHCHR) for all interested delegations during which the Secretariat provided them with information regarding the scenario and other technical details of the informal meeting. An information note for participants dated 1 September 2000 was circulated to all Permanent Missions in Geneva and major NGOs in advance of the meeting. The information note referred to issues of participation, accreditation, documentation and proposed organization of work.

9. The provisional agenda of the meeting and annotations thereto were contained in document E/CN.4/IM/2000/1. The documentation for the meeting consisted of reports prepared by OHCHR for consideration by the Third Committee of the General Assembly (mainly advance unedited versions) as well as of a few background and reference documents and various information materials. The reports prepared for the General Assembly were placed on the OHCHR Web site. Nine such documents had already been issued in final form and were available in the Conference Room in hard copy. Complete sets of all documents had been distributed by the Secretariat to all Bureau members and regional coordinators. Such sets were also available for consultation by all interested delegations participating in the meeting.

10. The agenda of the meeting followed the human rights items allocated in 2000 by the General Assembly to the Third Committee. On each item, staff members of OHCHR provided highlights of recent developments and information with respect to 59 reports submitted in 2000 by OHCHR to the Third Committee. The United Nations High Commissioner for Human Rights, Mrs. Mary Robinson, provided an update on her report to the General Assembly. In total, 27 government representatives and 10 NGO representatives took the floor to make comments, ask questions and share information, including indications by several Governments of their intentions to table resolutions in the Third Committee.

11. The meeting, which was one of the innovations and improvements relating to the functioning of the Commission on Human Rights agreed in its decision 2000/109, was acknowledged by all speakers as a useful and successful exercise.

12. The Chairperson of the fifty-sixth session of the Commission called upon those delegations which would be attending the session of the General Assembly to revert back to the Commission with feedback on how useful the informal meeting had been in terms of making relevant information available to them in their preparations for the Third Committee. He also welcomed comments through regional coordinators about how the meeting could be further improved, since from now on it would be held on an annual basis.

Background information concerning the work of the Third Committee

13. According to preliminary information provided by the secretariat of the Third Committee, the Committee will begin its work on 3 October 2001, at which time it will approve its draft programme of work. (It is to be noted that, as the dates of relevant meetings of the Third Committee and the numbers of agenda items are still subject to change, they are put in square brackets.) The Third Committee will begin consideration of human rights items on [22 October] with the item on the promotion and protection of the rights of children. Consideration of other human rights items would begin on [29 October]. It is proposed that the High Commissioner's dialogue take place on [7 November], followed by the dialogues with the special rapporteurs on [8, 9 and 12 November].

14. The human rights items to be allocated to the Third Committee by the General Assembly this year are as follows:

Proposed organization of work

15. As was the practice last year, it is proposed that the secretariat make presentations of a primarily informative nature concerning the human rights items allocated by the General Assembly to the Third Committee this year. These presentations will provide highlights of significant developments since the fifty-seventh session of the Commission with respect to the human rights items to be considered by the Third Committee, and pertinent information with respect to the reports submitted by OHCHR to the Third Committee. The High Commissioner for Human Rights will also take the floor in connection with her reports to the General Assembly.

16. After the presentation of each item/issue by the secretariat in the order of the human rights agenda items of the Third Committee, a general discussion will follow (questions and answers). Government representatives, observers for United Nations departments, specialized agencies and intergovernmental organizations, if any, will be given the floor for short interventions. It is expected that particular emphasis will be placed by government representatives and draft resolutions they intend to table during the fifty-sixth session of the General Assembly.

17. The Bureau of the Commission would welcome the participation in the informal one-day meeting of the Chairperson of the 8th annual meeting of the special rapporteurs/representatives, experts and chairpersons of working groups of the special procedures of the Commission, the Chairperson of the 13th annual meeting of the chairpersons of the human rights treaty bodies and the Chairperson of the Sub-Commission on the Promotion and Protection of Human Rights (or their representatives) should they happen to be in Geneva at that time. The mandate holders of special procedures and chairpersons of the treaty bodies have been encouraged, in connection with their respective reports to the General Assembly, to submit to the secretariat of the Commission a one-page update providing the essence of any significant developments regarding their respective mandates or reports, which will be read out by the secretariat.
