The present note contains the recommendations adopted by the Board of Trustees of the United Nations Voluntary Fund for Indigenous Populations at its nineteenth session, held in Geneva from 13 to 17 February 2006, which were approved by the United Nations High Commissioner for Human Rights on behalf of the Secretary-General on 1 March 2006.

#### **Summary**

The nineteenth session of the Board of Trustees of the United Nations Voluntary Fund for Indigenous Populations was held in Geneva from 13-17 February 2006. At the session, the Board examined a total of 395 admissible applications, in the light of the criteria for the selection of beneficiaries adopted by the General Assembly, and approved a total of 101 grants, for a total of some US\$ 439,335.

The Board recommended to the Secretary-General 46 grants for representatives of indigenous communities and organizations to attend the fifth session of the Permanent Forum on Indigenous Issues (New York, 15-26 May 2006), 45 grants for indigenous representatives of indigenous communities and organizations to attend the twenty-fourth session of the Working Group on Indigenous Populations (Geneva, 31 July-4 August 2006), and 10 grants for representatives of indigenous communities and organizations to attend the next session of the open-ended intersessional working group on a draft United Nations declaration of the rights of indigenous peoples, in the case that the mandate of that Working Group should be extended.

The annexes contain lists of the beneficiaries and the indigenous peoples they represent, and a table showing the contributions and pledges made to the Voluntary Fund.

#### Mandate of the Fund

- 1. The General Assembly, convinced that the establishment of a voluntary trust fund would constitute a significant development for the future promotion and protection of the human rights of indigenous populations, established the United Nations Voluntary Fund for Indigenous Populations by resolution 40/131 of 13 December 1985. The sole purpose of the Fund was to assist representatives of indigenous communities and organizations to participate in the deliberations of the Working Group on Indigenous Populations of the Sub-Commission on the Promotion and Protection of Human Rights by providing them with financial assistance, funded by means of voluntary contributions from Governments, non-governmental organizations and other private or public entities.
- 2. On 21 December 1995, the General Assembly expanded the mandate of the Fund by resolution 50/156, deciding that the Fund should also be used to assist representatives of indigenous communities and organizations to participate in the deliberations of the open-ended intersessional working group of the Commission on Human Rights on a draft United Nations declaration on the rights of indigenous peoples established by the Commission in its resolution 1995/32, as endorsed by the Economic and Social Council on 25 July 1995.
- 3. The General Assembly further expanded the mandate of the Fund in its resolution 56/140 of 19 December 2001 by deciding that the Fund should also be used to assist representatives of indigenous communities and organizations in attending, as observers, the sessions of the Permanent Forum on Indigenous Issues. In accordance with Council resolution 2000/22, which established the Permanent Forum as a subsidiary organ of the Council, its mandate is to discuss indigenous issues within the mandate of the Council relating to economic and social development, culture, the environment, education, health and human rights.

#### Mandate of the Board of Trustees

- 4. The mandate of the Board of Trustees of the Fund, as established by the General Assembly, is to advise the Secretary-General on the administration of the Fund, through the Office of the United Nations High Commissioner for Human Rights (OHCHR). The Board is composed of five persons with relevant experience on issues affecting indigenous populations, who serve in their personal capacity as United Nations experts. The Board members are appointed by the Secretary-General for a three-year, once-renewable term, in consultation with the current Chairman of the Sub-Commission on the Promotion and Protection of Human Rights. At least one member shall be a representative of a widely recognized organization of indigenous populations.
- 5. The five current members, whose term started on 1 January 2006, are themselves indigenous experts: Mr. Lars Anders Baer (Sami, Sweden), Mr. Nadir Bekirov (Crimean Tatar, Ukraine), Mr. Ahmed Mahiou (Amazigh, Algeria), Ms. Jannie Lasimbang (Kadazan, Malaysia) and Ms. Tarcila Rivera Zea (Quechua, Peru). Mr. Lars Anders Baers was not able to attend the session.

#### **Beneficiaries**

6. The criteria for the selection of beneficiaries have been established by the General Assembly, the Commission on Human Rights, as well as by the Secretary-General, upon recommendations of the Board of Trustees (see annex I).

#### Nineteenth session of the Board of Trustees

- 7. The nineteenth session of the Board of Trustees was held at the Palais Wilson in Geneva from 13 to 17 February 2006. The meeting was opened by Mr. Julian Burger, Coordinator of the Indigenous Peoples and Minorities Unit. In his opening remarks, he welcomed the members and in particular the two new members of the Board, and thanked them for their dedication and commitment to indigenous affairs.
- 8. The Board held 10 private meetings. It examined information prepared by the secretariat concerning the implementation of recommendations adopted at its eighteenth session and the financial situation of the Fund, including new contributions paid. In accordance with the mandate of the Fund, established in General Assembly resolutions 40/131 of 13 December 1985, 50/156 of 21 December 1995 and 56/140 of 19 December 2001, the Board considered applications for travel grants from representatives of indigenous organizations and communities to attend the 2006 sessions of the Permanent Forum on Indigenous Issues, the Working Group on Indigenous Populations and the Working Group on the Draft United Nations Declaration on the Rights of Indigenous Peoples.
- 9. On the first day of the session, the Board was briefed by the Indigenous Peoples and Minority Unit on the last sessions of the Working Group on Indigenous Populations, the Working Group on the Draft United Nations Declaration on the Rights of Indigenous Peoples, the seminar on indigenous peoples' permanent sovereignty over natural resources and their relationship to land, and the work of the Special Rapporteur on the situation of human rights and fundamental freedoms of indigenous peoples. Mr. Burger discussed recent developments, such as the establishment of a Human Rights Council and the OHCHR Strategic Management Plan, with its emphasis on country engagement.
- 10. The Board was also briefed by Mr. Philippe Charlemagne, of the Resource Mobilization Unit, on OHCHR's fundraising, the various categories of earmarked contributions and the latest annual appeal. The Board members expressed their hope that sufficient funds were available to accommodate the growing demand by indigenous peoples to participate in international forums.

#### Implementation of recommendations adopted at the eighteenth session in 2005

11. The Board noted with satisfaction that all the recommendations adopted at its eighteenth session had been satisfactorily implemented.

#### Consideration of new applications for grants

12. In accordance with resolution 2004/15 of the Sub-Commission on the Promotion and the Protection of Human Rights, the Board was informed that the main theme to be discussed in 2006 at the Working Group on Indigenous Populations will be: "Utilization of indigenous peoples' lands by non-indigenous authorities, groups or individuals for military purposes".

The Board was also informed that the special theme of the Permanent Forum to be discussed in 2006 will be: "Millennium Development Goals and indigenous peoples", focusing on goals 3 to 8, namely to "promote gender equality and empower women", "reduce child mortality", "improve maternal health", "combat HIV/AIDS and other diseases", "ensure environmental sustainability", and "develop a global partnership for development". The Board took into consideration the issues presented when selecting beneficiaries.

13. The Board of Trustees reviewed the financial situation of the Fund and the list of contributions received since the eighteenth session from regular and new donors, as well as the balance that remained in the Fund. After deducting mandatory provisions for programme support costs (13 per cent) and the operating cash reserve (15 per cent), in accordance with the relevant United Nations financial rules, an amount of US\$ 490,884 was available for expenditure.

#### 14. The Board considered:

- (a) A total of 203 admissible applications for travel grants (to cover travel costs and a daily stipend) for representatives of indigenous communities and organizations to attend the fifth session of the Permanent Forum on Indigenous Issues to be held in New York from 15 to 26 May 2006;
- (b) A total of 177 admissible applications for travel grants (to cover travel costs and a daily stipend) for representatives of indigenous communities and organizations to attend the twenty-fourth session of the Working Group on Indigenous Populations to be held in Geneva from 31 July to 4 August 2006; and
- (c) A total of 15 admissible applications for travel grants (to cover travel costs and a daily stipend) for representatives of indigenous communities and organizations to attend the twelfth session of the Working Group on a draft declaration on the rights of indigenous populations to be held in Geneva in September 2006, in the case the Commission on Human Rights or the Human Rights Council should decide to extend the mandate of that Working Group.

#### Recommendations for grants

- 15. Having examined the applications in the light of the selection criteria, established by the General Assembly, the Commission on Human Rights, as well as by the Secretary-General upon recommendations of the Board of Trustees, the Board recommended for approval to the Secretary-General:
- (a) Forty-six grants for representatives of indigenous communities and organizations to attend the PFII, for a total amount of about US\$ 244,320 (see annex III);
- (b) Forty-five grants for representatives of indigenous communities and organizations to attend the WGIP, for a total amount of about US\$ 148,115 (see annex IV); and
- (c) Ten grants for representatives of indigenous communities and organizations to attend the WGDD, for a total amount of about US\$ 46,900 (see annex V).

- 16. The Board decided to establish a contingency list of five additional possible beneficiaries to attend the WGIP for an amount of about US\$ 20,878 and nine additional possible beneficiaries to attend the PFII for a total amount of about US\$ 47,100 (see annexes VI and VII).
- 17. When making recommendations, the Board took into consideration the travel cost estimates provided by the OHCHR Travel Unit.
- 18. The Board ensured geographical, gender and intergenerational balance as much as possible in the selection process.

#### Recommendations concerning the Permanent Forum on Indigenous Issues

- 19. The Board recommended that the Bureau of the Forum at its fifth session in 2006 invite the Chairperson, or any other member of the Board who could be in New York during the session or the secretariat of the Fund, to deliver a statement on the implementation of the mandate given to the Fund by General Assembly resolution 56/140 of 19 December 2001.
- 20. The Board recommended that members of the Board present in New York meet with the members of the Forum informally to exchange information, and that they meet with donors.

#### Other recommendations

- 21. The Board recommended that the secretariat explore the possibility of developing a database containing relevant information on grants and beneficiaries, including information on their indigenous communities, the beneficiaries themselves and their respective organizations.
- 22. The Board recommended that travel arrangements be made well in advance of the meetings to reduce travel costs.
- 23. The Board noted the particular difficulty involved in accessing information on certain indigenous groups in Africa that could benefit from the assistance of the Fund, and recommended, inter alia, seeking the cooperation of the Working Group of Experts on Indigenous Populations/Communities of the African Commission on Human and Peoples' Rights, African Permanent Missions in Geneva and other relevant organizations, with a view to identifying such groups and obtaining accurate information.
- 24. The Working Group on Indigenous Populations at their annual session in 2006 should continue to invite the Chairperson or any other member of the Board who could be in Geneva during the session, or the secretariat of the Fund, to deliver a statement introducing the report of the Secretary-General on the Fund. The Board recommended that the Working Group on the United Nations Draft Declaration could follow the same practice.
- 25. The Board members emphasized the need to actively distribute the Fund's application forms as widely as possible, in particular in regions and countries which have been underrepresented.

- 26. The Board, taking note of the analysis by the secretariat of the replies received from beneficiaries on the impact of travel grants, recommended continuing to request beneficiaries to report on the follow-up activities organized upon their return, as well as on their participation at the Working Groups or Permanent Forum, to ensure that the community also benefits from the participation of their representative.
- 27. The Board recommended that side events be organized during the Permanent Forum and the WGIP to familiarize participants with the work of the Fund. These events should include presentations by past beneficiaries of grants from the Fund, to provide specific examples of the impact of the Fund.
- 28. With a view to reaching a wider range of indigenous organizations, the Board recommended that the Indigenous and Minorities Unit explore various communication channels and develop a directory of indigenous organizations. Indigenous organizations, in particular those working at the regional level, could be of assistance in collecting and updating data.
- 29. The Board recommended producing a publication on the Fund, based on the model of the Decade Fund, to include general information on the history and work of the Fund. The publication should be produced in English, French, Spanish and Russian.

#### Cost plan for 2007

- 30. The Board revised and approved the cost plan of the Fund for 2007 with envisaged expenditure amounting to US\$ 733,600.
- 31. The Board expressed its satisfaction with the increase of available funds.

#### **Fund-raising**

- 32. The Board held its annual meeting with donors on 16 February 2006. The meeting was attended by representatives of Algeria, Argentina, Australia, Australia, Azerbaijan, Brazil, Canada, Chile, Denmark, Ecuador, Estonia, Finland, France, Germany, Guatemala, the Holy See, Mexico, Norway, Pakistan, Peru, Spain, Sweden, Switzerland, Thailand, the United States of America, Venezuela and the European Commission. The Board expressed appreciation for the donors' contributions to the Fund.
- 33. A number of States expressed their strong support for the Fund. The representative of Pakistan remarked on the striking gap between available funds and grant requests. Several States expressed deep concerns on the issue of a United Nations draft declaration on the rights of indigenous peoples and highlighted the necessity to fund representatives to the next session of the Working Group.
- 34. Several States announced their intentions to contribute to the Fund. The representative of Venezuela announced that Venezuela will be making a contribution of US\$ 10,000 to the fund and reiterated its support to the work of the Fund. The representative of Mexico announced that it will be making a contribution of US\$ 10,000 to the fund. The representative of Spain announced that Spain's contribution to the OHCHR will contain a significant earmarked element for the Fund.

35. The Board recommended that the Bureau of the future Human Rights Council, at its first session in 2006, should invite the Chairperson, or any other member of the Board who could be in Geneva during the session of the Human Rights Council, to deliver a statement introducing the report of the Secretary-General on the nineteenth session of the Board on the activities and the needs of the Fund, and to appeal for new contributions.

#### The future direction of the Fund

- 36. The members highlighted the fundamental importance of the Fund and Board as an independent United Nations body that provides direct assistance to indigenous peoples and allows them to participate in United Nations meetings of vital importance for indigenous peoples. The members underlined the fact that at present all the Board members were indigenous representatives themselves.
- 37. In light of the importance of providing direct assistance to human rights projects by indigenous peoples, the Board recommended expanding the mandate of the Fund to include financial support to human rights projects, in addition to the provision of travel grants. The Board underlined the need to avoid duplication with other funds providing direct assistance to indigenous projects.
- 38. The Board recommended exploring the possibility of extending the mandate of the Fund to allow for ad hoc grants to support indigenous peoples' participation in meetings of United Nations bodies other than the Working Group on Indigenous Populations, the Working Group on a draft United Nations declaration and the Permanent Forum, in particular meetings of human rights treaty bodies.

#### Dates and agenda of the twentieth session

39. The Board of Trustees considered and approved their provisional agenda for the twentieth session. Taking into consideration that the secretariat should be able to analyse applications for the fifth session of the Permanent Forum received before the deadline of 1 October 2006, the Board considered that the annual session of five days should be scheduled from 26 February-2 March 2007. In that context, the Board urges donors to contribute before those dates.

#### Annex I

#### CRITERIA FOR THE SELECTION OF BENEFICIARIES

- 1. According to General Assembly resolution 40/131, the only beneficiaries of assistance from the Fund shall be representatives of indigenous populations' organizations and communities:
  - (a) Who are so considered by the Board of Trustees;
- (b) Who would not, in the opinion of the Board, be able to attend the sessions of the Working Groups or the Permanent Forum without the assistance provided by the Fund;
- (c) Who would be able to contribute to a deeper knowledge on the part of the Working Groups or the Permanent Forum of the problems affecting indigenous populations, and who would provide a broad geographical representation.

## 2. In addition, the Secretary-General approved the following criteria upon recommendation by the Board:

- (a) A travel grant approved by the secretariat is given on an individual basis. An organization or beneficiary cannot request that a beneficiary be replaced by another, except under exceptional circumstances, time permitting and upon approval by the secretariat;
- (b) The representatives and the organizations applying for a grant should be indigenous;
- (c) The Board does not consider requests from applicants which do not provide a letter of recommendation signed by an executive of their indigenous organization. The Board will not examine a letter signed by the applicant herself/himself;
  - (d) The Board considers a maximum of two applicants per organization;
- (e) Applicants are requested to submit application forms and recommendation letters in one of the working languages of the Board's secretariat (English, French or Spanish), applications in other languages will not be considered by the Board;
- (f) The Board selects both representatives who have never participated in a session of a working group or the Permanent Forum and representatives who have already participated and could develop specialized capacity and strengthen the core group of participants in a working group or the Permanent Forum;
- (g) The Board encourages indigenous organizations and communities to consider gender balance and, if possible, propose one woman and one man;
- (h) The Board encourages indigenous organizations and communities to consider nominating young persons;

- (i) The Board encourages the former beneficiaries of the OHCHR Indigenous Fellowship Programme to apply for grants to represent their indigenous organization or community at sessions of the Working Groups or Permanent Forum by sending duly completed application forms and meeting all the criteria for selection;
- (j) Applicants are requested to indicate their responsibility in their organization or community;
- (k) Applicants to attend the session of the Working Group on Indigenous Populations are requested to refer in their statements to the specific theme for the session;
- (l) The Board's recommendation in favour of an applicant to attend a session of the Permanent Forum does not exclude another recommendation to attend the Working Groups and vice versa:
- (m) The Board confirmed its practice according to which it will give priority to applicants living in their own community and country over applicants living abroad;
- (n) Failure of beneficiaries to fully participate in the session of the Working Groups or Permanent Forum has a negative impact on future recommendations for grants.

### 3. For the working group on the draft United Nations declaration on the rights of indigenous peoples only:

According to Commission on Human Rights resolution 1995/32, in order to be able to attend the working groups of the Commission on Human Rights, organizations must be in consultative status with the Economic and Social Council or be authorized by the Council Committee on Non-Governmental Organizations.

#### 4. For the Permanent Forum on Indigenous Issues only:

In accordance with Council resolution 2000/22, "... non-governmental organizations in consultative status with the Council may participate as observers; organizations of indigenous people may equally participate as observers in accordance with the procedures which have been applied in the Working Group on Indigenous Populations of the Sub-Commission on the Promotion and Protection of Human Rights".

According to the same resolution, the Permanent Forum has a mandate to discuss indigenous issues within the mandate of the Council relating to economic and social development, culture, the environment, education, health and human rights. Applicants must therefore refer in their statements to these issues.
