Introduction

1. The Preparatory Commission for the International Criminal Court, established in accordance with resolution F adopted by the United Nations Diplomatic Conference of Plenipotentiaries on the Establishment of an International Criminal Court on 17 July 1998, continued to carry out its mandate, in accordance with resolution F of the Conference and General Assembly resolutions 53/105 of 8 December 1998, 54/105 of 9 December 1999 and 55/155 of 12 December 2000, and to discuss ways to enhance the effectiveness and acceptance of the Court.

2. In accordance with General Assembly resolutions 54/105 and 55/155, the Preparatory Commission met at United Nations Headquarters for its sixth, seventh and eighth sessions from 27 November to 8 December 2000, 26 February to 9 March 2001 and 24 September to 5 October 2001.

3. The Bureau, as elected by the Preparatory Commission at its 1st and 2nd meetings, on 16 and 22 February 1999, continued to act as the Bureau of the Commission at its sixth, seventh and eighth sessions. At its 30th meeting, on 24 September 2001, the Commission was informed that Muhamed Sacirbey (Bosnia and Herzegovina) would no longer be available to act as Vice-Chairman of the Commission.

4. At its fifth session, from 12 to 30 June 2000, the Preparatory Commission adopted a report on the work of the Commission at its first to fifth sessions,¹ to which was annexed the finalized draft texts of the Rules of Procedure and Evidence (PCNICC/2000/1/Add.1) and of the Elements of Crimes (PCNICC/2000/1/Add.2).

5. At its eighth session, at the 33rd meeting, on 5 October 2001, the Preparatory Commission adopted a further report on its work, containing, in accordance with paragraph 5 of resolution F of the Conference, the draft texts of the Relationship Agreement between the Court and the United Nations, the Financial Regulations, the Agreement on the Privileges and Immunities of the Court, and the Rules of Procedure of the Assembly of States Parties.

6. These draft texts had been prepared in the context of working groups of the Preparatory Commission. To facilitate the tasks of the Commission, the Chairman, in consultation with the Bureau, had designated the following as coordinators of the working groups:

- Cristian Maquieira (Chile), Coordinator for the Working Group on a Relationship Agreement between the United Nations and the International Criminal Court;
- Georg Witschel (Germany), Coordinator for the Working Group on Financial Regulations and Rules;
- Phakiso Mochochoko (Lesotho), Coordinator for the Working Group on an Agreement on the Privileges and Immunities of the International Criminal Court;
- Saeid Mirzaee-Yengejeh (Islamic Republic of Iran), Coordinator for the Working Group on Rules of Procedure of the Assembly of States Parties.

7. Also, at its 33rd meeting, the Preparatory Commission agreed to include in its report the following, which was raised with respect to the report of the Working Group on a Relationship Agreement between the United Nations and the International Criminal Court:

- In the context of the discussions in the Working Group, the question was raised of how to deal with the dispute settlement provision of article 119, paragraph 2, of the Statute, and in this context, the question of the advisory opinions of the International Court of Justice was also raised. Delegations expressed the view that the Assembly of States Parties may consider this question.

8. At the same meeting, the Preparatory Commission also agreed to include in its report the following, which was raised with respect to the report of the Working Group on an Agreement on the Privileges and Immunities of the International Criminal Court.

- For registration of frequencies with the International Telecommunication Union (ITU), intergovernmental organizations require a special dispensation from ITU. The United Nations has been granted this dispensation. The activities of the Court will be hampered if it cannot operate radio and telecommunications equipment on its own frequencies. In order to overcome this major limiting factor for the Court, the attention of the Assembly of States Parties is drawn to this issue with a recommendation that the Assembly authorize the Court to seek a special dispensation with ITU so that the Court may be allocated its own frequencies. Alternatively, the Assembly of States parties may consider including a provision in the Relationship Agreement with the United Nations which would allow the Court to operate its radio and telecommunications equipment on frequencies registered with the United Nations.
- The issue was raised of the limitations to privileges and immunities granted to nationals and permanent residents in the territory of a State Party of their nationality or permanent residence. However, the Working Group did not have sufficient time to consider it. The attention of the Assembly of States Parties is therefore drawn to this important issue with a recommendation that the Assembly examine it when considering the draft Agreement on the Privileges and Immunities of the International Criminal Court.

9. In order to ensure linguistic consistency among the various language versions, the Preparatory Commission, also at the 33rd meeting, agreed to allow delegations to submit only linguistic corrections to the Secretariat no later than 1 January 2002 to be incorporated in the report.

10. The Preparatory Commission was addressed by Hans Holthuis, Registrar of the International Tribunal for the Former Yugoslavia, at its 28th and 32nd meetings, on 6 March, and 1 October 2001 respectively, and by Adama Dieng, Registrar of the International Criminal Tribunal for Rwanda, also at the 32nd meeting.

11. The Preparatory Commission noted with satisfaction that, during its sixth to eighth sessions, a total of 51 delegates had made use of the trust fund which, pursuant to paragraph 8 of General Assembly resolution 53/105, had been established to facilitate the participation of the least developed countries in the work of the Commission. The Preparatory Commission expressed its appreciation to the Governments of Denmark, and the United Kingdom of Great Britain and Northern

Ireland and to the European Commission for their contributions to the trust fund, as well as to the International Human Rights Law Institute of DePaul University (United States of America) for providing accommodation to delegates from the least developed countries who attended the seventh and eighth sessions.

12. The list of documents relating to the draft Relationship Agreement between the Court and the United Nations, the draft Financial Regulations, the draft Agreement on the Privileges and Immunities of the Court, and the draft Rules of Procedure of the Assembly of States Parties issued at the sixth to eighth sessions of the Commission, held in 2000 and 2001, is contained in annex III to the present report.

Annex I

Draft resolution of the Assembly of States Parties on the establishment of the Committee on Budget and Finance

The Assembly of States Parties,

Bearing in mind article 112, paragraphs 2 (b) and (d) and 4, of the Rome Statute,

Desiring to provide an appropriate mechanism for the budgetary and financial review and monitoring of the resources of the International Criminal Court, including those of the Assembly,

Decides to establish a Committee on Budget and Finance in accordance with the terms of reference set out in the annex to the present resolution.

Annex

1. The Assembly of States Parties establishes, in accordance with the present resolution, a Committee on Budget and Finance composed of 12 members.

2. The Assembly shall elect the members of the Committee on Budget and Finance, who should not be of the same nationality, on the basis of equitable geographical distribution. The members of the Committee shall be experts of recognized standing and experience in financial matters at the international level from States Parties. They shall carry out their duties for three calendar years and may be re-elected. Of the 12 members who are initially elected, 4 shall be elected for a period of one year, 4 for a period of two years and the remaining 4 for a period of three years.

3. The Committee on Budget and Finance shall be responsible for the technical examination of any document submitted to the Assembly that contains financial or budgetary implications or any other matter of a financial, budgetary or administrative nature, as may be entrusted to it by the Assembly of States Parties. In particular, it shall review the proposed programme budget of the Court, prepared by the Registrar, in consultation with the other organs referred to in article 34, subparagraphs (a) and (c), of the Rome Statute, and shall make the relevant recommendations to the Assembly concerning the proposed programme budget. It shall also consider reports of the Auditor concerning the financial operations of the Court and shall transmit them to the Assembly together with any comments which it may deem appropriate.

4. The Committee on Budget and Finance shall meet when required and at least once per year.

5. The Assembly of States Parties shall keep under review the number of members of the Committee on Budget and Finance.

Annex II

Draft resolution of the Assembly of States Parties on relevant criteria for voluntary contributions to the International Criminal Court

The Assembly of States Parties,

Bearing in mind the seventh preambular paragraph and article 116 of the Rome Statute, and taking note of regulation 7.2 of the Financial Regulations of the International Criminal Court,

1. *Requests* Governments, international organizations, individuals, corporations and other entities making voluntary contributions to declare that such contributions are not intended to affect the independence of the Court;

2. *Decides* that the Registrar shall assure himself/herself that any offered contributions:

(a) Will not affect the independence of the Court;

(b) Will fulfil any criteria the Assembly of States Parties may establish;

3. *Decides also* that the Registrar shall report to the Assembly of States Parties all offered voluntary contributions, regardless of whether they were accepted or refused.
