Implementation of resolution 1624 (2005)

Paragraph 1

- 1.1 What measures does Suriname have in place to prohibit by law and to prevent incitement to commit a terrorist act or acts? What further steps, if any, are under consideration?

Suriname does not yet have in place specific anti-terrorist laws. A study in this regard was conducted which resulted in a draft bill. A special commission was established by the Minister of Justice and Police, which is headed by the Attorney General of Suriname. This commission has the task to revise the Code of panel of Suriname.

- 1.2 What measures does Suriname take to deny safe haven to any persons with respect to whom there is credible and relevant information giving serious reasons for considering that they have been guilty of incitement to commit a terrorist act or acts?

Any persons with respect to whom there is credible and relevant information that is giving serious reasons for considering that they have been guilty of incitement to commit a terrorist act or acts can and will be denied visa to enter Suriname.

Paragraph 2

- 1.3 How does Suriname cooperate with other States in strengthening the security of its international borders with a view to preventing those guilty of incitement to commit a terrorist act or acts from entering their territory, including by combating fraudulent travel documents and, to the extent attainable, by enhancing terrorist screening and passenger security procedures?

In strengthening the security of its international borders with a view to preventing those guilty of incitement to commit a terrorist act or acts from entering their territory, including combating fraudulent travel documents and, to the extent attainable, by enhancing terrorist screening and passenger security procedures, Suriname firstly has proposed closed cooperation with its neighbouring countries. Suriname has issued special secured machine-readable passports for its citizen according to international standards. The necessary equipment was put in function at the international airport of Suriname. It is planned to equip all the ports of entry of Suriname with those machines.
