Eighteenth Meeting New York, 13 to 20 June 2008

Issues related to the workload of the Commission on the Limits of the Continental Shelf — tentative dates of submissions

Note by the Secretariat

1. The seventeenth Meeting of States Parties, in its decision on issues related to the workload of the Commission on the Limits of the Continental Shelf,¹ acknowledged the anticipated workload of the Commission owing to an increasing number of submissions, placing additional demands on its members and on the Division for Ocean Affairs and the Law of the Sea, Office of Legal Affairs, and requested coastal States Parties to submit to the Secretariat, for work planning purposes, by the end of November 2007, information on whether they intend to make a submission to the Commission and by which date, and requested the Secretariat to circulate a reminder to States Parties to that effect and subsequently report the information thus collected to States Parties.²

2. By note DOALOS/07-01406 dated 14 August 2007, the Secretariat circulated a reminder, in which it requested the Permanent Missions of coastal States Parties concerned to inform the Secretariat, as soon as possible, but not later than 30 November 2007, as to whether their Governments intended to make submissions to the Commission and by which date.³ The Secretariat also requested the Permanent Missions to inform the Secretariat, if applicable, whether the Governments concerned intended to make a submission individually or jointly with other neighbouring States.

3. Twenty-seven States responded to the above-mentioned communication from the Secretariat: Angola, Argentina, Barbados, Canada, Cape Verde, Denmark,

Ghana, Indonesia, Japan, Kenya, Madagascar, Malaysia, Maldives, Mexico, Myanmar, Palau, Philippines, Portugal, Republic of Korea, Seychelles, South Africa, Sri Lanka, Suriname, United Republic of Tanzania, United Kingdom of Great Britain and Northern Ireland, Uruguay and Viet Nam.

4. One State indicated in its response to the communication from the Secretariat that it experiences difficulties in the preparation of the submission and may not be in a position to fulfil the requirements of article 4 of Annex II to the Convention, as well as the decision contained in SPLOS/72, paragraph (a).

5. It is also noted that some coastal States made reference to their expected dates of submissions in their statements to the Meeting of States Parties to the United Nations Convention on the Law of the Sea or the General Assembly.

6. To date, the following States have made submissions, full or partial, to the Commission through the Secretary-General of the United Nations: Russian Federation (2001), Brazil (2004), Australia (2004), Ireland (2005), New Zealand (2006), France, Ireland, Spain and the United Kingdom of Great Britain and Northern Ireland (jointly, 2006), Norway (2006), France (2007) and Mexico (2007).

7. The annex to the present note contains a composite table indicating the tentative dates of submissions together with other relevant information.
