I. Introduction

- 1. Article 10 (1) and (2) of Protocol V on Explosive Remnants of War (ERW) stipulates as follows:
- "1. The High Contracting Parties undertake to consult and co-operate with each other on all issues related to the operation of this Protocol. For this purpose, a Conference of High Contracting Parties shall be held as agreed to by a majority, but no less than eighteen High Contracting Parties.
 - 2. The work of the conferences of High Contracting Parties shall include:
 - (a) Review of the status and operation of this Protocol;
 - (b) Consideration of matters pertaining to national implementation of this Protocol, including national reporting or updating on an annual basis;
 - (c) Preparation for review conferences."
- 2. By resolution A/RES/64/67, adopted on 2 December 2009, the General Assembly of the United Nations emphasized "the importance of the universalization of the Protocol on Explosive Remnants of War (Protocol V)," and welcomed "the commitment of States parties to the Protocol [...] to the effective and efficient implementation of the Protocol [...]." It also requested the Secretary-General of the United Nations "to render the necessary assistance and to provide such services, including summary records, as may be required for the Third Conference of the High Contracting Parties to Protocol V, [...] as well as for any continuation of work after the meetings."
- 3. The Third Conference of the High Contracting Parties to Protocol V decided, as stipulated in paragraph 53 of its Final Document CCW/P.V/CONF/2009/9, that the 2010 Meeting of Experts shall take place from 21 to 23 April 2010 in Geneva.
- 4. The Third Conference decided, as stipulated in paragraph 54 of its Final Document that the meeting of experts should especially focus on the following issues:
- (a) Clearance, removal or destruction of ERW, pursuant to Article 3 of the Protocol, under the overall responsibility of the Coordinator, Ms. Renata Alisauskiene of Lithuania;
- (b) Victim assistance, pursuant to Article 8 (2) of the Protocol, under the overall responsibility of the Coordinator, Ms. Stephanie Karner of Austria, to be assisted by Ms. Danijela Žunec Brandt of Croatia, as Friend of the Coordinator;
- (c) Cooperation and assistance and Requests for assistance pursuant to Article 7 of the Protocol, under the overall responsibility of the Coordinator, Mr. James C. O'Shea of Ireland.
- (d) The Web-based Information System for Protocol V (WISP.V), under the overall responsibility of the Coordinator, Mr. Gyula Somogyi of Hungary;
- (e) National reporting, pursuant to Article 10 (2) (b) of the Protocol and the Article 4 Generic Electronic Template, under the overall responsibility of the Coordinator, Mr. Henrik Markuš of Slovakia;
- (f) Generic preventive measures, pursuant to Article 9 and the Technical Annex of the Protocol, under the overall responsibility of the Coordinator, Mr. Eric Steinmyller of France.

- 5. The Third Conference also decided, as stipulated in paragraph 55 of its Final Document, that in implementing the Plan of Action to Promote Universality of the Convention and its annexed Protocols as adopted by the Third Review Conference, the Meeting of Experts should consider the issue of the universalization of Protocol V on Explosive Remnants of War under the overall responsibility of the President-designate of the Fourth Conference of the High Contracting Parties to Protocol V.
- 6. The First Conference decided, as stipulated in paragraph 42 of its Final Document, CCW/P.V/CONF/2007/1 that the work of the meetings of experts shall be considered by the Conferences of the High Contracting Parties to be held annually.
- 7. The Third Conference addressed, as stipulated in paragraph 56 of its Final Document, the issue of convening a two-day Fourth Conference of the High Contracting Parties to Protocol V in 2010 and decided that the issue of the date and duration of the Conference would be addressed at the Meeting of the High Contracting Parties to the Convention to be held on 12 and 13 November 2009.
- 8. The Third Conference decided, as stipulated in paragraph 57 of its Final Document, to nominate the representative of Australia as President-designate of the Fourth Conference, and the representatives of Pakistan and Slovakia as Vice-Presidents-designate.

II. Organization of the Fourth Conference

- 9. Pursuant to the decision of the 2009 Meeting of High Contracting Parties to the Convention, as stipulated in paragraph 42 of its Report, the Fourth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War was held at Geneva on 22 and 23 November 2010.
- 10. The following States Parties to Protocol V participated in the work of the Conference: Albania, Australia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Bulgaria, Canada, Chile, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Georgia, Germany, Guatemala, Holy See, Hungary, India, Ireland, Italy, Jamaica, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, New Zealand, Norway, Pakistan, Peru, Portugal, Qatar, Republic of Korea, Republic of Moldova, Romania, Russian Federation, Saudi Arabia, Senegal, Slovakia, Slovenia, Spain, Sweden, Switzerland, The former Yugoslav Republic of Macedonia, Tunisia, Ukraine, United Arab Emirates, and United States of America.
- 11. The following State Party to the Convention, which has notified its consent to be bound by Protocol V, but for which it is not yet in force, participated in the work of the Conference: China.
- 12. The following States Parties to the Convention participated in the work of the Conference as observers: Argentina, Bangladesh, Brazil, Cambodia, Cameroon, Cuba, Djibouti, Dominican Republic, Greece, Israel, Japan, Jordan, Lao People's Democratic Republic, Morocco, Philippines, Poland, Serbia, South Africa, Sri Lanka, Turkey, Uganda, United Kingdom of Great Britain and Northern Ireland, and Venezuela (Bolivarian Republic of).
- 13. The following States Signatories: Egypt and Viet Nam, and States not party to the Convention: Algeria, Angola, Armenia, Azerbaijan, Bahrain, Cote d'Ivoire, Ghana, Guinea, Haiti, Iran (Islamic Republic of), Iraq, Singapore, and Thailand also participated in the work of the Conference as observers.
- 14. The representatives of the United Nations Institute for Disarmament Research (UNIDIR), United Nations Mine Action Service (UNMAS), and United Nations Office for Disarmament Affairs (UNODA) participated in the work of the Conference as observers.

- 15. The representatives of the following organisations also took part in the work of the Conference as observers: European Union, Geneva International Centre for Humanitarian Demining (GICHD), International Committee of the Red Cross (ICRC), and International Federation of the Red Cross and Red Crescent Societies (IFRC).
- 16. The representatives of the following non-governmental organisations also took part in the work of the Conference as observers: Human Rights Watch, and Landmine and Cluster Munition Monitor.

III. Work of the Fourth Conference

- 17. The Fourth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War was opened on 22 November 2010 by Mr. Jarmo Sareva, Director, United Nations Office for Disarmament Affairs, Geneva Branch.
- 18. The Conference held four plenary meetings. At its first plenary meeting, on 22 November 2010, the Conference confirmed the nomination of Ambassador Peter Woolcott of Australia as President of the Fourth Conference of the High Contracting Parties to Protocol V. It also confirmed the nominations of Ambassador Zamir Akram of Pakistan and Ambassador Fedor Rosocha of Slovakia as Vice-Presidents of the Fourth Conference.
- 19. At the same plenary meeting, the Conference adopted its agenda, as contained in Annex I, and confirmed the Rules of Procedure, as contained in Annex II of the Final Document of the First Conference (CCW/P.V/CONF/2007/1).
- 20. At the same plenary meeting, the Conference adopted the arrangements for meeting the costs of the Conference, as recommended by the Third Conference of the High Contracting Parties to Protocol V (CCW/P.V/CONF/2009/9, Annex III).
- 21. At the same plenary meeting, the Conference appointed Mr. Bantan Nugroho, Head of the CCW Implementation Support Unit, as Secretary-General of the Conference.
- 22. At the same plenary meeting, the Conference decided to conduct its work in plenary meetings.
- 23. At the same plenary meeting, the Conference received a message from Mr. Ban Kimoon, Secretary-General of the United Nations, which was delivered by Mr. Jarmo Sareva, Director, United Nations Office for Disarmament Affairs, Geneva Branch.
- 24. The following States participated in the general exchange of views: Argentina, Australia, Belgium (on behalf of the European Union), Brazil, Chile, China, Germany, India, Pakistan, Poland, Republic of Korea, Russian Federation, Saudi Arabia, and United States of America. The representatives of UNMAS (on behalf of the United Nations Mine Action Team) and ICRC also took part in the general exchange of views. The statements made during the general exchange of views are reflected in the summary records of the Conference, which will be issued at a later date.
- 25. Pursuant to the decision by the First Conference to establish a database on Protocol V, in accordance with its Article 10 (2) (b), consisting of the national reports, annual or immediate updates of the national reports, and/or summary cover pages, if applicable, on matters pertaining to the implementation of Protocol V, as stipulated in paragraphs 24-28 of its Final Document (CCW/P.V/CONF/2007/1), the Conference had before it national annual reports from the following States: Australia, Austria, Belarus, Belgium, Bosnia and Herzegovina, Bulgaria, Canada, Croatia, Czech Republic, Denmark, Estonia, Finland, France, Germany, Guatemala, Holy See, Hungary, India, Ireland, Latvia, Liechtenstein, Lithuania, Netherlands, New Zealand, Pakistan, Portugal, Qatar, Republic of Korea,

Republic of Moldova, Romania, Russian Federation, Slovakia, Saudi Arabia, Spain, Sweden, Switzerland, Tunisia, Ukraine, and Uruguay.

- 26. During the course of the meeting the Conference considered documents CCW/P.V/CONF/2010/1 to CCW/P.V/CONF/2010/11, as listed in Annex IV. The official documents of the Conference are available in all official languages through the Official Document System of the United Nations at http://documents.un.org, and the official website of the CCW Protocol V as part of the website of the United Nations Office at Geneva at http://www.unog.ch/ccw.
- 27. During the course of the meeting the Conference heard presentations by Ukraine on the topic of Cooperation and assistance, and requests for assistance titled "Ukraine-UN Cooperation under Protocol V to the CCW".

IV. Conclusions and recommendations

A. Universalization

- 28. The Fourth Conference welcomed the States, which have consented to be bound by Protocol V since the Third Conference in 2009: Belgium, China, Cyprus, Gabon, Honduras, Italy, Qatar, and Saudi Arabia.
- 29. The Conference recommended that the Secretary-General of the United Nations, as Depositary of Protocol V, and the President of the Fourth Conference, on behalf of the High Contracting Parties, exercise their authority to achieve the goal of universality of Protocol V. To this effect, the Conference requested the President to consider reporting to the sixty-sixth session of the United Nations General Assembly on his endeavours. The Conference also called on the High Contracting Parties to Protocol V to promote wider adherence to Protocol V in their respective regions, pursuant to Actions 2 to 5 of the Plan of Action to Promote the Universality of the Convention and its annexed Protocols as adopted by the Third Review Conference.

B. Clearance, removal or destruction of Explosive Remnants of War

30. The Conference took note of the Report by the Coordinator on Clearance, Removal or Destruction of ERW, as contained in CCW/P.V/CONF/2010/2, dated 27 September 2010.

31. The Conference decided:

- (a) To continue the consideration of clearance, removal or destruction of ERW in the context of the Meetings of Experts and the Conferences of the High Contracting Parties to Protocol V;
- (b) Taking into account the close linkage between effective clearance and the obligations under Article 4 on recording and retaining of information, to merge these two topics under the overall responsibility of the Coordinator on Clearance;
- (c) To consider possible improvements to the generic electronic template aimed at making recording of information on used explosive ordinances more accurate;
- (d) To keep under further consideration the topic on priority-setting for clearance and on review of clearance activities plan implementation;
- (e) To keep under review the potential environmental consequences of ERW clearance.

C. Victim assistance

- 32. The Conference took note of the Report by the Coordinator on Victim Assistance, as contained in CCW/P.V/CONF/2010/7, dated 14 October 2010.
- 33. Bearing in mind the rich discussions and the work undertaken under Protocol V this year, as well as under previous Coordinators, the Conference decided:
- (a) To continue the consideration of victim assistance in the context of the Meetings of Experts and the Conferences of the High Contracting Parties to Protocol V and to provide adequate time to addressing this important issue.
- (b) To request that the Coordinator report annually to the Conference on High Contracting Parties on the state of implementation of article 8 paragraph 2 and the Plan of Action.
- (c) To request that the Meeting of Experts further discuss the issue of reporting under Article 8 paragraph 2, keeping in mind also the Plan of Action, and request the Coordinator to make suggestions to the Fifth Conference of the High Contracting Parties based on this discussion. The Meeting of Experts should bear in mind the benefits of streamlining reporting and the need to minimize undue reporting burdens.
- (d) To establish a web-category on victim assistance under the existing Protocol V website, providing statements, presentations and submitted questionnaires, in accordance with High Contracting Parties.
- (e) To request that the Meeting of Experts consider the benefits of the Plan of Action for the wider CCW community.

D. Cooperation and assistance and requests for assistance

- 34. The Conference took note of the Report by the Coordinator on Cooperation and Assistance and Requests for Assistance, as contained in CCW/P.V/CONF/2010/3, dated 24 September 2010.
- 35. The Conference decided:
- (a) To continue the consideration of cooperation and assistance, and of requests for assistance, as a priority issue in the context of the Meetings of Experts and the Conferences of the High Contracting Parties to Protocol V;
- (b) To encourage High Contracting Parties to include detailed information in reporting forms E and F, as relevant, on cooperation and assistance provided, as well as received;
- (c) To encourage High Contracting Parties, relevant international organizations and institutions which might be in a position to do so, to consider providing assistance in response to requests submitted under Article 7 of the Protocol, or in response to needs identified in other ways, including during the Meetings of Experts;
- (d) To encourage States which have submitted requests for assistance to provide regular updates on the status of those requests, using the amended Form B (Appraisal of needs) of the Formats for Requests for Assistance, as approved by the Third Conference of the High Contracting Parties.

E. Recording, retaining and transmission of information

36. The Conference took note of the Report by the Coordinator on the Article 4 Generic Electronic Template, as contained in CCW/P.V/CONF/2010/5, dated 27 September 2010.

37. The Conference decided:

- (a) To keep under further review the implementation of Article 4 by the High Contracting Parties, including the adequacy and the usefulness of the Article 4 Generic electronic template as a tool for effective recording and retaining of information pertinent to the implementation of Article 4 of the Protocol;
- (b) That the 2011 Meeting of Experts continue the consideration of the implementation of Article 4, which would include, *inter alia*:
 - (i) national procedures and experience in the implementation of the High Contracting Parties' obligations under Article 4. Discussion paper no. 3 titled "Recording, Retaining and Transfer of Information" may continue to serve as a basis for the discussion on the actions taken in this respect; and
 - (ii) action taken in making use of the Article 4 generic electronic template at the national level by High Contracting Parties that have not established their own national system for recording and retaining information pursuant to Article 4 of the Protocol. Discussion paper no. 2 of the 2009 Meeting of Experts titled "Elements for Consideration on article 4 generic electronic template" may continue to serve as a basis for the discussion on actions taken in this respect.
- (c) To merge the deliberations on the implementation of article 4 of the Protocol with those on clearance, removal or destruction of ERW, under the overall responsibility of the Coordinator on Clearance;
- (d) To encourage States to consider using the CCW Secretariat (Implementation Support Unit) as the Third Party in the event a Third Party is needed for collecting and transmitting information pursuant to article 4 (2).

F. National reporting

38. The Conference took note of the Report by the Coordinator on national reporting, pursuant to Article 10 (2) (b) of the Protocol, as contained in CCW/P.V/CONF/2010/4, dated 27 September 2010.

39. The Conference decided:

- (a) To adopt the "Guide to National Reporting under CCW Protocol V", as contained in CCW/P.V/CONF/2009/4/Add.1, dated 26 October 2009, and CCW/P.V/CONF/2009/4/Add.1/Corr.1, dated 4 November 2009, as a document representing a check list of questions to be used as a tool at the discretion of the High Contracting Parties to facilitate the filling-out of the forms of the national reporting under Protocol V by providing the information referred to in paragraphs 24 to 28 of the Final Document of the First Conference of the High Contracting Parties.
- (b) To reiterate the recommendation to the High Contracting Parties to Protocol V (and observer States submitting their national reports on a voluntary basis) to use the guide in order to provide the above-mentioned information in the most comprehensive way possible.
- (c) To continue to evaluate the reporting mechanism, including the reporting formats referred to in paragraphs 24 to 28 of the Final Document of the First Conference of the High Contracting Parties and "The Guide to National Reporting under CCW

Protocol V"; and to request the 2011 Meeting of Experts to make recommendations on the above for consideration by the Fifth Conference of the High Contracting Parties to Protocol V.

(d) To encourage the High Contracting Parties to comply with the requirement of submitting initial National reports and their annual updates and to invite the observer States to provide national reports on a voluntary basis.

G. Generic preventive measures

40. The Conference took note of the Report by the Coordinator on Generic preventive measures, pursuant to Article 9 and the Technical Annex of the Protocol, as contained in CCW/P.V/CONF/2010/6 and CCW/P.V/CONF/2010/6/Add.1, dated 11 November 2010.

41. The Conference decided:

- (a) To adopt the Guide for the implementation of Part 3 of the Technical Annex, the text of which is reproduced in document CCW/P.V/CONF/2010/6/Add.1, and to recommend that it be implemented in the national systems of the High Contracting Parties to Protocol V as a best practice;
- (b) To continue the practice of addressing one specific technical issue directly related to the implementation of Article 9 and Part 3 of the Technical Annex of Protocol V;
- (c) To invite all States Parties to share during the 2011 Meeting of Experts their national technical approaches and experience in implementing Article 9 and Part 3 of the Technical Annex of Protocol V.

H. The Web-based Information System for Protocol V (WISP.V)

42. The Conference took note of the current version of the WISP.V and decided to commence the testing phase assisted by interested States. The Coordinator in cooperation with the CCW ISU and UNOG will fine tune the WISP.V based on the results of the testing phase. Subsequently, upon its completion, the WISP.V will be ready for use by all High Contracting Parties to Protocol V as an additional tool to the existing framework for cooperation and assistance.

Follow-up

- 43. The Conference decided that the 2011 Meeting of Experts shall take place from 6 to 8 April 2011 in Geneva.
- 44. The Conference decided that this meeting should especially focus on the following issues:
- (a) Clearance, removal or destruction of ERW, pursuant to Article 3 of the Protocol, and the Article 4 Generic Electronic Template, under the overall responsibility of the Coordinator, Ms. Petra Drexler of Germany;
- (b) Victim assistance, pursuant to Article 8 (2) of the Protocol, under the overall responsibility of the Coordinator, Ms. Stephanie Karner of Austria, to be assisted by Ms. Danijela Žunec Brandt of Croatia, as Friend of the Coordinator;
- (c) Cooperation and assistance and Requests for assistance pursuant to Article 7 of the Protocol, under the overall responsibility of the Coordinator, Mr. James C. O'Shea of Ireland;

- (d) The Web-based Information System for Protocol V (WISP.V), under the overall responsibility of the Coordinator, Mr. Gyula Somogyi of Hungary;
- (e) National reporting, pursuant to Article 10 (2) (b) of the Protocol under the overall responsibility of the Coordinator, Mr. Amandeep S. Gill of India;
- (f) Generic preventive measures, pursuant to Article 9 and the Technical Annex of the Protocol, under the overall responsibility of the Coordinator, Navy Captain Eric Steinmyller of France.
- 45. The Conference also decided that, in implementing the Plan of Action to Promote Universality of the Convention and its annexed Protocols as adopted by the Third Review Conference of the High Contracting Parties to the Convention, the Meeting of Experts should consider the issue of the universalization of Protocol V on Explosive Remnants of War under the overall responsibility of the President-designate of the Fifth Conference of the High Contracting Parties to Protocol V.
- 46. The Conference decided that the two-day Fifth Conference of the High Contracting Parties to Protocol V will be convened in 2011 on dates to be decided at the Meeting of the High Contracting Parties to the Convention to be held on 25 and 26 November 2010.
- 47. The Conference decided to nominate Ambassador Mikhail Khvostov of Belarus as President-designate of the Fifth Conference, and a representative of Ireland and a representative of the Non-Aligned Movement as Vice-Presidents-designate.
- 48. The Conference considered a provisional agenda of the Fifth Conference, as contained in Annex II, and the estimated costs of the Fifth Conference, as contained in CCW/P.V/CONF/2010/10, and recommended them for adoption at the time of the Fifth Conference in 2011. The Conference also adopted the estimated costs of the 2011 Meeting of Experts, as contained in CCW/P.V/CONF/2010/9.
- 49. At its fourth plenary meeting, the Fourth Conference of the High Contracting Parties to Protocol V on Explosive Remnants of War adopted its final document as contained in CCW/P.V/CONF/2010/CRP.1, as orally amended, which is being issued as document CCW/P.V/CONF/2010/11.
