ANNEX

Declaration issued by the Supreme Soviet of the Byelorussian  
Soviet Socialist Republic

On behalf of the Byelorussian people, the Supreme Soviet of the Byelorussian SSR expresses deep gratitude to the sponsors and all *the* States Members of the United Nations for the adoption, at the forty-fifth session of the General Assembly, of the resolution entitled "International cooperation to address and mitigate the consequences of the accident at the Chernobyl nuclear power plant".

The Byelorussian SSR was most severely affected by the disaster at Chernobyl, which constituted a national tragedy for our Republic. About 22.4 per cent of the territory of the Republic was contaminated by radiation, and 20 per cent of the population was in the contaminated area. *The* after-effects pose a real threat to the lives and health of hundreds of thousands of people, particularly children, and to the future of the Byelorussian identity.

As we see it, the moral and material support has profound significance: as a reflection of the new political thinking, as a reaffirmation of coordination among States on *the* basis of universal human values and humanitarian principles, and as a sign of the strengthening of the spirit of partnership and the development of new forms of international cooperation.

We are grateful to the Secretary-General of the United Nations, Mr. Javier Pérez de Cuéllar, *for* his personal attention to this matter and for his major contribution in intensifying international efforts and coordinating international initiatives to solve the many complex problems resulting from the disaster.

In expressing its sincere gratitude *for* the across-the-board assistance to the Byelorussian people, and the support by States, using the machinery of the United Nations, for our own national efforts to overcome this major calamity, the Supreme Soviet of the Byelorussian SSR is confident that in this new phase of international cooperation to address and mitigate the consequences of the accident at Chernobyl, the highly humanitarian principles of the aforementioned resolution will find practical expression through the participation of the world community.

We hope that the substantive focus of international solidarity will be on the most severely affected regions and their inhabitants, especially children, women, the elderly, the disabled and those who were involved in localizing the disaster and limiting its effects. The parliamentarians of the Byelorussian SSR appeal to the parliaments and Governments of States, intergovernmental and non-governmental organizations, the business, financial, scientific and religious communities, citizens' groups, funds, representatives of the mass media, fellow citizens, and all people of good will to respond without delay to the call made by the General Assembly at its forty-fifth session to provide appropriate moral support and practical assistance in emergency situations.

For its part, the Supreme Soviet of the Byelorussian SSR, fully accepting its responsibility for the future of the Byelorussian nation, declares that it is determined to continue taking comprehensive national measures, and that it is prepared to continue participating in international programmes of cooperation and assistance to the population of the areas affected by the radiological and environmental disaster.

The Supreme Soviet of the Byelorussian SSR calls on the United Nations to proclaim 26 April the international day for the prevention of nuclear and other industrial or technological disasters. It hopes that the States Members of the United Nations will support the *convening* of a pledging conference for a Chernobyl fund to promote the appropriate activities of the United Nations system, to be held at United Nations Headquarters in New York on the occasion of the fifth anniversary of the accident at the Chernobyl nuclear power plant.
