Note by the President of the General Assembly

The President of the forty-eighth session of the General Assembly has the honour to submit to the members of the Assembly his note on the open-ended and broad-based consultations on an agenda for development (see annex, sect. I), as well as his summary on the World Hearings on Development (see annex, sect. II), prepared pursuant to paragraph 3 of Assembly resolution 48/166 of 21 December 1993, in which the Assembly, <u>inter alia</u>, invited the President of the General Assembly to promote, as early as possible in 1994, in an open-ended format, broad-based discussions and exchange of views on an agenda for development, on the basis of the report of the Secretary-General requested in its resolution 47/181.
