I. Introduction

1. The previous recommendations made by the Fifth Committee to the General Assembly under agenda item 111 appear in the report of the Committee contained in document A/57/648.
2. The Fifth Committee resumed its consideration of the item at its 45th meeting, on 28 March 2003. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary record (A/C.5/57/SR.45).

II. Consideration of draft decision A/C.5/57/L.62

3. At the 45th meeting, on 28 March, the Chairman of the Committee introduced a draft decision entitled "Action taken on certain items" (A/C.5/57/L.62) and orally revised it by:
 - (a) Adding agenda item 118 (Human resources management) and the following documents: notes by the Secretary-General transmitting the report of the Office of Internal Oversight Services on possible discrimination due to nationality, race, sex, religion and language in recruitment, promotion and placement (A/56/956) and the comments of the Joint Inspection Unit thereon (A/56/956/Add.1);
 - (b) Adding agenda item 122 (Report of the Secretary-General on the activities of the Office of Internal Oversight Services) and the following document: note by the Secretary-General transmitting the report of the Office of Internal Oversight Services on the management review of the Office of the United Nations High Commissioner for Human Rights (A/57/488).

4. At the same meeting, the Committee adopted draft decision A/C.5/57/L.62, as orally revised, without a vote (see para. 5).
