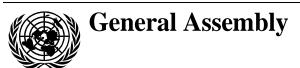

Letter dated 4 April 2003 from the Permanent Representatives of Peru and the Russian Federation to the United Nations addressed to the Secretary-General

Moscow Declaration of the Ministers for Foreign Affairs of the Russian Federation and of the Rio Group Troika

On 1 April 2003 a meeting was held in Moscow between Mr. I. S. Ivanov, Minister for Foreign Affairs of the Russian Federation, and the Ministers for Foreign Affairs of the Rio Group Troika, namely Mr. Allan Wagner, of the Republic of Peru, Mr. Roberto Tovar, of the Republic of Costa Rica and Mr. Celso Amorim, of the Republic of Brazil.

I

After analysing the development since 1997 of the high-level political dialogue between the Russian Federation and the Rio Group, the Ministers for Foreign Affairs reaffirmed that its constructive character, and mutual trust, allow for a frank and productive exchange of views on key problems of the international agenda, thereby contributing to an improvement of their cooperation in the international arena.

The Parties agreed to intensify political contacts, and to consider the possibility of holding a summit meeting at a future date.

II

After discussing the basic problems facing the international community, the Ministers for Foreign Affairs reaffirmed the desire of the Russian Federation and of the Rio Group to reinforce their cooperation in the international arena with a view to the strengthening of international peace and security, respect for international law, poverty reduction, the promotion of democracy and human rights, as well as economic development and protection of the environment.

The Ministers for Foreign Affairs stressed the importance of intensifying cooperation in order to carry out joint action which would help make the globalization process more orderly, balanced and secure, and direct it towards the search for mutually advantageous decisions.

The Ministers for Foreign Affairs reaffirmed the central role of the United Nations and the Security Council in international relations as the main universal instrument for the maintenance of international peace and security and the promotion of economic and social development. They also stressed the need for strict observance of the Charter of the United Nations and of the universally recognized principles and norms of international law. The Parties called for renewed efforts by the international community to strengthen and consolidate the collective security system of the United Nations.

Analysing the situation in Iraq, the Ministers stressed the common commitment of their countries to the principles of multilateral diplomacy and the strengthening of the legal foundations of international life, including the principles

of respect for the sovereignty and territorial integrity of States. They expressed their desire for an early end to the hostilities, with minimal loss of life, and their support for political and diplomatic efforts to restore peace, and, in particular, for the adoption of urgent measures under the auspices of the United Nations to avoid a humanitarian disaster in Iraq.

The Parties emphasized the importance of the disarmament process and of non-proliferation of nuclear weapons and other weapons of mass destruction, and noted the need to abide by and strengthen the agreements reached in this sphere and to promote their universal acceptance.

III

The Ministers for Foreign Affairs particularly stressed the importance of economic and social development and, in this respect, underscored the need to promote a strengthened and non-discriminatory multilateral trading system. They also reaffirmed their interest in the early conclusion of the Doha round negotiations and their concern that the outcome should include special and differentiated treatment for the benefit of developing countries, granting preferential access to products from those countries to the markets of the developed countries.

The Parties noted the importance of establishing an effective mechanism for monitoring the global financial and monetary structure and for drawing up a system of measures for rapid response to crises and a long-term strategy for the prevention of global upheavals. They stressed the need for combined efforts by the international community to implement the decisions of the World Summit on Sustainable Development (Johannesburg, August/September 2002) and the International Conference on Financing for Development (Monterrey, March 2002).

The Ministers for Foreign Affairs of the Rio Group Troika reported on the Rio Group's initiative to establish innovative financial mechanisms to meet social needs, strengthen democratic governance and confront the growth of extreme poverty. The Minister for Foreign Affairs of the Russian Federation expressed his interest and willingness to participate in broad dialogue with all interested parties on the modalities for carrying out that initiative.

IV

The Ministers for Foreign Affairs agreed that a central objective of the international community should be to minimize the threat of conflicts at all levels. The Ministers expressed concern about the intensification of threats to national, regional and international security, in particular international terrorism, illicit drug trafficking and transnational organized crime, and also the persistence and worsening of structural challenges such as poverty and extreme poverty, which endanger stability and democratic governance.

Accordingly, attention was drawn to the need to continue an active dialogue and exchange of information on the conceptual issues of regional and international security, which would contribute to taking greater account of the specific concerns of countries and subregions, and also to coordination of the Parties' approaches within the framework of multilateral cooperation in dealing with new challenges and threats. In this context, the Ministers for Foreign Affairs of the Rio Group Troika

reported to the Minister for Foreign Affairs of the Russian Federation on preparations for the Special Conference on Security (Mexico, 6 to 8 May 2003).

The Parties advocated that the United Nations should be further adapted to respond to the challenges and threats of the twenty-first century and that the overall efficiency and complementarity of the United Nations system should be enhanced in combating these challenges and threats.

V

The Ministers for Foreign Affairs exchanged information about the efforts being made by their countries in combating terrorism and agreed on the need to intensify cooperation to prevent and combat this scourge, which is one of the most serious threats to international peace and security, to human rights and fundamental freedoms, and to the democratic foundations of society, and also has grave consequences for the economic and social development of States. The Ministers for Foreign Affairs are convinced that no arguments can serve to justify those who commit, finance or support terrorist acts.

In this context, they agreed that cooperation between the Russian Federation and the Rio Group will be directed towards achieving common objectives in this area, including the development and strengthening of the legal and treaty framework for combating international terrorism and the financing of terrorism, and the intensification of cooperation against terrorism in the framework of multilateral mechanisms at various levels.

The Ministers for Foreign Affairs expressed support for maintaining a permanent dialogue on cooperation between the Russian Federation and the Rio Group for the prevention and suppression of international terrorism in all its forms and manifestations.

VI

In addition to regular annual contacts during the sessions of the United Nations General Assembly, which they agreed to continue, the Ministers for Foreign Affairs recognized the value of holding meetings between the Russian Federation and the Rio Group Troika, alternately in the Russian Federation and in the country heading the pro tempore secretariat of the Rio Group.

In this context, the Minister for Foreign Affairs of Brazil, in his capacity as First Secretary pro tempore of the Rio Group, extended a cordial invitation to the Minister for Foreign Affairs of the Russian Federation to meet the Ministers for Foreign Affairs of the Rio Group Troika in Brazil in 2004. The invitation was accepted with pleasure.
