

Addendum

- 1. By a communication received on 25 June 2003, the Permanent Mission of the Republic of Moldova to the United Nations informed the Secretariat that Ms. Tatiana Răducanu had decided to withdraw her candidature.
- 2. In consequence, the following candidate should be deleted from the list of candidates for ad litem judges of the International Tribunal for Rwanda appearing in paragraph 7 of document A/57/801: Ms. Tatiana Răducanu (Republic of Moldova).
- 3. This deletion is in addition to those listed in paragraph 3 of document A/57/801/Add.1, in paragraph 3 of document A/57/801/Add.2, in paragraph 2 of document A/57/801/Add.3 and in paragraph 2 of document A/57/801/Add.4.
