Letter dated 2 July 2003 from the President of the General Assembly addressed to the Secretary-General

I have the honour to refer to your letter of 27 June 2003 concerning the candidature of Ms. Khalida Rachid to replace Mr. Mansoor Ahmed, who resigned as permanent judge of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States between 1 January and 31 December 1994, effective 20 May 2003 (annex II).

In accordance with article 12 bis, paragraph 2, of the statute of the International Tribunal, I have reviewed the qualifications of Ms. Rachid and am pleased to inform you that I concur with the proposed appointment.

Letter dated 27 June 2003 from the Secretary-General addressed to the President of the General Assembly

I have the honour to refer to article 12 bis, paragraph 2, of the Statute of the International Criminal Tribunal for the Prosecution of Persons Responsible for Genocide and Other Serious Violations of International Humanitarian Law Committed in the Territory of Rwanda and Rwandan Citizens Responsible for Genocide and Other Such Violations Committed in the Territory of Neighbouring States, between 1 January 1994 and 31 December 1994, which reads as follows:

"In the event of a vacancy in the Chambers amongst the permanent judges elected or appointed in accordance with this article, after consultation with the Presidents of the Security Council and of the General Assembly, the Secretary-General shall appoint a person meeting the qualifications of article 12 above, for the remainder of the term of office concerned."

In this connection, I regret to inform you that Mr. Mansoor Ahmed, a national of Pakistan, resigned as a permanent judge of the International Tribunal for Rwanda, effective 20 May 2003.

The Government of Pakistan has presented the candidacy of Ms. Khalida Rachid, a national of Pakistan, to replace Mr. Ahmed. Please find attached her curriculum vitae (see appendix).

It is my view that Ms. Rachid meets the qualifications which are prescribed in Article 12 of the Statute of the International Tribunal for Rwanda. I also consider that the appointment of Ms. Rachid would be well calculated to ensure adequate representation on the Tribunal of the principal legal systems of the world, as contemplated in paragraph 1 (c) of article 12 bis of the Tribunal's Statute.

I should therefore like to proceed towards consultation with you on the appointment of Ms. Rachid, in accordance with article 12 bis, paragraph 2, of the Statute of the International Tribunal for Rwanda. I look forward to receiving your views on the matter.
