#### **Report of the Fifth Committee**

#### **I. Introduction**

1. The previous recommendations made by the Fifth Committee to the General Assembly under agenda item 119 appear in the reports of the Committee contained in documents A/58/571 and A/58/571/Add.1.

2. The Fifth Committee resumed its consideration of the item at its 31st to 33rd and 39th meetings, on 10, 15 and 16 March and 2 April 2004. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/58/SR.31-33 and 39).

3. For its further consideration of the item, the Committee had before it the following documents:
