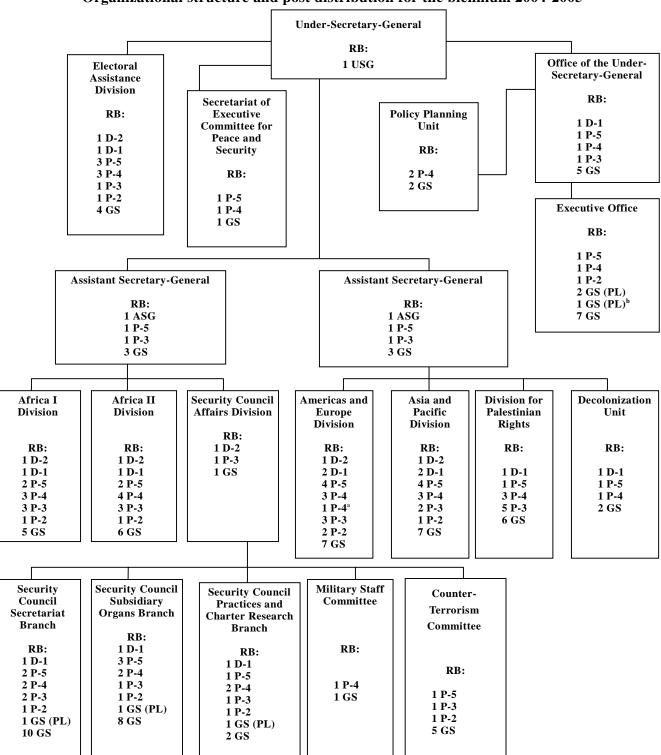

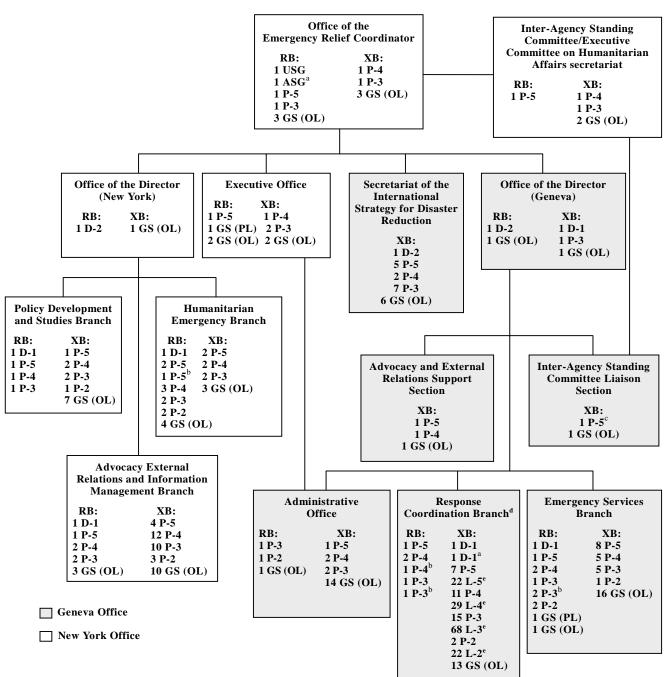

Worldwide audience research to obtain feedback on information products and services has long been a priority for the Department. While the Department has always made the effort to use the most up-to-date tools in communication research, it has never had the capacity to study the effectiveness of more than a few programmes at any given moment. However, although resources for evaluation activities are still limited, the Department is undertaking to make systematic evaluation integral to the work of all units. The first step has been to provide various training sessions in evaluation techniques to all programme managers. Furthermore, the Department is instituting an annual programme impact review to accelerate its movement towards a new "evaluation culture" of increased performance management, in line with the results-basedbudgeting framework proposed by the Secretary-General.

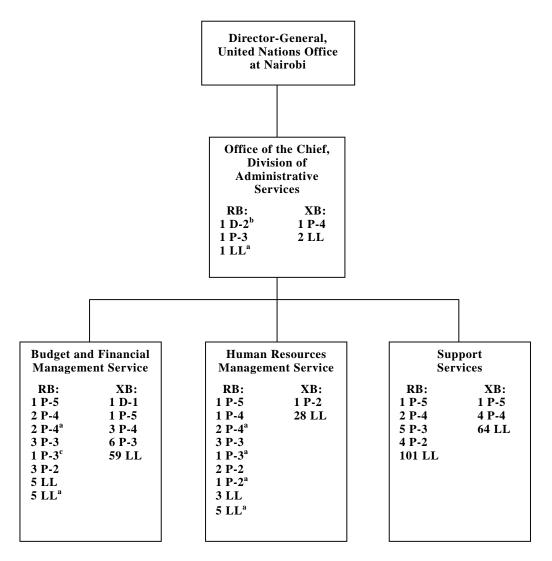
