Fifty-ninth year****Letter dated 26 July 2004 from the representatives of Colombia,  
Myanmar, Nepal, the Philippines, Sri Lanka, the Sudan and  
Uganda to the United Nations addressed to the Secretary-General**

Our Governments are heartened by the strides made by the United Nations on the issue of protecting children, especially in conflict situations. Indeed, as parties to the Convention on the Rights of the Child, we are fully committed to the protection of children in all aspects pertaining to their well-being and the full enjoyment of their rights.

We have considered carefully your report on children and armed conflict (A/58/546-S/2003/1053) of 10 November 2003 and are greatly interested in the perspectives presented. However, we would like to express our concern regarding the two corrigenda to the report (A/58/546/Corr.1-S/2003/1053/Corr.1 and A/58/546/Corr.2-S/2003/1053/Corr.2), which were issued on 20 February and 19 April 2004, respectively. Furthermore, we are concerned by the Secretariat's use of the Geneva Conventions and the Additional Protocols in indicating a definition of "armed conflict", when these international legal instruments do not provide for an internationally agreed definition of armed conflict. We note that the above-mentioned corrigenda show a double standard in relation to the United Nations work in protecting children and thus undermine the credibility, accuracy and sincerity of the report.

We appreciate the briefings given by Mr. Olara Otunnu, your Special Representative for Children and Armed Conflict, and we welcome his willingness to engage in a consultation process with Member States, especially those concerned, in the preparation of the next report. We attach particular importance to the consultation process recommended in paragraph 36 (d) of General Assembly resolution 51/77, which aims to coordinate the efforts of all stakeholders, including Governments, in ensuring respect for and protection of children's rights.

We look forward to the forthcoming report, which we believe should be impartial, accurate, credible, objective and fair, based on reliable and verified information. It is our earnest hope that the next report will not apply double standards and arbitrary considerations in dealing with this issue.

To that end, we hope that the process of preparing the next report will involve, inter alia, Member States, especially those concerned, as well as United Nations country teams. We would appreciate it if the report reflects the views of the Member States concerned. The recommendations of the report should aim to enhance States' capacity to protect children and foster international cooperation in order to improve their conditions.

We are fully confident that, by upholding the principles and spirit of the Charter of the United Nations, rising above political and power considerations, we can all make a significant difference in the lives of the affected children around the world.

We would be grateful if you could have the present letter circulated as a document of the General Assembly and the Security Council.
