#### NOTE

The resolutions and decisions of the General Assembly are identified as follows:

#### Regular sessions

Until the thirtieth regular session, the resolutions of the General Assembly were identified by an arabic numeral followed by a roman numeral in parentheses indicating the session (for example: resolution 3363 (XXX)). When several resolutions were adopted under the same number, each of them was identified by a capital letter placed between the two numerals (for example: resolution 3367 A (XXX), resolutions 3411 A and B (XXX), resolutions 3419 A to D (XXX)). The decisions were not numbered.

Since the thirty-first session, as part of the new system adopted for symbols of General Assembly documents, resolutions and decisions have been identified by an arabic numeral, indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution 31/1, decision 31/301). When several resolutions or decisions were adopted under the same number, each of them has been identified by a capital letter placed after the two numerals (for example: resolution 31/16 A, resolutions 31/6 A and B, decisions 31/406 A to E).

#### Special sessions

Until the seventh special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letter "S" and a roman numeral indicating the session (for example: resolution 3362 (S-VII)). The decisions were not numbered.

Since the eighth special session, resolutions and decisions have been identified by the letter "S" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution S-8/1, decision S-8/11).

#### **Emergency special sessions**

Until the fifth emergency special session, the resolutions of the General Assembly were identified by an arabic numeral followed, in parentheses, by the letters "ES" and a roman numeral indicating the session (for example: resolution 2252 (ES-V)). The decisions were not numbered.

Since the sixth emergency special session, resolutions and decisions have been identified by the letters "ES" and an arabic numeral indicating the session, followed by an oblique stroke and another arabic numeral (for example: resolution ES-6/1, decision ES-6/11).

In each of the series described above, the numbering follows the order of adoption.

#### A. Elections and appointments

#### 59/401. Appointment of the members of the Credentials Committee

At its 1st plenary meeting, on 14 September 2004, the General Assembly, in accordance with rule 28 of its rules of procedure, appointed a Credentials Committee for its fifty-ninth session consisting of the following Member States: BENIN, BHUTAN, CHINA, GHANA, LIECHTENSTEIN, RUSSIAN FEDERATION, TRINIDAD AND TOBAGO, UNITED STATES OF AMERICA and URUGUAY.

#### 59/402. Election of five non-permanent members of the Security Council

At its 32nd plenary meeting, on 15 October 2004, the General Assembly, in accordance with Article 23 of the Charter of the United Nations and rule 142 of the rules of procedure of the Assembly, elected Argentina, Denmark, Greece, Japan, and the United Republic of Tanzania as non-permanent members of the Security Council for a two-year term of office beginning on 1 January 2005 to fill vacancies occurring on the expiration of the terms of office of Angola, Chile, Germany, Pakistan and Spain.

- (a) Noted that, should it adopt the draft resolution entitled "Programme planning", <sup>118</sup> the programme of work under section 29, Management and central support services, of the programme budget for the biennium 2004–2005, would be modified as indicated in paragraph 3 of the statement by the Secretary-General, and an additional amount of 500,000 United States dollars at initial 2004–2005 rates would be required under section 29B, Office of Programme Planning, Budget and Accounts, of the programme budget for the biennium 2004–2005, subject to the procedures established by the General Assembly in its resolutions 41/213 of 19 December 1986 and 42/211 of 21 December 1987 for the use and operation of the contingency fund;
- (b) Noted the possible substantial financial costs related to the eventual implementation of a cost accounting system;
- (c) Requested the Secretary-General to provide a full presentation of the financial implications of identified options for the possible implementation of such a system to the General Assembly at its sixtieth session for consideration.
