## Overview

- 11.1 The programme was established following the final review and appraisal of the United Nations New Agenda for the Development of Africa in the 1990s. As a result of that review, the General Assembly adopted resolution 57/2 of 16 September 2002 and resolution 57/7 of 4 November 2002, which brought the United Nations New Agenda for the Development of Africa in the 1990s to a close and endorsed the recommendation of the Secretary-General that the New Partnership for Africa's Development should be the framework within which the international community, including the United Nations system, should concentrate its efforts for Africa's development. The General Assembly underscored the need for a structure in the United Nations Secretariat in New York, at the appropriate level, which would review and report on support provided by the United Nations system and the international community for the New Partnership and on the coordinated implementation of outcomes of summit meetings and conferences as they relate to Africa, as well as to coordinate global advocacy in support of the New Partnership.
- 11.2 In resolution 57/7, the General Assembly also welcomed the actions already taken at the regional level to organize the activities of the United Nations system around thematic clusters covering the priority areas of the New Partnership, and, in this regard, urged the strengthening of this process as a means of enhancing the coordinated response of the United Nations system in support of the New Partnership. Finally, it called upon the United Nations system to enhance its advocacy role and public information activities in support of Africa's development. Subsequent to resolution 57/7, in its resolution 57/300 of 20 December 2002, the General Assembly endorsed the creation of the Office of the Special Adviser on Africa and entrusted that Office with the responsibilities of coordinating the preparation of Africa-related reports, coordinating global advocacy in support of the New Partnership for Africa's Development, and coordinating the interdepartmental task force on African affairs to ensure coherence and an integrated approach for United Nations support to Africa.
- 11.3 In response, through Secretary-General's bulletin ST/SGB/2003/6 of 1 May 2003, the Secretary-General established the Office of the Special Adviser on Africa with the following functions: (a) to support the General Assembly and the Economic and Social Council in their deliberations on Africa; (b) to coordinate and guide the preparation of Africa-related reports and inputs, in particular support for the New Partnership for Africa's Development by the United Nations system and the international community, including the private sector and civil society; (c) to coordinate the interdepartmental task force on African affairs in order to ensure a coherent and integrated approach for United Nations support for Africa, including following up on the implementation of all global summit and conference outcomes related to Africa; (d) to initiate reports on critical issues affecting Africa, in particular on the interrelated issues of peace and development; (e) to coordinate global advocacy in support of the New Partnership for Africa's Development; and (f) to act as the focal point for the New Partnership for Africa's Development within the United Nations Secretariat at Headquarters.
- 11.4 The activities for which the Office is responsible fall within programme 9 of the biennial programme plan for the period 2006-2007. Taking into account the nature and scope of the support to the New Partnership for Africa's Development that the United Nations and the programmes and specialized agencies of the United Nations system are expected to provide, the programme includes three subprogrammes, as follows:
  - (a) Subprogramme 1. Coordination of global advocacy of and support for the New Partnership for Africa's Development, under the responsibility of the Office of the Special Adviser on Africa;

- (b) Subprogramme 2. Regional coordination of and support for the New Partnership for Africa's Development, under the responsibility of a special coordinating unit in the Economic Commission for Africa (ECA);
- (c) Subprogramme 3. Public information and awareness activities in support of the New Partnership for Africa's Development, under the responsibility of the Africa Section in the Department of Public Information.

The main objectives of the programme are: (a) to mobilize the support and galvanize the efforts of the international community for African peace and development; (b) to ensure that the development of Africa remains one of the priorities of the international community; (c) to promote a supportive framework for Africa's development efforts; (d) to promote a coordinated and effective response by the United Nations system at the policy and operational levels in support of Africa's development; and (e) to strengthen South-South cooperation.

- 11.5 An important aspect of the work of the Office of the Special Adviser on Africa, which is responsible for subprogramme 1, will be the preparation of reports to aid deliberations on African peace and development issues by the various intergovernmental bodies of the United Nations and other thematic studies that will shed light on particular policy issues affecting Africa's peace and development. The Office seeks to raise awareness of Africa's development issues through advocacy and catalytic activities, participation at key forums, promotion of United Nations system coordination, promotion of South-South cooperation and interface with civil society and private sector. In addition, it will closely monitor and follow up on existing commitments made in connection with recent international conferences and other initiatives. The Office will also organize briefings for African delegates on topical issues on African development, and in particular on progress in the implementation of the New Partnership for Development. The Office may be called upon from time to time to prepare reports for the Economic and Social Council and its subsidiary bodies. In view of the interlinkages between peace and development in Africa, the Office will analyse and draw attention to the root causes of conflict in African countries, monitor early warning signals and advise on steps that need to be taken to mitigate conflicts in African countries.
- 11.6 The work of subprogramme 2, which falls under the responsibility of ECA, will aim at facilitating the coordination of the United Nations system-wide support to the implementation of the New Partnership for Africa's Development and other related programmes and initiatives at the regional, subregional and country levels using the frameworks of ECA offices in the subregions, the regional economic communities, the thematic clusters under the United Nations action plans in support of the New Partnership for Africa's Development, the resident coordinator system and non-governmental organizations.
- 11.7 Subprogramme 3, which falls under the responsibility of the Department of Public Information, will place special emphasis on publicizing the work of the United Nations and the United Nations system, other international organizations, bilateral donors, regional organizations and African countries to support the implementation of the New Partnership for Africa's Development through media liaison and enhanced distribution of information materials. The subprogramme will develop global communications strategies on priority issues affecting Africa and ensure that these strategies incorporate the full range of information activities undertaken globally by the Department. It will implement those strategies in coordination with the United Nations Communications Group and the United Nations system as a whole.
- 11.8 In implementing this programme, the Office of the Special Adviser on Africa, ECA and the Department of Public Information will pay due regard to the need to foster collaboration and coordination with other entities of the United Nations system working in Africa, which may entail

participating in various inter-agency meetings on Africa's development. Thus, the offices will work closely with Member States, the African Union, the secretariat of the New Partnership for Africa's Development in Johannesburg, South Africa, the United Nations system, including the Bretton Woods institutions, and the Global Coalition for Africa, in the performance of its functions and in order to promote their activities as part of a coordinated United Nations information campaign on Africa. In addition, it will establish and maintain contacts with civil society organizations and the private sector. It will promote South-South cooperation in support of Africa's development and in doing so will participate in existing frameworks, such as the Tokyo International Conference on African Development.

- 11.9 The expected accomplishments and indicators of achievement for the programme in the biennium 2006-2007 are detailed, together with resources, under the programme of work. The overall framework of these expected accomplishments and indicators of achievement is shown in table 11.1.

- 11.10 The issue of publications as a part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown in table 11.2 below in summary and as distributed in the output information for each subprogramme.

- 11.11 The overall resources required for the biennium 2006-2007 under this section amount to \$9,740,400 before recosting, reflecting an increase of \$165,400 (or 1.7 per cent). The growth shown in table 11.5 can be summarized as follows:

- (a) An increase of \$112,200 under subprogramme 1 as a result of: (i) an increase of \$104,800 (for consultants and experts, travel of staff, contractual services and general operating expenses) in the light of additional activities in the Office in support of the New Partnership for Africa's Development; and (ii) an increase in the amount of \$7,400 reflecting the Office's share of centrally provided data-processing infrastructure services and support costs;

- (b) An increase of \$53,200 under subprogramme 3 as a result of: (i) an increase of \$50,600 (for other staff costs and contractual services) in support of additional promotion and liaison activities; and (ii) an increase of \$2,600 reflecting the Office's share of centrally provided data-processing infrastructure services and support costs.
- 11.12 During the biennium 2006-2007, the projected extrabudgetary resources amounting to \$526,000 will supplement resources from the regular budget to finance various activities, such as: (a) preparation of policy papers on emerging issues on Africa, with emphasis on the nexus between peace and development; (b) follow-up activities to the Third Tokyo International Conference on African Development; (c) activities enhancing human security in Africa; (d) initiatives for increased cooperation between Africa and its development partners, including Asian countries; (e) water resources and conflict; (f) youth unemployment and conflict; and (g) promotion of understanding and support for the implementation of the New Partnership for Africa's Development in Europe, Asia and Africa through the posting of outputs on major Africa-related websites and distribution of information kits and media packages.
- 11.13 Pursuant to General Assembly resolution 58/269 of 23 December 2003, resources identified for the conduct of monitoring and evaluation would amount to \$150,100, funded from regular budget resources and reflected under each subprogramme.
- 11.14 The estimated percentage distribution of the resources of the programme in the biennium 2006-2007 is shown in table 11.3.
- 11.15 The distribution of resources is summarized in tables 11.4 and 11.5.

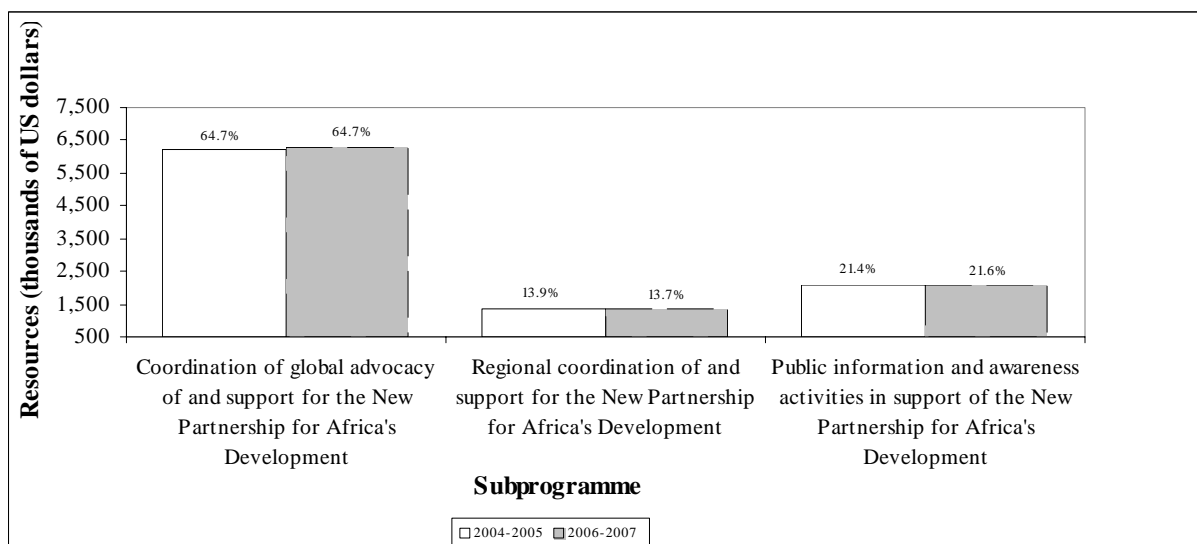

- 11.17 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) Member States demonstrate the political will to implement actions in support

of the New Partnership for Africa's Development; (b) the agencies of the United Nations system collaborate and coordinate their activities in a coherent and effective manner; (c) the private sector and civil society show their willingness to be involved in the implementation of the New Partnership; and (d) all stakeholders implement their financial pledges and other commitments in support for the New Partnership for Africa's Development.

- 11.19 The amount of \$6,303,600, reflecting an increase of \$112,200, is required for the continuation of the 19 existing posts and related non-post resources. The increase of \$112,200 for the non-post category will cover additional requirements under consultants and experts, travel of staff, contractual services and general operating expenses to enable the Office of the Special Adviser on Africa to undertake additional advocacy, promotion and liaison activities in support of the New Partnership for Africa's Development through the organization of additional expert group meetings, the undertaking of additional travel, the update of the software for the Directory of African non-governmental organizations, the redesign of the Office's website and the development of an advocacy and communication strategy. The increase will also cover the Office's share of centrally provided data-processing infrastructure services and support costs.

## Subprogramme 2

### Regional coordination of and support for the New Partnership for Africa's Development

**Resource requirements: (before recosting): \$1,330,400**

- 11.20 The subprogramme will be implemented by ECA. The programme of work has been formulated by drawing upon subprogramme 2 of the biennial programme plan for the period 2006-2007. In addition to the outputs listed in paragraph 11.22, the subprogramme also contributes to the report to the General Assembly on the United Nations system support for the New Partnership for Africa's Development prepared by the Office of the Special Adviser on Africa.

### External factors

- 11.21 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) United Nations agencies and organizations working in Africa are committed to the implementation of joint activities and programmes in support of the New Partnership for Africa's Development and the attainment of the United Nations Millennium Development Goals; and (b) African regional bodies, regional economic communities and intergovernmental organizations are supportive of United Nations efforts to strengthen system wide support for the New Partnership for Africa's Development.

### Outputs

- 11.22 During the biennium, the following outputs will be delivered:
- (a) Servicing of intergovernmental and expert bodies (regular budget):

- 11.25 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that media outlets in Europe, North America and Africa are willing to reproduce the information contained in the Africa Section's various outputs, including *Africa Renewal*.

## Outputs

- 11.26 During the biennium, the following final outputs will be delivered: other substantive activities (regular budget and extrabudgetary):
- (a) Recurrent publications: *Africa Renewal* (four times a year) in English (8); *Afrique Renouveau* (four times a year) in French (8);
  - (b) Booklets, fact sheets, wall charts, information kits: information kits, briefing papers, press releases, media advisories and input to United Nations radio broadcasts on major international, regional and local initiatives and developments that support or have an impact on Africa's economic and social development (4);
  - (c) Press releases, press conferences: promotion of information materials produced by the section through media liaison with editors and writers in major African media and with major donor and other countries to place these articles and to include relevant information on United Nations support for Africa in their own materials (1);
  - (d) Technical material:
    - (i) *Africa Renewal* website (English): develop and maintain the website, produce content tailored to the media and others interested in Africa's development for access through the website and create the site design to optimize audience access to all available information materials (<http://www.un.org/AR>) (1);
    - (ii) *Afrique Renouveau* website (French): develop and maintain the website, produce content tailored to the media and others interested in Africa's development for access through the website and create site design and page layouts to optimize audience access to all available information materials (<http://www.un.org/AR>) (1).

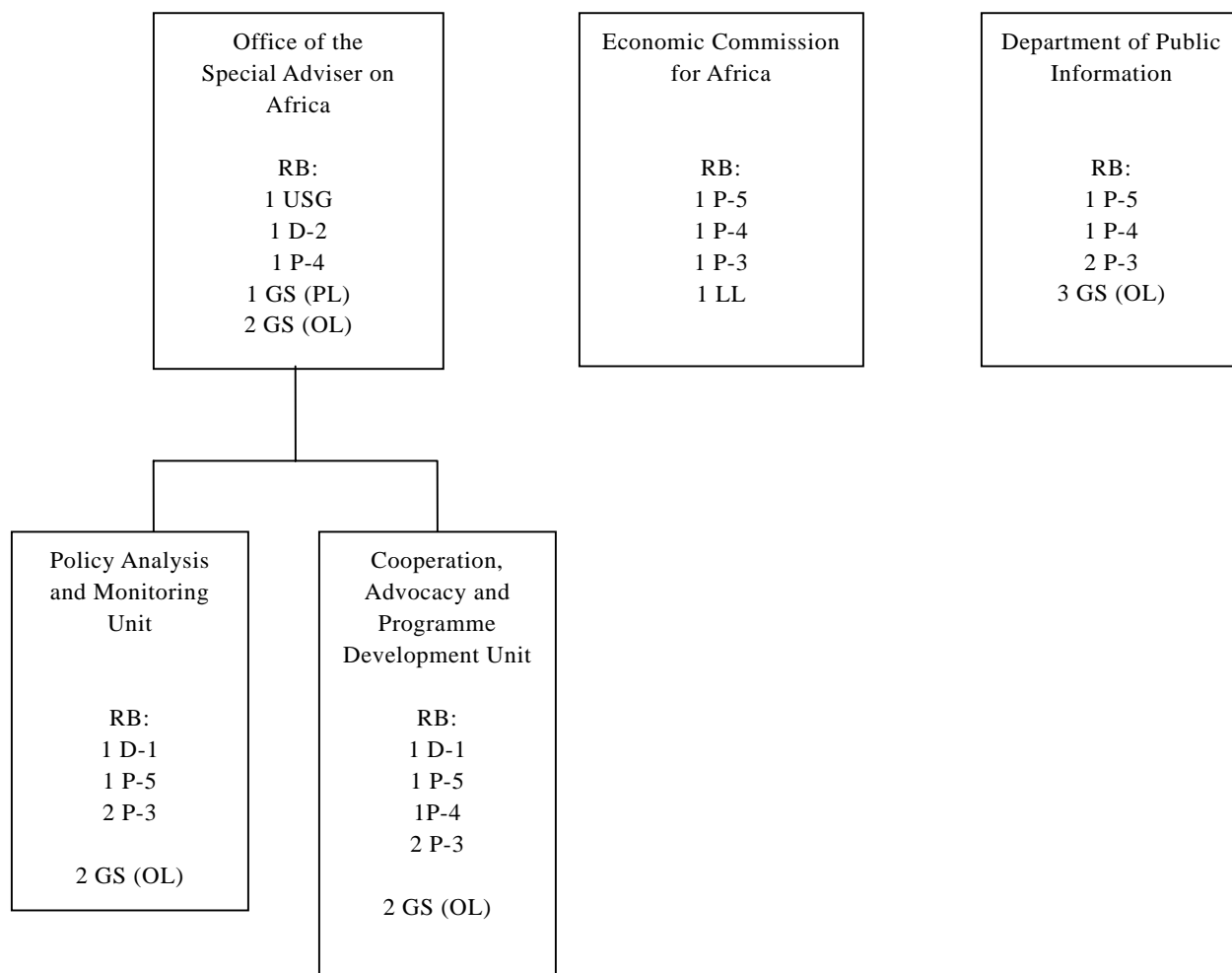

- 11.27 The amount of \$2,106,400, reflecting an increase of \$53,200, provides for the continuation of the seven existing posts and related non-post requirements. The increase of \$53,200 for the non-post category will cover additional requirements under other staff costs, contractual services and general operating expenses to enable the subprogramme to implement additional promotion and liaison activities through increased use of African-based freelance writers, redesign of the *Africa Renewal* website, improvement of the graphic appeal of the magazine and enhanced distribution and increased target deliveries of the magazine and other materials produced by the section. The increase will also cover the Office's share of centrally provided data-processing infrastructure services and support costs.
