## Overview

- 14.1 The United Nations Environment Programme (UNEP) is responsible for the implementation of the work programme under this section. The activities for which UNEP is responsible fall within the framework of programme 11, Environment, of the biennial programme plan for the period 2006-2007.
- 14.2 UNEP was established by the General Assembly in its resolution 2997 (XXVII) of 15 December 1972, with the Governing Council of UNEP as its policymaking organ, a secretariat to serve as a focal point for environmental action and coordination within the United Nations system and a voluntary fund, namely, the Environment Fund, to provide additional funding for environmental programmes. The secretariat is headed by an Executive Director who is elected by the Assembly on the nomination of the Secretary-General. The Executive Director is responsible for the administration of the Environment Fund, under the authority and policy guidance of the Governing Council.
- 14.3 The mandate of UNEP has been confirmed through various legislative measures, both by the General Assembly and the Governing Council of the Programme. UNEP also provides the secretariats to several global and regional conventions that have been established in areas related to UNEP programme activities.
- 14.4 As in the biennium 2004-2005, the programme of work for the biennium 2006-2007 is geared towards implementation of the internationally agreed development goals, including those contained in the United Nations Millennium Declaration and in outcomes of major United Nations conferences and international agreements adopted since 1992. It is fully consistent with the mandate given to UNEP in the 1972 Stockholm Declaration on the Human Environment, the 1997 Nairobi Declaration on the Role and Mandate of the United Nations Environment Programme and the 2000 Malmö Declaration. The programme of work will be implemented through seven subprogrammes, namely: (a) environmental assessment and early warning; (b) policy development and law; (c) policy implementation; (d) technology, industry and economics; (e) regional cooperation and representation; (f) environmental conventions; and (g) communications and public information.
- 14.5 In implementing the programme of work, UNEP will, inter alia: (a) carry out consultations and interaction between representatives of and partnerships among Governments, scientific institutions, intergovernmental and non-governmental organizations (NGOs) on keeping the state of the environment under review at the global and subglobal levels; (b) participate and contribute to regional and global processes related to environmental assessments and early warning and environmental monitoring and information management; (c) participate in and contribute to inter-agency activities related, inter alia, to the United Nations System Chief Executives Board for Coordination (CEB), the High-level Committee on Programmes and the United Nations executive committees; the work of the legal advisors led by the United Nations Office of Legal Affairs; poverty-environment nexus; post-conflict environmental issues; environmental emergencies; integrated water resource management; United Nations-Energy; network of UNEP-United Nations Industrial Development Organization (UNIDO) national cleaner production centres; promoting sustainable patterns of consumption and production; discussions on economics, trade and environment issues and multilateral environmental agreements; parties to the United Nations Framework Convention on Climate Change; UNEP inputs to United Nations system-wide activities related to environment and sustainable development; system-wide follow-up to the World Summit on Sustainable Development; the work of the United Nations Development Group; and in support of the Decade of Education for Sustainable Development (2005-2014); (d) provide technical support to expert groups, such as the Millennium Project Task Force 7 on Water and Sanitation and

environmental risk assessment in developing strategies and decision-making tools for effective technologies in disaster management; (e) contribute to United Nations Department of Public Information media kits, publications and audio-visual materials; (f) participate in and contribute to initiatives led by other United Nations bodies concerned with environment in the region; (g) provide substantial input to intergovernmental conferences of the parties to the UNEP regional seas agreements and action plans; and (h) participate in and contribute to other intergovernmental regional and subregional processes and development and coordinated implementation of joint project proposals tackling transboundary and common environmental priorities.

- 14.6 In his report (A/59/395), submitted in compliance with General Assembly resolution 58/270 of 23 December 2003, by which the Assembly requested the Secretary-General to review the structure and functions of all liaison or representation offices in New York of organizations headquartered elsewhere funded from the United Nations regular budget, the Secretary-General informed the Assembly that the New York office of UNEP is responsible for both representational and substantive programmatic activities and is the location of the Policy Coordination and Inter-agency Affairs branch of the Division of Policy Development and Law. The office serves as a vital link for UNEP in the three main areas of intergovernmental meetings, inter-agency matters and outreach activities. The New York office ensures, through its participation in intergovernmental meetings, that the UNEP mandate and activities on a wide variety of environmental policy issues are taken into account in the deliberations and recommendations of the Assembly and the Economic and Social Council and its subsidiary bodies located at United Nations Headquarters, as well as special United Nations summits and conferences. Coordination of United Nations system-wide activities in the field of the environment is ensured by the participation of the New York office in major inter-agency meetings, such as CEB and executive committees, as well as linkages with agencies, funds and programmes and departments of the United Nations system. It is also the UNEP focal point for its membership in the United Nations Development Group and coordination of programmatic activities related to country-level capacity development and technical cooperation. Through various outreach initiatives and products, the office builds support among groups, such as United Nations-affiliated NGOs, foundations, private sector corporations, academic institutions, religious and indigenous groups and others for the work of UNEP, providing them with scientific and substantive information and facilitating the transmittal of their views and information to other substantive units within UNEP. The New York office also serves as the UNEP focal point with the Department of Public Information, works closely with the Office of the Spokesman for the Secretary-General and organizes environment-related special events and exhibits at United Nations Headquarters and in New York. The staff of the office consists of one P-4, one P-2 and two GS (OL) financed from the United Nations regular budget, and one D-1, one P-4 and four GS (OL) funded through extrabudgetary resources.
- 14.7 Pursuant to the request contained in General Assembly resolutions 56/253 of 24 December 2001 and 57/292 of 20 December 2002, that the United Nations Office at Nairobi (UNON) be further strengthened, proposals for strengthening the programme budget component of the Office are included in section 28G, Administration, Nairobi, of the proposed programme budget for the biennium 2006-2007. These proposals include the establishment of 13 new posts under the proposed programme budget to provide administrative services that otherwise would have to be financed from the extrabudgetary resources of UNEP and the United Nations Human Settlements Programme (UN-Habitat). The proposals would therefore result in releasing UNEP and UN-Habitat extrabudgetary resources from administrative activities for reprogramming for substantive activities.

- 14.8 The Programme's main expected accomplishments and indicators of achievement for the biennium 2006-2007 are detailed, together with required resources, under executive direction and management and the programme of work. The overall framework of these expected accomplishments and indicators of achievement is shown in table 14.1.

- 14.9 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown below in table 14.2 and as distributed in the output information for each subprogramme.

- 14.10 The regular budget resources for the biennium 2006-2007 amount to \$11,193,600 and reflect an increase of \$277,800, or 2.5 per cent, distributed as follows: (a) an increase of \$273,500 under executive direction and management, representing: (i) the delayed impact of the P-5 post established in the biennium 2004-2005 for the Chief, Evaluation and Oversight Unit of UNEP (\$154,500); (ii) the establishment of one new P-3 post, for a Programme Officer as Secretary of the Governing Bodies of UNEP (\$119,000); and (b) an increase of \$4,300 under programme of work relating to the UNEP share of centrally provided data-processing infrastructure services and support costs, including those of storage area networks, application servers, departmental servers, backup units and desk top connectivity.
- 14.11 The extrabudgetary resources projected to be available to UNEP in the biennium 2006-2007 amount to \$260,931,400 and represent 95.6 per cent of the total resources expected to be available to this programme. The existing arrangements for intergovernmental review and management of

these extrabudgetary funds provide for the Governing Council of UNEP to approve biennial budgets for the use of such extrabudgetary resources.

- 14.12 The scope of the evaluation and oversight function of UNEP comprises the programmes and projects of the Environment Fund and related trust funds as well as projects of the Global Environmental Facility that are implemented by UNEP. The overall objective of the Evaluation and Oversight Unit is to enable UNEP senior management and its member States to engage in systematic reflection on UNEP programme performance, to increase the effectiveness of programmes and to review their objectives, if necessary. Pursuant to General Assembly resolution 58/269 of 23 December 2003, the Evaluation and Oversight Unit in UNEP comprises a Chief at the P-5 level, an Evaluation Officer at the P-4 level, a junior Professional officer and three administrative support staff in the General Service (Other level), falling under executive direction and management, funded from the regular budget.
- 14.13 The estimated percentage distribution of the resources under section 14 for the biennium 2006-2007 is as shown in table 14.3.

## A. Policymaking organs

### *Resource requirements (before recosting): \$41,200*

- 14.15 The Governing Council is the policymaking organ of UNEP. It has one principal subsidiary organ, namely, the Committee of Permanent Representatives.
- 14.16 The Governing Council consists of 58 member States. By its resolution 53/242 of 28 July 1999, the General Assembly instituted an annual ministerial-level, global environmental forum, with the Governing Council constituting the forum in the years that it meets in regular session and, in alternate years, with the forum taking the form of a special session of the Governing Council, in which participants review important and emerging policy issues in the field of the environment. The ninth special session and the twenty-fourth regular session of the Governing Council/Global Ministerial Environment Forum will be held in Dubai from 7 to 9 February 2006 and in Nairobi from 5 to 9 February 2007, respectively.
- 14.17 The Governing Council decided, in its decisions 19/32 and 21/20, that the Committee of Permanent Representatives would hold four regular meetings a year and that its proceedings would be conducted in all the official languages of the United Nations.

- 14.18 The estimated amount of \$41,200 will cover overtime and hospitality requirements during meetings of the Governing Council and its subsidiary organs.

## B. Executive direction and management

- 14.19 Executive direction and management is composed of the Office of the Executive Director of UNEP and the United Nations Scientific Committee on the Effects of Atomic Radiation.

### 1. Office of the Executive Director

***Resource requirements (before recosting): \$3,684,000***

- 14.20 The Executive Director of UNEP has overall responsibility within the United Nations system for providing leadership on environmental policy, assessing the causes and effects of environmental change, identifying emerging issues and catalysing responsive international action. The Executive Director is also responsible for the coordination of environmental activities within the United Nations system and the provision of support to the UNEP Governing Council/Global Ministerial Environment Forum.
- 14.21 The Office of the Executive Director provides executive and support services to the Executive Director and the Deputy Executive Director, as well as to the senior management of UNEP. The Deputy Executive Director assists the Executive Director in the performance of his or her functions. The Deputy Executive Director manages the Environment Programme, supervises all divisions and regional offices of UNEP and the mechanisms for programme coordination and monitoring, while, at the same time, playing an active role in developing and facilitating consultations with Governments, including through permanent missions accredited to UNEP in Nairobi, and ensures UNEP responsibility as implementing agency of the Global Environment Facility.
- 14.22 Included in the Office of the Executive Director are the Programme Coordination and Management Unit, the Evaluation and Oversight Unit and the Office of the Secretariat for Governing Bodies. The Programme Coordination and Management Unit coordinates the planning and programming process, facilitates the project design and approval process, and monitors and reports on programme performance. The Unit also supports the Deputy Executive Director in the management of the programme, including the guidance and policy clearance of all programmatic matters. The



Evaluation and Oversight Unit evaluates the implementation of the programme and coordinates UNEP activities related to the Office of Internal Oversight Services, Board of External Auditors and Joint Inspection Unit. Based on the evaluation and audit recommendations, the Unit provides policy advice for improved programme management and implementation. The secretariat for Governing Bodies provides secretariat support to the Governing Council/Global Ministerial Environment Forum and its subsidiary bodies, such as the Committee of Permanent Representatives, serves as the focal point for the overview of external relations with Governments, as well as relevant intergovernmental organizations, NGOs and the United Nations agencies, and provides documentation to and facilitates the participation of Governments and other external partners in sessions of the Governing Council/Global Ministerial Environment Forum and the meetings of its subsidiary bodies.

14.23 During the biennium, the following outputs will be delivered:

(a) Servicing of intergovernmental and expert bodies (regular budget/extrabudgetary):

- (i) United Nations Environment Programme — Governing Council:
  - a. Substantive servicing of meetings. Ninth special session, twenty-fourth regular session and the Bureau meetings of the Governing Council/Global Ministerial Environment Forum (6);
  - b. Parliamentary documentation. Reports to the Governing Council/Global Ministerial Environment Forum as required (30);
- (ii) UNEP — Committee of Permanent Representatives:
  - a. Substantive servicing of meetings. Preparatory meetings by the Committee of Permanent Representatives, including its subcommittees related to the ninth special session and the twenty-fourth regular session of the Governing Council/Global Ministerial Environment Forum (20); regular meetings of the Committee of Permanent Representatives (8);
  - b. Parliamentary documentation. Quarterly reports to the Committee of Permanent Representatives (40);
- (b) Other substantive activities (regular budget/extrabudgetary):
  - (i) Booklets, fact sheets, wall charts, information kits: list of environmental meetings (24);
- (c) Conference services, administration, oversight (regular budget/extrabudgetary):
  - (i) Overall administration and management: direction, guidance and policy clearance of all programmatic and administrative actions; coordination of the planning and programming process, including the preparation of the strategic framework, biennial programme and budget, project documents; management of programme and project implementation, including regular programme and project performance reviews as well as the preparation of programme performance monitoring reports;
  - (ii) Audits: facilitation of internal and external audits and follow-up on the implementation of audit recommendations;
  - (iii) Evaluations: coordination and management of the evaluation of programmes and projects, including the preparation of the annual evaluation report, subprogramme evaluations and project evaluations.

- 14.24 The amount of \$3,684,000 provides for 17 posts and various non-post items. The increase of \$273,500 in post resources is attributable to: (a) the full funding of one P-5 post established in the biennium 2004-2005 for a Chief, Oversight and Evaluation Unit of UNEP (\$154,500); and (b) the establishment in 2006-2007 of one new P-3 post, Secretary of the Governing Bodies of UNEP, to ensure efficiency in the provision of secretariat support to the Group of 77 and China, Nairobi Chapter, relationship and communication with Governments and permanent representatives and preparation and conduct of meetings of the Governing Council, Committee of Permanent Representatives and related bodies, with a focus on administrative and budgetary matters, protocol, and the monitoring of efforts to achieve the goal of gender equality within UNEP (\$119,000).
- 14.25 Non-post requirements for travel of staff (\$28,600), rental and maintenance of office and data-processing equipment (\$60,300), communications (\$6,200), supplies and materials (\$6,400) and office automation equipment (\$15,100) are proposed at the maintenance level.
- 14.26 Extrabudgetary resources are utilized to assist in the management of UNEP, including in particular, the development, formulation, delivery and evaluation of the UNEP programme of work.

## 2. United Nations Scientific Committee on the Effects of Atomic Radiation

### *Resource requirements (before recosting): \$995,400*

- 14.27 Since the creation of the United Nations Scientific Committee on the Effects of Atomic Radiation by General Assembly resolution 913 (X) of 3 December 1955, its mandate has been to undertake broad reviews of the sources of ionizing radiation and the effects of such radiation on the health of humans and the environment. At the time of its formation, nuclear weapons were being tested in the atmosphere and radioactive debris was being dispersed throughout the environment. Treaties now ban tests of weapons in the atmosphere, but the global exposure of populations from natural or medical sources continues to be considerably larger than that caused by fallout from weapons testing, even at its peak during the mid-1960s. Exposure to radiation occurs from sources and practices, such as nuclear electricity generation, areas of high background from natural radiation, reactor accidents such as the one at Chernobyl, occupations that entail enhanced exposure to man-made or naturally occurring sources, and from medical diagnostic and therapeutic procedures utilizing X-rays and radionuclides. The Scientific Committee evaluates these and by linking to effects, plays a central role in radiation risk assessment worldwide. Its radiation risk assessments provide the scientific foundation used by the International Commission on Radiological Protection in developing its recommendations for radiation protection and by the International Atomic Energy Agency in formulating its Basic Safety Standards for the protection of people and the safety of radiation sources.
- 14.28 The secretariat of the Scientific Committee, located in Vienna, organizes and services its annual sessions and is responsible for the preparation of the scientific documents requested by the Committee for review and discussion at its sessions.
- 14.29 The General Assembly, in its resolution 59/114 of 10 December 2004, emphasized the need for the Scientific Committee to hold regular sessions on an annual basis so that its report can reflect the latest developments and findings in the field of ionizing radiation and thereby provide updated information for dissemination among all States. In the same resolution, the Assembly reaffirmed its decision to maintain the present functions and independent role of the Scientific Committee.

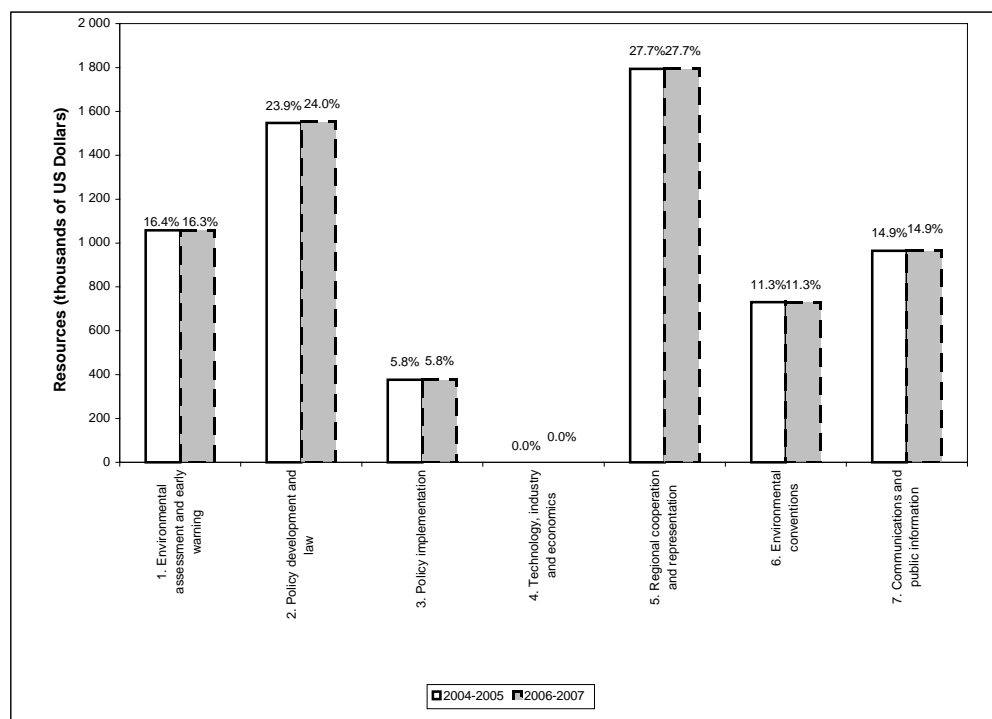
- 14.32 The amount of \$705,000 provides for the continuation of three posts. Non-post requirements of \$290,400, at the maintenance level, would cover: overtime (\$1,200); specialized consultancy services for preparation of studies and reports to the annual sessions of the Scientific Committee (\$108,200); travel of representatives (\$142,900); travel of staff (\$14,000); contractual services for publication of an explanatory booklet regarding the activities of the United Nations Scientific Committee on the Effects of Atomic Radiation (\$1,500); maintenance of data-processing equipment (\$12,000); and acquisition and replacement of data-processing equipment (\$10,600).

### Subprogramme 1

#### Environmental assessment and early warning

**Resource requirements (before recosting): \$1,057,700**

- 14.33 The Division of Environmental Assessment and Early Warning is responsible for the implementation of this subprogramme. The programme of work has been formulated drawing upon subprogramme 1 of programme 11 of the biennial programme plan for the period 2006-2007.
- 14.34 In the biennium 2006-2007, subprogramme 1 will undertake further efforts to strengthen the scientific base of its assessment process and improve the credibility of assessment findings, including through the development of innovative approaches and assessment methodologies, and the strengthening of the scientific capacities of regional and national centres, which contribute to UNEP assessment activities. Efforts will also be undertaken to strengthen its participation in global assessments, such as, inter alia, Global International Waters Assessment, Global Marine Assessment, World Water Assessment and Global Forest Resources Assessment, as well as activities of the global environmental observing and monitoring systems, such as, inter alia, Global Ocean Observing System and Global Earth Observation System of Systems. Furthermore, the biodiversity-related services offered through the UNEP World Conservation Monitoring Centre will be revitalized to cater to the needs of both member States and multilateral environmental agreements.

- 14.35 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) adequate institutional framework will be in place and there would be cooperation and commitment of external partners at the global, regional and national levels, including Governments, intergovernmental organizations and scientific communities contributing to the environmental assessment process; (b) Governments will be willing to provide access to national-level information as input to assessment activities and state-of-the-environment reporting; and (c) sufficient additional financial contributions are mobilized.

#### Outputs

## Subprogramme 2

### Policy development and law

**Resource requirements (before recosting): \$1,551,000**

- 14.38 The Division of Policy Development and Law is responsible for the implementation of this subprogramme. The programme of work has been formulated drawing upon subprogramme 2 of programme 11 of the biennial programme plan for the period 2006-2007.
- 14.39 In the biennium 2006-2007, much of the policy coordination work will focus on strengthening the work of UNEP within the United Nations Development Group, in particular its contribution to national poverty reduction strategies, and on facilitation of coordinated approaches to addressing environmental priorities within the United Nations system. Furthermore, efforts will be undertaken

to develop approaches to enhance the engagement of civil society in policy dialogue in addressing the internationally agreed priorities. The emphasis of the policy review and development work for the biennium 2006-2007 will be the environmental components of the internationally agreed goals, including integrated water resources management, human health, urban pollution and climate change.

Related outputs include information kits and a web-accessible database (4); subregional training courses for national policymakers in policy evaluation and environmental accounting for sustainable management of dryland environments (2); workshop to provide technical support to national Governments in testing the ecosystem approaches on the regional and national levels as a strategic tool for integrated policy development for land use management and soil conservation (1); workshops and country dialogues on integrating vulnerability and adaptation to climate change into sustainable development planning in six countries in eastern and southern Africa, resulting in six adaptation pilot projects to test adaptation methodologies (6);

- (iii) Fellowships and grants: attachment programme for legal officers from developing country Governments as well as from countries with economies in transition to work, on a temporary basis, in the UNEP Environmental Law Branch to obtain relevant training and experience (3);

- 14.42 The requirements, at the maintenance level of \$1,515,500, would provide for the continuation of five posts. Non-post requirements, \$35,500, reflecting an increase of \$4,300 would cover: the UNEP New York office share of centrally provided data-processing infrastructure services costs, including those of storage area networks, application servers, departmental servers, back-up units and desktop connectivity (\$3,400); communications (\$12,100); maintenance of office automation equipment (\$11,700); the UNEP New York office share of centrally provided data-processing infrastructure support costs (\$900); office supplies (\$3,400) and replacement of office automation equipment (\$4,000).

### Subprogramme 3 Policy implementation

#### *Resource requirements (before recosting): \$376,200*

- 14.43 The Division of Environmental Policy Implementation is responsible for the implementation of this subprogramme. The programme of work has been formulated drawing upon subprogramme 3 of programme 11 of the biennial programme plan for the period 2006-2007.
- 14.44 During the biennium 2006-2007, there will be an increase in activities related to environmental education and training, including those designed to support the implementation of the Decade of Education for Sustainable Development initiative. The implementation of the Global Programme of Action for the Protection of the Marine Environment from Land-based Activities will be strengthened, including its participation in such intergovernmental or inter-agency activities as, inter alia, implementation of the outcome of the Barbados Programme of Action, and the United Nations Open-ended Informal Consultative Process on Oceans and the Law of the Sea. The biennium will also see the strengthening of the UNEP contribution to inter-agency work in relation to environmental emergencies as well as the continuation of efforts to replicate the environmental law services to other regions based on the experience gained in Africa.

#### External factors

- 14.45 The subprogramme is expected to achieve its objectives and expected accomplishments on the assumption that: (a) there will be political will and commitment by Governments to address environmental management issues and promote prevention and mitigation of environmental damage with UNEP advice and assistance; and (b) there are no major shortfalls to the Environment Fund and other external funding to carry out the work programme.

- 14.47 The amount of \$317,000, at the maintenance level, provides for the continuation of two posts. - 14.49 The main challenges for the biennium will be the implementation of the outcome of the Strategic Approach to International Chemicals Management process, which is expected to be concluded by early 2006, as well as the continued support to the implementation of the elements of the Johannesburg Plan of Implementation related to sustainable production and consumption. Another development would be the availability of a wide range of services from the UNEP International Environmental Technology Centre, including capacity-building services and institutional networking in areas of waste management and energy conservation and efficiency, attributed to the ongoing process of revitalization of the Centre. In addition, the biennium will see more collaborative efforts with relevant United Nations entities in promoting mutually supportive environment and trade, finance and economic development policies, as well as the fostering of

partnerships and the initiation of joint undertakings with the industry and financial sector in advancing cleaner production practices and sustainable consumption of natural resources.

## Subprogramme 5

### Regional cooperation and representation

**Resource requirements (before recosting): \$1,793,700**

- 14.53 The Division of Regional Cooperation and Representation is responsible for the implementation of this subprogramme. The programme of work has been formulated drawing upon subprogramme 5 of programme 11 of the biennial programme plan for the period 2006-2007. The programme of work is implemented through six regional offices, those for Africa, Asia and the Pacific, Europe, Latin America and the Caribbean, North America and West Asia, each of which addresses the unique circumstances of the corresponding region, but encompasses some common elements.
- 14.54 In the biennium 2006-2007, capacities of regional offices will be strengthened to support regional environmental policy dialogue and coordinated policy implementation, and the delivery of UNEP technology transfer and capacity-building activities at the regional, subregional and national levels. In the context of regional cooperation, regional offices will contribute to a wide range of intergovernmental processes such as, inter alia, the environmental initiative of the New Partnership for Africa's Development, Transport, Health and Environment Pan-European Process,

Environment and Health Initiative of the Americas, African Ministerial Council on Water, Caribbean Network of Protected Areas activities and Arab Initiative on Sustainable Development.

- 14.57 The amount of \$1,627,900, at the maintenance level, provides for the continuation of seven posts. Non-post resources of \$165,800, at the maintenance level, would cover: other staff costs (\$71,800); consultants' services to undertake evaluations of regional delivery arrangements (\$15,000); travel of staff (\$26,400); communications (\$19,400); maintenance of office automation equipment (\$25,500); office supplies (\$3,600); and replacement of office automation equipment (\$4,100).

## Subprogramme 6 Environmental conventions

**Resource requirements (before recosting): \$730,200**

- 14.58 The Division of Environmental Conventions is responsible for the implementation of this subprogramme. The programme of work has been formulated drawing upon subprogramme 6 of programme 11 of the biennial programme plan for the period 2006-2007.
- 14.59 During the biennium 2006-2007, efforts will be undertaken to promote, among member States, the consideration of socio-economic factors in the implementation of multilateral environmental agreements, in particular biodiversity-related multilateral environmental agreements, and to promote, within the framework of the Inter-Agency Network on Biotechnology, the application of biotechnology in developing countries. In addition, the subprogramme will continue its efforts to find ways to use the Regional Seas mechanism as a vehicle for implementing the objectives of sustainable development as well as of multilateral environmental agreements, with particular attention given in the biennium 2006-2007 to joint development and implementation of programmes and projects with global conventions such as, inter alia, the Basel Convention and the International Convention for the Prevention of Pollution from Ships.

- 14.64 During the biennium 2006-2007, efforts will continue to ensure that environmental issues receive adequate coverage by the international media and that the public is provided with access to comprehensive and credible environmental information from its website(s) via the Internet. In addition, awareness-raising activities and campaigns, with a special focus on children, youth and sporting communities, will be organized to create environmental awareness and enhance their participation in environmental management.

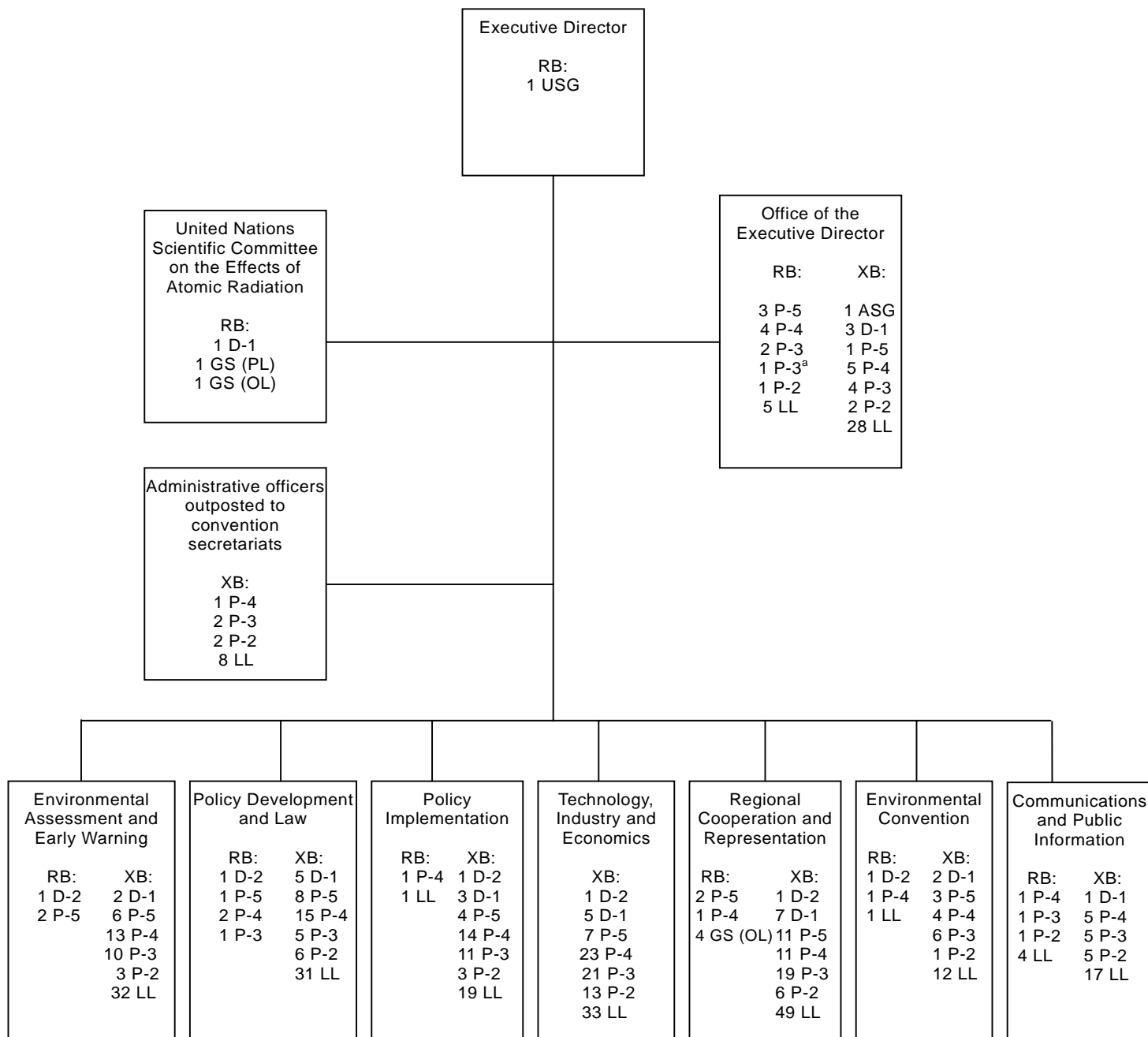
