Overview

- 20.1 The Economic Commission for Latin America and the Caribbean (ECLAC) is responsible for the implementation of programme 17 of the biennial programme plan and priorities for the period 2006-2007. Its terms of reference were adopted by the Economic and Social Council in its resolution 106 (VI) and subsequent amendments.
- 20.2 The proposed programme budget for the biennium 2006-2007 is intended to allow ECLAC to continue to provide its support to the capacity-building of its member States through a combination of analytical work and operational service. The flexibility to grasp and respond to new demands of its stakeholders shows in the Commission's drive to continuously refocus its activities to consider new topics and explore emerging interrelationships between different subject areas. The redeployment of a number of posts among subprogrammes reflects the efforts made to manage the subprogrammes more effectively in response to changing demands.
- 20.3 In line with the general orientation and thrust of the biennial programme plan and priorities for the period 2006-2007, and taking into account the relevant provisions of the internationally agreed development goals contained in the United Nations Millennium Declaration, in its resolution 607 (XXX) (Puerto Rico, June-July, 2004), the Commission adopted its biennial programme of work. In the resolution, the Commission endorsed the proposed priorities of the work programme of the Commission for the biennium 2006-2007 presented below:
- (a) The promotion of a broader vision of macroeconomic stability to fuel growth and reduce volatility;
 - (b) Integration into the rest of the world and the importance of regional affairs;
 - (c) An increase in the region's productive potential;
 - (d) An increase in social cohesion;
 - (e) Improvements in global institutions and the importance of migration, sustainable development and financing for development.
- 20.4 As an integral part of these efforts and in collaboration with other agencies in the relevant fields, ECLAC intends to continue to follow up directly the regional dimensions of the outcome of the world summits on sustainable development, social development, women, population and development, ageing, human settlements, small island developing States, financing for development, and the information society, through preparation of reports, participation in meetings and technical and substantive support. As part of this process, the Commission will continue to develop and improve the common system and database for the regional follow-up of all United Nations conferences, including the internationally agreed development goals of the Millennium Declaration.
- 20.5 ECLAC continues to participate in the Economic Commissions-Economic and Social Affairs clusters under the leadership of the Department of Economic and Social Affairs, which is a useful tool in ensuring that the programmes of work of participating United Nations entities in the various economic and social sectors are duly harmonized and consistent. Notably, it was not only a window of opportunity to avoid duplications, but most importantly to identify potential synergies, and instances of collaboration at the stage of budget implementation.
- 20.6 The expected accomplishments and indicators of achievement for ECLAC in the biennium 2006-2007 are detailed, together with resources, under executive direction and management and the programme of work. The overall framework of these expected accomplishments and indicators of achievement is shown in table 20.1.

- 20.7 The issue of publications as part of the programme of work has been reviewed in the context of each subprogramme. It is anticipated that recurrent and non-recurrent publications will be issued as shown in summary, below in table 20.2 and as distributed in the output information for each subprogramme.

- 20.8 The overall resources required for the biennium 2006-2007 for this section amount to \$85,697,900 before recosting, reflecting an increase of \$326,500 (or 0.4 per cent). The growth in table 20.4 can be summarized as follows:
- (a) The decrease of \$31,600 under policymaking organs relates to reduced requirements for other staff costs based on expenditure patterns;
 - (b) The net increase of \$13,100 under executive direction and management for non-post requirements relates to assessments to be conducted on orientations and relevance of the main research line and publication programme of ECLAC and the programme of technical cooperation;
 - (c) The net increase of \$1,017,700 under programme of work reflects the overall strengthening of the subprogrammes as highlighted in the biennial programme plan for the biennium 2006-

2007, which was emphasized in resolution 607 (XXX) adopted at the thirtieth session of the Commission, as follows:

- (i) An increase of \$516,300 under subprogramme 1, comprising \$497,300 for posts, is related to the inward redeployment of a P-3 and 3 Local level posts and \$19,000 for non-posts for consultants and experts;
- (ii) A net decrease of \$120,700 under subprogramme 2, comprising \$90,700 for posts and \$30,000 for non-post requirements, is related to the abolition of one Local level post, the functions of which will be subsumed by the remaining posts, as well as reduced requirements for travel and consultants and experts, reflecting expenditure patterns, offset in part by increased requirements for general temporary assistance;
- (iii) An increase of \$695,700 under subprogramme 3 relates largely to post requirements (\$686,700) for two new posts, one at the P-4 level and the other at the P-2 level, inward redeployment of two P-4 posts, one from subprogramme 6 and one from subprogramme 11, offset by the outward redeployment of one P-5 post to subprogramme 8. The post changes are aimed at strengthening the work on, inter alia, systematic analysis, quantitative modelling of public expenditure and follow-up on the progress made in attaining the Millennium Development Goals. Increased requirements for consultants and experts (\$10,200) are offset slightly by reduced requirements for travel of staff (\$1,200);
- (iv) An increase of \$109,800 under subprogramme 4, comprising \$92,800 for posts and \$17,000 for non-post requirements, relates to the establishment of one new P-2 Associate Social Affairs Officer post to strengthen the substantive capacity of the subprogramme in critical areas of concern related to socio-economic issues, social development, etc. The increase in non-post resources relates to specialized expertise under consultants and experts not available in-house;
- (v) A net decrease of \$36,000 under subprogramme 6, comprising \$43,100 for posts offset partly by an increase of \$7,100 for non-post requirements. Post changes relate to the establishment of one P-2 post and one P-3 post to strengthen the subprogramme as it relates to analysis of population trends, demographics, social and economic causes and implications, etc., offset by the outward redeployment of a P-4 post to subprogramme 3. The increase in non-post resources relates to specialized expertise under consultants and experts not available in-house;
- (vi) A net increase of \$19,600 under subprogramme 7 for non-posts requirements relates to consultants and experts, and travel of staff, offset slightly by reduced requirements for general temporary assistance;
- (vii) An increase of \$479,600 under subprogramme 8 for posts arises from the full funding of one P-2 post established in the biennium 2004-2005, one new P-2 post proposed for 2006-2007 and inward redeployment of one P-5 post from subprogramme 3, in an effort to enhance the substantive capacity of the subprogramme;
- (viii) A decrease of \$453,500 under subprogramme 9 for posts relates to the outward redeployment of three Local level posts from the former Transport Unit to subprogramme 1 to support research in the field of trade facilitation, and abolition of 2 Local level posts as their functions are being subsumed by existing posts;
- (ix) A decrease of \$335,500 under subprogramme 10 relates largely to post changes as follows: outward redeployment of one P-3 post to subprogramme 1 to strengthen the substantive capacity of the subprogramme; and abolition of one Local level clerical post

as its functions are being subsumed by other posts in the subprogramme. For non-post requirements, decreases relate to general temporary assistance and consultants;

- (x) A net decrease of \$45,500 under subprogramme 11 relates mainly to the full funding of one P-4 post established in the biennium 2004-2005 and the establishment of one new P-2 post to strengthen capacity in the area of economic development and growth, offset by the outward redeployment of one P-4 post to subprogramme 3;
- (xi) An increase of \$187,900 under subprogramme 12 relates mainly to post changes (\$180,200) as a result of the inward redeployment of one P-2 post from programme support to strengthen the substantive capacity of the subprogramme. For non-post requirements, increases relate to general temporary assistance and travel of staff;
- (d) A net decrease of \$672,700 under programme support, which includes a reduction of \$977,000 for posts offset in part by increases of \$304,300 for non-post requirements. The post changes relate to the outward redeployment of one P-4 post to subprogramme 3 and one P-2 post to subprogramme 12 to strengthen these subprogrammes; and the abolition of six Local level posts, as the functions in the central support areas will be consolidated. Increased requirements under non-post requirements relate to contractual services, general operating expenses and furniture and equipment offset in part by reduced requirements for other staff costs, consultants and experts, travel of staff and supplies and materials.

20.9 In the area of mobilization of extrabudgetary resources and management of technical cooperation projects, three significant factors are highlighted as impacting the revised estimates for the biennium 2004-2005 and the projections for the biennium 2006-2007. The first is the positive evolution of the long-established relationship of ECLAC with some bilateral donors, which have adopted the modality of financing integrated programmes rather than individual projects. The second is the strengthened and deepened relationship with the Commission of the European Communities, which has become one of the Commission's most important contributors and partners in the provision of technical cooperation services to its stakeholders. The third factor relates to the increased participation of private foundations and non-governmental organizations in the implementation of ECLAC extrabudgetary activities, both as contributors and partners.

20.10 The projected extrabudgetary resources of \$19,285,400 for the biennium 2006-2007 will supplement provisions from the regular budget to finance activities such as applied research, advisory services, group training and workshops. Notwithstanding the comments reflected in paragraph 20.9 above, at present the estimates for the biennium 2006-2007 reflect a conservative approach to the calculation of extrabudgetary resources, as the estimates include only those projects for which firm commitments or preliminary indications from prospective donors have been received.

20.11 Pursuant to General Assembly resolution 58/269 of 23 December 2003, the submission incorporates for the first time evaluation plans for all ECLAC substantive subprogrammes, as well as for the executive direction and management, which is intended to cover all components of the programme support area. Resources identified under the regular budget for the conduct of evaluations would amount to \$1,444,600. This is estimated on the basis of 106.6 work-months at the Professional and above category (\$1,163,700) and 67.9 work-months at other categories (\$278,400), as well as requirements estimated for consultant services in the amount of \$2,500. Extrabudgetary resources totalling \$231,700, which is dependant on receipt of such funding, are estimated at 7.5 work-months at the Professional and above category (\$74,300) and 34.0 work-months at other categories (\$139,400), as well as requirements for consultants (\$16,500) and training (\$1,500).

- 20.12 The estimated percentage distribution of the resources for ECLAC in the biennium 2006-2007 is as follows:

A. Policymaking organs

Resource requirements (before recosting): \$1,183,100

Economic Commission for Latin America and the Caribbean

- 20.13 The terms of reference of ECLAC were established by the Economic and Social Council in its resolution 106 (VI) of 25 February and 5 March 1948 and subsequent amendments. The Commission is composed of 41 members and 7 associate members and holds biennial sessions during even-numbered years for five days, to review the work of the secretariat and approve its biennial programme of work. The biennial session has two ad hoc committees, one on technical cooperation among developing countries and regions, and the other on population and development, meeting on sustainable development. The thirty-first session of ECLAC will be held in Santiago in the first half of 2006.

Committee of the Whole

- 20.14 The Committee of the Whole was established in 1952. It normally meets at United Nations Headquarters, in New York, with permanent representatives of ECLAC, member States, if and when required, during the years in which the Commission does not hold a biennial session. The plenary of the Committee of the Whole is expected to meet in New York for three days during the biennium 2006-2007, to hold discussions on issues of concern to the Commission.

Presiding Officers of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean and Tenth Regional Conference on Women

- 20.15 The Presiding Officers provide overall direction to the work of the Secretariat on issues related to the integration of women into development in the region, in accordance with paragraph 88.2 of the Regional Plan of Action on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean. The Presiding Officers will meet on three occasions in the coming biennium: twice in 2006 and once in 2007.
- 20.16 The Regional Conference on the Integration of Women into the Economic and Social Development of Latin America was established as a permanent subsidiary body of ECLAC at the eleventh extraordinary session of the ECLAC Committee of the Whole, held on 21 November 1977. At that session, ECLAC approved the Regional Action Plan for the Integration of Women into the Latin American Economic and Social Development, adopted in Havana in 1977. The purposes of the Conference are to identify women's needs at the regional and subregional levels, present recommendations, undertake periodic assessments of the activities carried out in fulfilment of regional and international plans and agreements on the subject, and serve as a forum for debates on relevant issues. Its sessions are held every three years and is expected to meet in 2007.

Committee of High-Level Governmental Experts

- 20.17 The Committee of High-Level Governmental Experts was established on 7 May 1971. It is a subsidiary organ of the Commission and acts as a forum devoted to the analysis of various aspects

of the implementation and appraisal of development strategies in Latin America and the Caribbean. In the past it has dealt with industrialization and science and technology issues, although recently its main focus has been on population matters. It meets, if and when required, annually. The Committee is scheduled to meet in New York in 2006 and 2007.

Caribbean Development and Cooperation Committee

- 20.18 The Caribbean Development and Cooperation Committee was established in 1975. It coordinates economic and social development cooperation and addresses other development concerns of the Caribbean members of ECLAC. It also serves as an advisory and consultative body to the Executive Secretary of ECLAC on issues concerning the Caribbean. The Committee will meet annually in the biennium 2006-2007.

Committee on Central American Economic Cooperation

- 20.19 The Committee on Central American Economic Cooperation was established in 1952. It provides overall coordination and direction to the secretariat in relation to activities to promote the integration of national economies in Central America. It also serves as an advisory and consultative body to the Executive Secretary of ECLAC on issues related to the Central American region and as a subsidiary organ of the Commission. The Committee will meet annually during the biennium 2006-2007.

Regional Council for Planning and Presiding Officers of the Regional Council for Planning, Latin American and Caribbean Institute for Economic and Social Planning

- 20.20 The Regional Council for Planning, Latin American and the Caribbean Institute for Economic and Social Planning (ILPES), consisting of 40 member Governments, was established in 1974. It is the principal intergovernmental body of the Caribbean Institute for Economic and Social Planning (ILPES) and meets every four years. The twelfth meeting of the Council was held on 6 November 2002 in Madrid. It is expected to meet once during the 2006-2007 biennium.
- 20.21 The Presiding Officers of the Regional Council for Planning, consisting of 11 member Governments, examines the work programme for ILPES and evaluates its past activities. It meets at least once a year. The Presiding Officers are expected to meet in 2006 and 2007.

Executive Committee of the Statistical Conference of the Americas

- 20.22 The Executive Committee of the Statistical Conference of the Americas was established at the same time as the Statistical Conference of the Americas during the twenty-eighth session of the Commission (see resolution 580 (XXVIII)). It meets annually to provide support for the Statistical Conference of the Americas. The main responsibilities of the Executive Committee are: to prepare a biennial programme of regional and international cooperation concerning statistical matters to be presented to the regular conference; to follow up on the implementation of the agreements and the tasks assigned by the Conference; and to decide on the substantive documentation to be presented to the Conference.

- 20.23 The next meetings of the Executive Committee as mandated by ECLAC resolution 580 (XXVIII) will be in Mexico City in 2006 and in Brasilia in 2007.

Statistical Conference of the Americas

- 20.24 The Statistical Conference of the Americas was approved as a subsidiary organ of the Commission at the twenty-eighth session of ECLAC (resolution 580 (XXVIII)).
- 20.25 The Conference meets on a biennial basis in odd years with the objectives of promoting the development and improvement of national statistics and their international comparability, strengthening cooperation among national statistical offices and international and regional agencies, and preparing a biennial programme of regional and international cooperation to meet the demands of the countries of the region in the field of statistics. The next meeting of the Conference will be held in Santiago in 2007.

- 20.26 The amount of \$1,183,100, for policymaking organs, including a decrease of \$31,600, provides for the servicing of the meetings of ECLAC intergovernmental bodies. The decrease relates to reduced requirements for temporary assistance for meetings (\$21,500), general temporary assistance (\$3,200), overtime (\$1,800), external translation (\$1,600), miscellaneous services (\$1,100), supplies and materials (\$1,600) and hospitality (\$800).

B. Executive direction and management

Resource requirements (before recosting): \$5,384,200

- 20.27 The Office of the Executive Secretary provides overall direction, supervision and management to the ECLAC secretariat, with a view to implementing the legislative mandates and the approved programme of work. It continues to be responsible for the preparation of a biennial institutional substantive report on the main topics to be discussed at the session of the Commission, as well as for the publication of the *CEPAL Review*.
- 20.28 In addition, the Office will provide direction and policy orientation and continue with the establishment of the criteria to coordinate the implementation of and follow-up to the Millennium Development Goals and other cross-cutting issues, such as gender mainstreaming and sustainable development, throughout the substantive subprogrammes.

- 20.29 The Programme Planning and Operations Division, on behalf of the Executive Secretary, will continue to provide advice, overall substantive coordination and guidance to ECLAC subprogramme managers on the formulation of the proposed biennial programme plan and priorities of ECLAC, the preparation of the draft programme of work and the report of the work of the Commission for presentation to and adoption by the biennial session of the Commission, as well as the preparation of the programme budget proposals for the biennium and the subsequent budget performance reports.
- 20.30 The Division will also undertake the substantive monitoring of the implementation of the work programme and the preparation of the biennial programme performance report. Similarly, it will organize, coordinate and report on the evaluation plan of ECLAC. In addition, the Division will continue to provide substantive servicing to and prepare relevant documentation for the meetings of the Ad Hoc Working Group and the Committee of the Whole established pursuant to ECLAC resolution 553 (XXVI) with the purpose of carrying out priority-setting exercises for the programme of work and provide strategic guidance to the Commission on institutional and policy issues. The Division will also continue coordination, development, updating and maintenance operations of the ECLAC official website and subsites; the coordination, guidance and supervision of the ECLAC extrabudgetary technical cooperation programme and its relevant fund-raising activities, and the work of the ECLAC, Santiago Library, for which resources are provided under subsection D, Programme support.
- 20.31 The Office of the Executive Secretary includes the Information Services Unit. The activities of the Unit are carried out in Santiago in close coordination with the Department of Public Information at Headquarters and include: organizing press conferences and issuing press releases; producing and disseminating booklets and information kits about the work of ECLAC and the United Nations; placing opinion pieces in the region's media; producing and editing a bimonthly newsletter and attending to journalists and the general public.

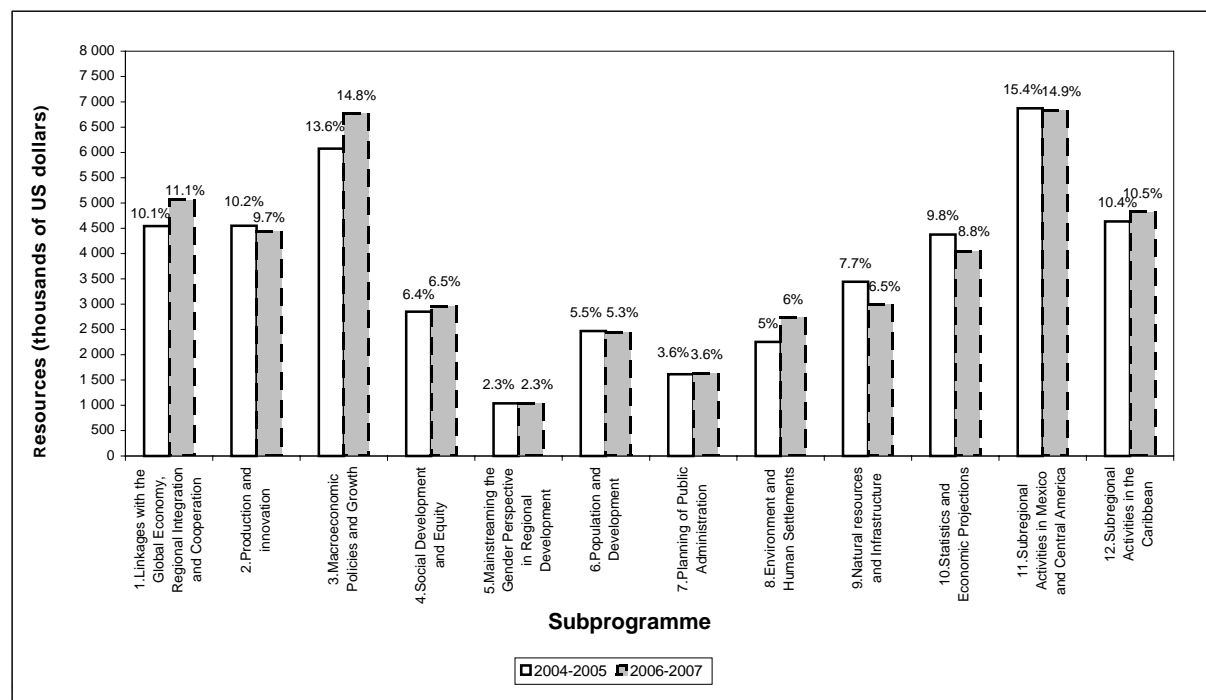

- 20.38 The amount of \$4,838,200 for posts includes an increase of \$497,300 resulting from the following:
- (a) the inward redeployment of one P-3 post from subprogramme 10 to strengthen the substantive

capacity of the subprogramme to implement designated high-priority work programme outputs; and (b) inward redeployment of three Local level posts from subprogramme 9 to enhance the support capabilities for research in the subprogramme, particularly in the area of trade facilitation. The non-post requirements of \$221,100 are required for other staff costs (\$31,700), consultants and experts (\$104,200) and travel of staff (\$85,200). The increase of \$19,000, results from additional requirements for consultants (\$13,000) and experts (\$6,000).

Production and innovation

- 20.39 This subprogramme is carried out by the Division of Production, Productivity and Management, with close collaboration from the ECLAC office in Brasilia. The programme of work has been formulated by drawing upon subprogramme 2 of programme 17 of the biennial programme plan and priorities for the period 2006-2007.
- 20.40 The subprogramme's activities will be directly linked to the relevant provisions of the internationally agreed development goals of the Millennium Declaration, particularly Goal 8: Develop a global partnership for development, target 12, specifically with respect to good governance of public policies, that is, their efficiency, accountability and transparency, and target 18, regarding the dissemination of the benefits of new technologies, especially with respect to information and communications. The subprogramme will develop lines of research and offer policy recommendations to regional stakeholders concerning three main subject areas: (a) recent changes in the region's production structure; (b) behaviour of the main economic agents in the region (enterprises of different types and sizes); and (c) performance assessment of those economic actors, particularly with respect to innovation and knowledge.

- 20.43 The amount of \$4,218,100 provides for 20 posts and includes a decrease of \$90,700 reflecting the abolition of one clerical Local level post as the functions are to be rationalized and subsumed in other posts of a similar nature in ECLAC. The amount of \$210,400 for non-post requirements provides for other staff costs (\$51,600), consultants and experts (\$93,000) and travel of staff (\$65,800). It includes a net increase of \$30,000 resulting from additional requirements for general temporary assistance offset by reductions under consultants and experts and travel of staff.

- 20.48 The amount of \$6,505,600 for posts reflects an increase of \$686,700, which is the net result of: (a) one new P-4 post, to strengthen the work on systematic analysis and quantitative modelling of public expenditure in the social sector of the countries of the region with a view to follow up on the trends and evolution of major policy reforms currently under way and assess their effectiveness; (b) one new P-2 post to collect, evaluate, interpret, analyse specific statistics and qualitative socio-economic information, inter alia, obtained from a variety of sources and pertaining to particular sectors, countries, regions or development topics; (c) the outward redeployment of one P-5 post to subprogramme 8, to strengthen the substantive capacity of the subprogramme to implement designated high-priority work programme outputs in the field of sustainable development; (d) the inward redeployment of one P-4 post from subprogramme 6 to assist in the preparation of traditional publications, organize technical and expert meetings of a regional scope, provide technical cooperation assistance related to macroeconomic issues of concern to policymakers and relevant authorities in the region; (e) the inward redeployment of one P-4 post from subprogramme 11, to enhance the capacities of the subprogramme to follow up on the progress made in attaining the Millennium Development Goals relevant to poverty reduction through sustainable growth and the evolution of the enabling macroeconomic policies at the country, subregional and regional levels, as well as to discharge functions with a high impact on the whole region related to the provision of support to the operations of the REDIMA network of macroeconomists as a unique coordinating forum; (f) the inward redeployment of one P-4 post from the Extrabudgetary Resource Mobilization Unit under programme support to the Brasilia office, to enhance the capacities of the national office to follow up on the economic and social evolution of the host countries, the coherence of its macroeconomic and social policies in order to attain the relevant Millennium Development Goals and to provide technical advice on major macroeconomic and financial issues, the latter closely related to the follow up and implementation

Social development and equity

Resource requirements (before recosting): \$2,962,300

- 20.50 The subprogramme will be carried out by the Social Development Division. The programme of work has been formulated by drawing upon subprogramme 4 of programme 17 of the biennial programme plan and priorities for the period 2006-2007.
- 20.51 The subprogramme covers four main subject areas, namely: (a) the formulation, management and evaluation of social policies, programmes and projects; (b) the assessment of the social situation of the population and vulnerable groups with emphasis on poverty and equity; (c) the analysis of changes in the socio-economic stratification in Latin America and the Caribbean and of the impact of economic reforms and structural adjustment on new forms of sociocultural integration and disintegration; and (d) the promotion and consolidation of first and second-generation human rights, which are essential for the construction of a climate of governance and democracy which promotes social development for the strengthening of social peace. In implementing the activities of the subprogramme, special account will be taken of the relevant provisions of the internationally agreed development goals of the Millennium Declaration, in particular Goal 1: Eradicate extreme poverty and hunger and Goal 2: Achieve universal primary education.

- 20.56 In implementing the activities of the subprogramme, special account will be taken of the relevant provisions of the internationally agreed development goals of the Millennium Declaration, in particular Goal 3: Promote gender equality and empower women.

- 20.61 The focus of the activities for the biennium will be on improving the generation of sociodemographic information and knowledge on population issues for use in social programming in the countries of the region. To this end, the subprogramme will develop lines of applied research and provide technical cooperation services to Governments and other relevant stakeholders in the region in four major areas: (a) demographic analysis and population projections; (b) population information; (c) incorporation of sociodemographic variables into development policies, programmes and projects; and (d) regional cooperation in population and development. In implementing the activities of the subprogramme, special account will be taken of the attainment of the internationally agreed development goals set forth in the Millennium Declaration, in particular Goal 1: Eradicate extreme poverty and hunger; Goal 4: Reduce child mortality, specifically on issues related to the incorporation of demographic variables in socio-economic programming; and Goal 5: Improve maternal health, especially on issues related to the improvement of reproductive health.

- 20.64 The amount of \$2,303,500 provides for 15 posts and reflects a reduction of \$43,100. The decrease results from: (a) establishment of one P-3 and one P-2 post to carry out, inter alia, analysis of population trends and their components, their demographic, social and economic causes and their social, economic and policy implications, offset by (b) the outward redeployment of one P-4 post to subprogramme 3, to reinforce the substantive capacity in that subprogramme. The non-post requirements of \$129,800 provide for other staff costs, consultants and experts, and travel of staff and include an increase of \$7,100 for consultants (\$4,400) and experts (\$2,700).

Subprogramme 7

Planning of public administration

Resources requirements (before recosting): \$1,632,900

- 20.65 The activities of this subprogramme will be carried out by ILPES. The programme of work has been formulated by drawing upon subprogramme 7 of programme 17 of the biennial programme plan and priorities for the period 2006-2007.
- 20.66 The focus of activities for the biennium will be on improving public sector management in the countries of the region with regard to planning, budgeting and local development. To this end, the subprogramme will develop lines of research and provide technical cooperation and training services to Governments and other relevant stakeholders in the region to build their technical capacities in two main subject areas, namely: (a) public sector budget policies and management, and (b) local development policies. In implementing the activities of the subprogramme, special account will be taken of the relevant provisions of the internationally agreed development goals of the Millennium Declaration, in particular Goal 8: Develop a global partnership for development, in particular the commitment to good governance, development and poverty reduction, both nationally and internationally.

- 20.69 The amount of \$1,537,500 at the maintenance level is proposed for posts. - 20.70 Activities under this subprogramme will be carried out by the Sustainable Development and Human Settlements Division. The programme of work has been formulated by drawing upon subprogramme 8 of programme 17 of the biennial programme plan and priorities for the period 2006-2007.
- 20.71 The activities for the biennium will focus on three areas: (a) assessment of the advance of sustainable development in the region; (b) follow-up to public policies and international and regional agreements on sustainable development; and (c) incorporation of sustainable development criteria in land-use development and human settlements. In implementing the activities of the subprogramme, special account will be taken of the relevant provisions of the internationally agreed goals of the Millennium Declaration, in particular Goal 7: Ensure environmental sustainability, especially target 9 regarding the integration of the principles of sustainable development into country policies and programmes, and target 11 relating to achieving a significant improvement in the lives of slum dwellers. The subprogramme will also focus on the follow up to the implementation of relevant international agreements, especially those adopted under the Habitat Agenda (Habitat II).

- 20.76 The focus of activities for the biennium will be on promoting the adoption of best practices related to sustainable management of natural resources and to widen the access of the population to public utility services. To this end, the subprogramme will develop research lines and provide technical cooperation services to regional stakeholders concerning two major subject areas, namely: (a) the sustainable management of natural resources and (b) provision and regulation of public utilities and infrastructure services. In implementing the activities of the subprogramme, special account will be taken of the relevant provisions of the internationally agreed development goals of the Millennium Declaration, in particular Goal 7: Ensure environmental sustainability, especially target 9 dealing with the integration of the principles of sustainable development into country policies and programmes, and target 10 on the reduction of the number of people without access to safe drinking water.

- 20.79 The amount of \$2,787,200 for posts includes a decrease of \$453,500 resulting from: (a) outward redeployment of three Local level posts to subprogramme 1 to enhance the support capabilities for research in the receiving subprogramme particularly in the area of trade facilitation. The work programme activities of the former thematic area of transport under this subprogramme have been redefined into a new thematic area of trade facilitation to respond to the changing demands of member States; and (b) abolition of two Local level clerical posts, the functions of which have been realigned and will be subsumed in other posts of a similar nature. The amount of \$202,200 at the maintenance level, for non-post requirements provides for general temporary assistance (\$54,100), consultants and experts (\$81,600) and for travel of staff (\$66,500).

Subprogramme 10

Statistics and economic projections

Resource requirements (before recosting): \$4,039,400

- 20.80 The work under this subprogramme will be carried out by the Statistics and Economic Projections Division. The programme of work has been formulated by drawing upon subprogramme 10 of programme 17 of the biennial programme plan and priorities for the period 2006-2007.
- 20.81 The focus of activities for the biennium will be on improving the capacity of ECLAC member States to compile and disseminate statistical information and indicators essential to the design and timely monitoring of economic and social development policies. The subprogramme comprises four major subject areas: (a) technical cooperation with member States and regional statistical bodies; (b) statistical databanks on Latin America and the Caribbean and dissemination of regional statistics and indicators; (c) economic statistics and the System of National Accounts; and (d) modelling and prospective analysis of the development process in the countries of Latin America and the Caribbean.
- 20.82 In implementing the activities of the subprogramme, special account will be taken of the relevant provisions of the internationally agreed development goals of the Millennium Declaration, in particular Goal 1: Eradicate extreme poverty and hunger, especially with regard to the estimation and use of social indicators relating to income distribution, poverty and employment characteristics of different social groups, with support from the Programme for the Improvement of Surveys of Living Conditions in Latin America and the Caribbean. The subprogramme will continue to strengthen the role of the Statistical Conference of the Americas of ECLAC, the intergovernmental body that sets cooperation priorities for statistical development in the region.

- 20.85 The amount of \$3,814,100 provides for 25 posts, reflecting a decrease of \$315,900. In implementing the activities of the subprogramme to achieve the expected results, special account will be taken of the relevant provisions of the internationally agreed goals of the Millennium Declaration, in particular Goal 1: Eradicate extreme poverty and hunger, Goal 3: Promote gender equality and empower women, Goal 7: Ensure environmental sustainability, and Goal 8: Develop a global partnership for development.

- 20.92 The activities will focus on the promotion of cooperation among ECLAC member and associate member countries in the Caribbean subregion in areas such as: (a) macroeconomic policies and economic development; (b) linkages with the international economy, integration and cooperation; (c) social development in the Caribbean; (d) statistics and information management for development; (e) sustainable development in the Caribbean; and (f) science and technology for development. In this context, priority will be attached to follow up on the outcome of the International Meeting to Review the Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, held in Mauritius in January 2005, and the new phases of the implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, including the formulation of national development strategies.
- 20.93 In implementing the activities of the subprogramme, special account will be taken of the relevant provisions of the internationally agreed goals of the Millennium Declaration, in particular Goal 1:

Eradicate extreme poverty and hunger, Goal 3: Promote gender equality and empower women, Goal 7: Ensure environmental sustainability and Goal 8: Develop a global partnership for development, especially target 14: address the special needs of landlocked countries and small island developing States.

Notes on the economies of the countries of the subregion (1); development and preparation of educational and training materials on water resources management, in conjunction with the Caribbean Water Partnership, for use in primary, secondary and tertiary education and by the general public (2); improvement and updating of the databases on sustainable development of the Caribbean small island developing States (2); preparation and distribution of information notes on selected trade issues of relevance to member States of the Caribbean Development Cooperation Committee in the context of current and future negotiations (2); regular updating and

- (v) Substantive servicing of inter-agency meetings: convening of separate meetings of the Inter-agency Collaborative Group, as appropriate (1); organization and convening of technical meetings of Caribbean small island developing States and meetings between them and the agencies of the Inter-agency Collaborative Group with responsibility, under their respective mandates, for the implementation of specific aspects of sustainable development in the subregion (1);
- (c) Technical cooperation (extrabudgetary):
 - (i) Advisory services: provision of advisory services to countries of the region, upon request, on issues relating to trade, investment, integration and subregional cooperation; provision of advisory services to countries of the subregion, upon request, in the areas of population and development, gender equity, social policies and social vulnerability; provision of advisory services to countries of the subregion, upon request, on information management and the organization of statistical services; provision of advisory services to countries of the subregion, upon request, on issues relating to new phases of the implementation of the Programme of Action for the Sustainable Development of Small Island Developing States, including the formulation of national development strategies, the conceptualization of approaches applicable to problem areas and the formulation of project proposals. especially officers of water resources management institutions and agencies, agriculture and sustainable development specialists, and staff of selected non-governmental agencies (4 workshops are estimated to be organized); organization and implementation of a data management workshop for public and private sector officials; organization of seminars and workshops, at the request of member States of the Caribbean Development Cooperation Committee, on various aspects of hemispheric and international trade in the context of advances with respect to hemispheric integration and new international trade regulations; subregional workshops for public sector officials on the use of the databases of economic statistics.

- 20.96 The amount of \$4,498,700 reflecting an increase of \$180,200 provides for 34 posts. The increase results from the inward redeployment of one P-2 post from the Project Management Unit intended to enhance the substantive capabilities of the subprogramme to implement designated high-priority work programme activities. The amount of \$322,900 for non-post requirements relates to: other staff costs (\$95,500); for consultants and experts (\$157,300); and for travel of staff (\$70,100). The increase of \$7,700 is mainly related to additional general temporary assistance for peak workload periods.

D. Programme support

Resource requirements (before recosting): \$33,393,400

- 20.97 The activities carried out under programme support comprise conference services, library services, management of technical cooperation activities and administration and common services.

Outputs

- 20.98 During the biennium 2006-2007 the following outputs will be delivered:

- (a) *Conference services.* The activities are carried out by the Documents and Publications Division in Santiago and the Editorial, Documents and Conference Services. The main activities relate to: (i) the provision of technical services to the meetings of policymaking organs of ECLAC and other intergovernmental meetings held under its auspices; (ii) the provision of

conference services to the meetings of policymaking organs of ECLAC and other intergovernmental meetings held under its auspices, including translation, interpretation, editing and verbatim reporting; (iii) the publications programme, distribution of ECLAC publications; and (iv) collaboration with the United Nations Sales Unit in the commercial distribution of United Nations publications;

- (b) *Library services.* Library services are provided to ECLAC staff members and external users by the libraries at Santiago and Mexico City. Activities include the publication of bulletins and bibliographies; the provision of services to remote users through the Internet; United Nations depository library in Chile; establishment of agreements and cooperation with other libraries in the subregion; dissemination of the substantive documentation of ECLAC; processing of external bibliographic resources and information in support of the substantive activities of the Commission in the subregion; disseminating the Micro-ISIS programme throughout the subregion and advising Libraries and information centres on its installation and operation; providing technical assistance and organizing courses on the use of Micro-ISIS; answering reference queries; publication of bulletins and bibliographies on paper and through electronic means; and updating daily the section of the ECLAC webpage pertaining to the Library;
- (c) *Management of technical cooperation activities.* The activities are carried out by the Project Management and the Extrabudgetary Resource Mobilization Units of the Programme Planning and Operations Division. The ECLAC technical cooperation programme is formulated to supplement the regular budget resource allocation. It is geared to strengthening and expanding the economic and social research agenda and to the application of research findings to the provision of advisory services and training for the benefit of ECLAC member States. It plays an active role in integrating substantive activities financed with extrabudgetary funds with those financed with the regular budget. It also aims at maintaining a mutually supporting balance between substantive research and operational activities. The anticipated outputs during the biennium are as follows:
 - (i) Publication of reports on the activities carried out by the ECLAC system to support and/or promote technical cooperation among developing countries at the regional, subregional and national levels; institutional arrangements for technical cooperation activities existing in developing member States of ECLAC; operational activities carried out in the region to promote interregional cooperation;
 - (ii) Advisory services to Governments and/or regional institutions in the identification and/or elaboration of technical cooperation programmes and project proposals, to be implemented at the regional, national or interregional level;
 - (iii) Coordination with the technical cooperation focal points in other regional commissions for the promotion of interregional cooperation activities;
 - (iv) Consultations with other regional organizations that carry out technical cooperation in Latin American and the Caribbean, to identify priorities to be included in the regional programme;

- (v) Collaboration with substantive units in the ECLAC system and subregional offices, for the preparation and implementation of projects to promote and support technical cooperation among developing countries components in the ECLAC programme of work;
- (vi) Assistance to Governments in the identification of technical and cooperation demands and opportunities and in the preparation of project proposals;
- (vii) Preparation of project agreements and proposals in accordance with the operational and financial rules and procedures established by the contributing organization, institution or government and by the United Nations;
- (viii) Preparation of budgets for extrabudgetary activities;
- (ix) Monitoring project implementation;
- (x) Administration of extrabudgetary funds in close collaboration with the substantive units responsible for the implementation of such projects;
- (d) *Administration and common services.* The main activities of the Division of Administration at ECLAC-Santiago are: (a) the overall management and coordination of administrative services, policy formulation and the establishment of managerial and administrative guidelines at ECLAC and overseeing administrative activities at two ECLAC subregional headquarters in Mexico City and Port of Spain and five national offices; (b) human resources management: recruitment, placement and career development of staff, staff administration and classification, maintenance of the classification system for General Service posts established under administrative instruction ST/AI/410, internship programme, medical and employee assistance, general advice and individual counselling; (c) budget formulation and control through preparation of biennial programme budgets and budget performance reports, budgeting and monitoring of approved budgets and staffing table control; (d) financial management and control through establishment of procedures for the control and maintenance of regular and extrabudgetary funds, implementation of financial regulation and rules and financial reporting and accounting, including treasury services; (e) general support services: including communications and transportation; procurement, facilities management and maintenance, archives and records management; (f) planning and coordinating the implementation and administration of IMIS in the ECLAC system; (g) language training at all ECLAC duty stations (excludes training activities funded centrally and directed by the Office of Human Resources Management); and (h) Electronic information activities carried out by the Electronic Information Section in consultation with the ECLAC Information Management Committee whose main activities are to advise the Executive Secretary on policy formulation for the automation processes at ECLAC, including the allocation of material and financial resources; provide technical advice and support services to substantive areas, ensuring the appropriate functioning of the ECLAC automation platform, including the website, Internet and IMIS services; supervise the maintenance services of ECLAC computer hardware and ensure the security of its information systems.

20.99 The amount of \$23,127,900 includes a decrease of \$977,000 which is the net result of: (a) the redeployment of one P-4 from the Extrabudgetary Resource Mobilization Unit to subprogramme 3; (b) the redeployment of one P-2 from the Project Management Unit to subprogramme 12; and (c) abolition of six Local level posts as follows: two posts in Document and Publications, Santiago, one post in Document and Publications, Mexico, one post in the Library and two posts in the General Services Section.

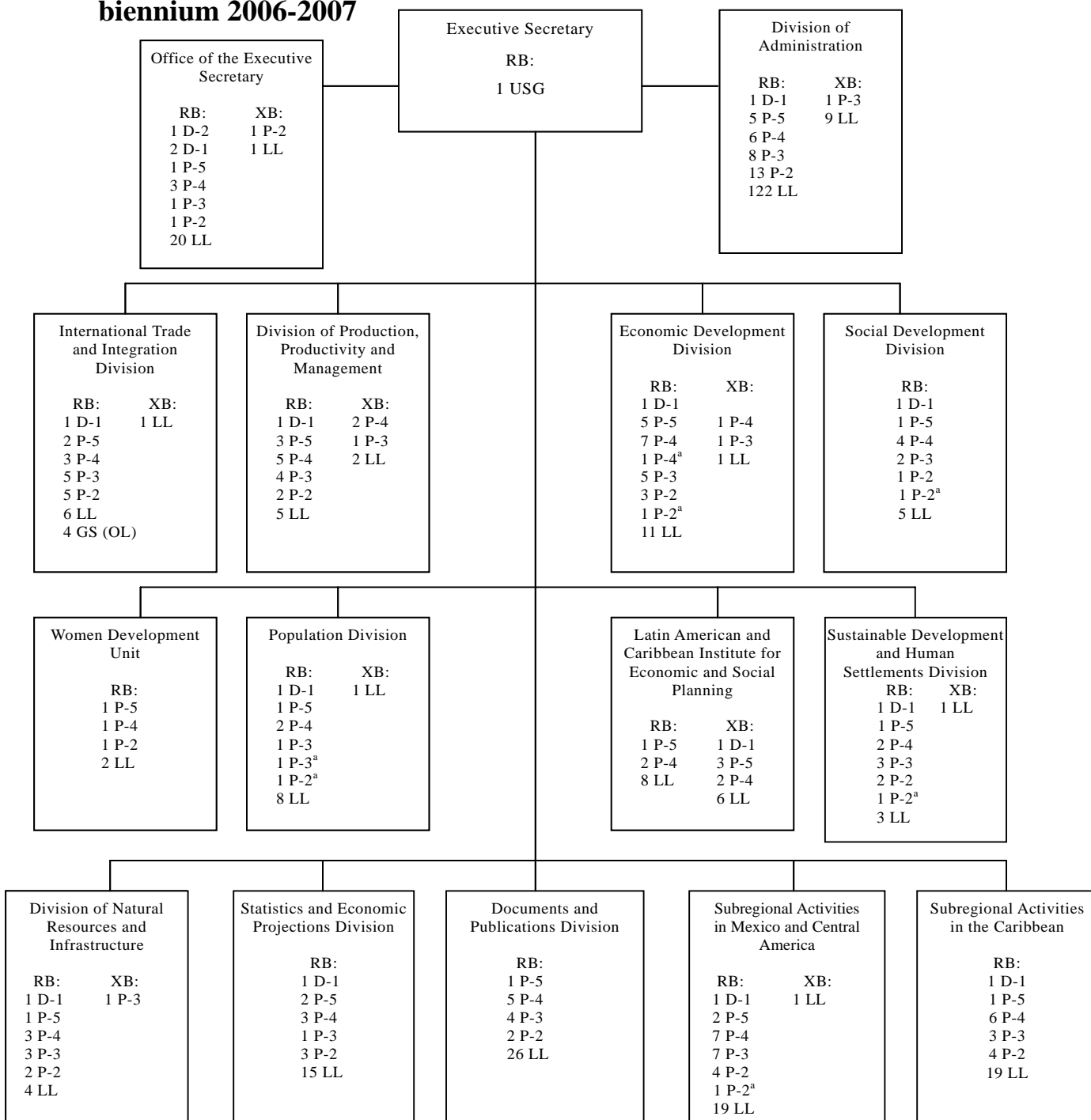
20.100 The amount of \$10,265,500 for non-post requirements include a net increase of \$304,300 for: (a) increases relating to: (i) contractual services (\$123,800); (ii) general operating expenses (\$110,800); and (iii) furniture and equipment (\$92,500); and (b) offset by decreases for: (i) other staff costs (\$11,900); (ii) consultants and experts (\$2,300); (iii) travel of staff (\$1,200); and (iv) supplies and materials (\$7,400). The increase under contractual services is largely related to external translation requirements and the purchase of new software and licences for the office in Santiago and the five national offices. As concerns the additional requirements under general operating expenses, this is related, inter alia, to the rental of premises, rental and maintenance of data-processing equipment and information technology help desk and communications costs with the increased use of videoconferencing services. The increase in requirements for furniture and equipment is related to the acquisition of office automation equipment.
