## Proposed programme budget for the biennium 2006-2007

### Report of the Fifth Committee

*Rapporteur:* Ms. Katja Pehrman (Finland)

#### I. Introduction

1. At its 17th plenary meeting, on 20 September 2005, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixtieth session the item entitled "Proposed programme budget for the biennium 2006-2007" and to allocate it to the Fifth Committee.

2. The Fifth Committee considered the item at its 12th to 16th, 21st, 23rd to 26th, 29th to 31st and 33rd to 36th meetings, on 25 to 28 and 31 October, 8, 14, 18, 21 and 22 November and 12, 14, 16, 19 to 21 and 23 December 2005. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/60/SR.12-16, 21, 23-26, 29-31 and 33-36).

3. 5. At its 36th meeting, on 23 December, in accordance with the guidelines for the use of the contingency fund (see the annex to General Assembly resolution 42/211 of 21 December 1987), the Committee considered a consolidated statement of programme budget implications and revised estimates that were subject to the criteria for the use of the contingency fund (A/C.5/60/25) and the related report of the Advisory Committee (A/60/7/Add.31). After due consideration, the Committee decided to recommend a change in respect of the programme budget implications relating to assistance to survivors of the 1994 genocide in Rwanda, particularly orphans, widows and victims of sexual violence (A/C.5/60/L.22 sect. F, and A/60/7/Add.26). Accordingly, the Committee decided to recommend revised estimates totalling \$22,234,000 in respect of charges to the contingency fund (see A/C.5/60/SR.36).

6. The table below summarizes the recommendations of the Fifth Committee for each section of the proposed programme budget for the biennium 2006-2007. The recommendations are based on the proposals of the Secretary-General,<sup>1</sup> the recommendations of the Advisory Committee on Administrative and Budgetary Questions thereon,<sup>2</sup> revised estimates submitted by the Secretary-General and the appropriations required for the implementation of resolutions adopted by the General Assembly at its current session.

## **II. Consideration of proposals on the proposed programme budget for the biennium 2006-2007**

### **A. Draft resolution A/C.5/60/L.25**

7. At its 36th meeting, on 23 December, the Committee had before it draft resolution A/C.5/60/L.25, entitled “Questions relating to the proposed programme budget for the biennium 2006-2007”, submitted by the Chairman following informal consultations.

8. At the same meeting, the Committee adopted draft resolution A/C.5/60/L.25 without a vote (see para. 56, draft resolution I).

9. After the adoption of the draft resolution, a statement was made by the representative of the Syrian Arab Republic in explanation of position (see A/C.5/60/SR.36).

### **B. Draft resolution A/C.5/60/L.26**

10. At its 36th meeting, on 23 December, the Committee had before it draft resolution A/C.5/60/L.26, entitled “Programme budget for the biennium 2006-2007”, submitted by the Chairman following informal consultations.

11. At the same meeting, the Committee adopted draft resolution A/C.5/60/L.26 without a vote (see para. 56, draft resolution II).

12. In the draft resolution the Committee recommended a gross appropriation of \$3,798,912,500 (draft resolution II A) and an estimate for income (other than income derived from staff assessment) of \$25,620,400 (draft resolution II B). The net expenditure for the biennium 2006-2007 is thus estimated at \$3,773,292,100. The financing of the requirements is dealt with in draft resolution II C.

13. In draft resolution II B, the Committee also recommended an estimate of \$401,734,800 as staff assessment for transfer in the course of the biennium 2006-2007 to the Tax Equalization Fund, from which credits are distributed to Member States in accordance with General Assembly resolution 973 (X) of 15 December 1955.

### **C. Draft resolution A/C.5/60/L.12**

14. At its 36th meeting, on 23 December, the Committee had before it draft resolution A/C.5/60/L.12, entitled “Unforeseen and extraordinary expenses for the biennium 2006-2007”, submitted by the Chairman following informal consultations.

15. At the same meeting, the Committee adopted draft resolution A/C.5/60/L.12 without a vote (see para. 56, draft resolution IV).

**D. Draft resolution A/C.5/60/L.13**

16. At its 36th meeting, on 23 December, the Committee had before it draft resolution A/C.5/60/L.13, entitled “Working Capital Fund for the biennium 2006-2007”, submitted by the Chairman following informal consultations.

17. At the same meeting, the Committee adopted draft resolution A/C.5/60/L.13 without a vote (see para. 56, draft resolution V).

18. In the draft resolution, the Committee recommends that the Working Capital Fund be established at the level of \$100 million.

**III. Consideration of proposals on special subjects relating to the proposed programme budget for the biennium 2006-2007**

19. At its 36th meeting on 23 December, the Committee had before it draft resolution A/C.5/60/L.27, entitled “Special subjects relating to the proposed programme budget for the biennium 2006-2007”, submitted by the Chairman following informal consultations.

**A. International Trade Centre UNCTAD/WTO**

20. The Committee considered this question at its 33rd and 36th meetings, on 19 and 23 December (see A/C.5/60/SR.33 and 36).

21. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly approve resources in the amount of \$26,732,000 (at the exchange rate of SwF 1.27 to US\$ 1) proposed for the biennium 2006-2007 under section 13, International Trade Centre UNCTAD/WTO, of the proposed programme budget for the biennium 2006-2007 (see para. 56, draft resolution III, sect. I).

**B. Capital master plan**

22. The Committee considered this question at its 29th and 36th meetings, on 12 and 23 December (see A/C.5/60/SR.29 and 36).

23. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Recognize the urgent need to continue the implementation of the design and pre-construction phases of the capital master plan;

(b) Authorize the Secretary-General to proceed with design work, related project management and management of pre-construction services to the extent that those activities can be implemented without prejudice to the decision to be taken by the Assembly at a later stage regarding its selection of the strategy for implementation of the capital master plan;

(c) Decide to convert \$8,198,000 of the existing commitment authority into an appropriation with assessment for the year 2006 so as to provide for the



continuation of design work and related project management and management of the pre-construction phase, including swing space requirements, as a minimum amount that would be required for capital master plan implementation during the first four months of 2006, irrespective of the strategy for the capital master plan to be endorsed by the General Assembly at a later stage;

(d) Also decide to revert, as a matter of priority, to the issue of the capital master plan at the first part of its resumed sixtieth session, in March 2006 (see para. 56, draft resolution III, sect. II).

### **C. Administrative expenses of the United Nations Joint Staff Pension Fund**

24. The Committee considered this question at its 23rd, 24th, 33rd and 36th meetings, on 14 and 18 November and 19 and 23 December (see A/C.5/60/SR.23, 24, 33 and 36).

25. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Concur with the recommendations contained in the reports of the Advisory Committee on Administrative and Budgetary Questions on the administrative expenses of the United Nations Joint Staff Pension Fund and on the administrative and financial implications arising from the report of the Standing Committee of the United Nations Joint Staff Pension Board;

(b) Approve expenses, chargeable directly to the Fund, totalling \$91,722,700 net for the biennium 2006-2007 and a revised estimate of \$89,563,100 net for the biennium 2004-2005 for the administration of the Fund;

(c) Also approve an additional amount of \$1,079,000 above the level of resources set out in section 1, Overall policymaking, direction and coordination, of the proposed programme budget for the biennium 2006-2007 as the United Nations share of the cost of the administrative expenses of the central secretariat of the Fund;

(d) Authorize the United Nations Joint Staff Pension Board to supplement the voluntary contributions to the Emergency Fund for the biennium 2006-2007 by an amount not exceeding \$200,000 (see para. 56, draft resolution III, sect. III).

### **D. Subvention requested by the United Nations Institute for Disarmament Research**

26. The Committee considered this question at its 23rd and 36th meetings, on 14 November and 23 December (see A/C.5/60/SR.23 and 36).

27. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Take note of the report of the Secretary-General on the request for a subvention to the United Nations Institute for Disarmament Research resulting from the recommendations of the Board of Trustees of the Institute on the work

programme of the Institute for 2006-2007 and the related report of the Advisory Committee on Administrative and Budgetary Questions;

(b) Endorse the proposal that the request for a subvention to the Institute be submitted for review and approval by the General Assembly on a biennial basis in the context of its consideration of the proposed programme budget for the related biennium;

(c) Approve the request for a subvention to the Institute of \$468,100 for the biennium 2006-2007 from the regular budget of the United Nations, on the understanding that no additional provision would be required under section 4, Disarmament, of the proposed programme budget for the biennium 2006-2007 (see para. 56, draft resolution III, sect. IV).

**E. Revised estimates resulting from resolutions and decisions adopted by the Economic and Social Council at its resumed organizational and first substantive sessions of 2005**

28. The Committee considered this question at its 23rd and 36th meetings, on 14 November and 23 December (see A/C.5/60/SR.23 and 36).

29. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly take note of the report of the Secretary-General and endorse the observations and recommendations of the Advisory Committee on Administrative and Budgetary Questions contained in its report (see para. 56, draft resolution III, sect. V).

**F. Estimates in respect of special political missions, good offices and other political initiatives authorized by the General Assembly and/or the Security Council**

30. The Committee considered this question at its 33rd and 36th meetings, on 19 and 23 December (see A/C.5/60/SR.33 and 36).

31. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Take note of the report of the Secretary-General and endorse the observations and recommendations of the Advisory Committee contained in its report;

(b) Approve for the 26 missions dealt with in the report of the Secretary-General the charge of \$100 million against the provision for special political missions requested under section 3, Political affairs, of the proposed programme budget for the biennium 2006-2007;

(c) Decide to resume at the first part of its resumed sixtieth session its consideration of the report of the Secretary-General on the estimates in respect of special political missions, good offices and other political initiatives authorized by the General Assembly and/or the Security Council;

(d) Note that an unallocated balance of \$255,949,300 would remain against the provision of \$355,949,300 for special political missions under section 3,

Political affairs, of the proposed programme budget for the biennium 2006-2007 (see para. 56, draft resolution III, sect. VI).

#### **G. Construction of additional office facilities at the Economic Commission for Africa in Addis Ababa**

32. The Committee considered this question at its 33rd and 36th meetings, on 19 and 23 December (see A/C.5/60/SR.33 and 36).

33. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly take note of the report of the Secretary-General and endorse the related recommendations of the Advisory Committee on Administrative and Budgetary Questions contained in its report (see para. 56, draft resolution III, sect. VII).

#### **H. Possibility of operating guided tours, bookstores and gift shops at the United Nations Office at Nairobi and the cost implications thereof**

34. The Committee considered this question at its 23rd, 24th and 36th meetings, on 14 and 18 November and 23 December (see A/C.5/60/SR.23, 24 and 36).

35. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly request the Secretary-General to organize, effective 1 January 2006, a guided tour operation at the United Nations Office at Nairobi, and in that context also request him to report the actual income and expenditures of the guided tour operation at the United Nations Office at Nairobi in the budget performance reports for the biennium 2006-2007 under income section 3, Services to the public (see para. 56, draft resolution III, sect. VIII).

#### **I. Efforts of the Economic and Social Commission for Asia and the Pacific in rationalization of monitoring and evaluation**

36. The Committee considered this question at its 36th meeting, on 23 December (see A/C.5/60/SR.36).

37. At the same meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Welcome the efforts of the Economic and Social Commission for Asia and the Pacific in rationalization of monitoring and evaluation in accordance with General Assembly resolution 58/269 of 23 December 2003, especially in carrying out self-evaluation activities in a systematic and comprehensive manner;

(b) Request the Commission, in that regard, to report on its activities in this area in the proposed programme budget for the biennium 2008-2009 (see para. 56, draft resolution III, sect. IX).

**J. Workplan on reform of the Economic Commission for Europe**

38. The Committee considered this question at its 36th meeting, on 23 December (see A/C.5/60/SR.36).

39. At the same meeting the Committee decided, without a vote, to recommend that the General Assembly welcome the workplan on reform of the Economic Commission for Europe adopted by the Commission in its decision of 2 December 2005, decide that the Commission should implement the measures outlined in its decision, and to that end request the Secretary-General to allocate the requisite resources under section 19, Economic development in Europe, of the proposed programme budget for the biennium 2006-2007 (see para. 56, draft resolution III, sect. X).

**K. Administrative and financial implications of the decisions and recommendations contained in the report of the International Civil Service Commission for 2005**

40. The Committee considered this question at its 9th, 10th and 36th meetings, on 20 and 21 October and 23 December (see A/C.5/60/SR.9, 10 and 36).

41. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Decide to approve the new scale of staff assessment recommended by the International Civil Service Commission in its report with effect from 1 January 2006;

(b) Also decide to revert to the other issues contained in the report of the Secretary-General at the first part of its resumed sixtieth session (see para. 56, draft resolution III, sect. XI).

**L. Financial viability of the United Nations Institute for Training and Research**

42. The Committee considered this question at its 15th and 36th meetings, on 28 October and 23 December (see A/C.5/60/SR.15 and 36).

43. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Take note of the report of the Secretary-General and of the related report of the Advisory Committee on Administrative and Budgetary Questions;

(b) Decide to provide the Institute with the amount of \$242,400, being the equivalent of the amount of rental, maintenance and other administrative costs associated with conducting the core training programme for the biennium 2006-2007;

(c) Reiterate that in order to ensure stability of the funding for the General Fund and the viability of repaying the United Nations its debt, the Institute should systematically charge 13 per cent of programme support costs to special purpose grants whenever possible (see para. 56, draft resolution III, sect. XII).

**M. Ethics office; comprehensive review of the governance arrangements including an independent external evaluation of the auditing and oversight systems; and the independent audit advisory committee**

44. The Committee considered this question at its 36th meeting on 23 December (see A/C.5/60/SR.36).

45. At the same meeting the Committee decided, without a vote, to recommend that the General Assembly:

(a) Take note of the reports of the Secretary-General and of the Advisory Committee on Administrative and Budgetary Questions;

(b) Recall its resolution 60/247 of 23 December 2005;

(c) Note that the approved resources would provide for the establishment of an ethics office and the undertaking of the evaluation study called for pursuant to paragraph 164 of General Assembly resolution 60/1 of 16 September 2005;

(d) Decide to establish the Independent Audit Advisory Committee to assist the General Assembly to discharge its oversight responsibilities and request the Secretary-General to propose its terms of reference, ensure coherence with the outcome of the ongoing review of oversight and report to the Assembly at the second part of its resumed sixtieth session on related resource requirements (see para. 56, draft resolution III, sect. XIII).

**N. Contingency fund**

46. The Committee considered this question at its 36th meeting, on 23 December (see A/C.5/60/SR.36).

47. At the same meeting the Committee decided, without a vote, to recommend that the General Assembly note that a balance of \$4,966,000 remains in the contingency fund (see para. 56, draft resolution III, sect. XIV).

**O. Effects of changes in rates of exchange and inflation**

48. The Committee considered this question at its 36th meeting, on 23 December (see A/C.5/60/SR.36).

49. At the same meeting the Committee decided, without a vote, to recommend that the General Assembly take note of the revised estimates arising from recosting due to the effects of changes in the rates of exchange and inflation (see para. 56, draft resolution III, sect. XV).

**P. Joint Inspection Unit**

50. The Committee considered this question at its 1st, 2nd and 36th meetings, on 10 and 11 October and 23 December (see A/C.5/60/SR.1, 2 and 36).

51. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly approve the gross budget for the Joint Inspection Unit for the biennium 2006-2007 in the amount of \$10,511,100 (see para. 56, draft resolution III, sect. XVI).

#### **Q. International Civil Service Commission**

52. The Committee considered this question at its 9th, 10th and 36th meetings, on 20 and 21 October and 23 December (see A/C.5/60/SR.9, 10 and 36).

53. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly approve the gross budget for the International Civil Service Commission for the biennium 2006-2007 in the amount of \$16,211,300 (see para. 56, draft resolution III, sect. XVII).

#### **R. Jointly financed gross budget of the Department of Safety and Security**

54. The Committee considered this question at its 25th, 26th and 36th meetings, on 21 and 22 November and 23 December (see A/C.5/60/SR.25, 26 and 36).

55. At its 36th meeting the Committee decided, without a vote, to recommend that the General Assembly approve the gross budget for the Department of Safety and Security for the biennium 2006-2007 in the amount of \$225,682,400, broken down as follows:

- (a) Field security operations: \$201,423,900;
- (b) Security and safety services at the United Nations Office at Vienna: \$24,258,500 (see para. 56, draft resolution III, sect. XVIII).

## IV. Recommendations of the Fifth Committee

56. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolutions:

### **Draft resolution I**

### **Questions relating to the proposed programme budget for the biennium 2006-2007**

*The General Assembly,*

*Recalling* its resolutions 41/213 of 19 December 1986, 42/211 of 21 December 1987, 45/248 B, section VI, of 21 December 1990, 56/253 of 24 December 2001, 58/269 and 58/270 of 23 December 2003 and 59/275, 59/276 and 59/278 of 23 December 2004, and paragraphs 161 to 167 of its resolution 60/1 of 16 September 2005,

*Reaffirming* the respective mandates of the Advisory Committee on Administrative and Budgetary Questions and the Committee for Programme and Coordination in the consideration of the proposed programme budget,

*Having considered* the proposed programme budget for the biennium 2006-2007,<sup>1</sup> as well as other reports<sup>2</sup> and programme budget implication statements<sup>3</sup> of the Secretary-General and the relevant reports of the Advisory Committee on Administrative and Budgetary Questions<sup>4</sup> and the Committee for Programme and Coordination<sup>5</sup> thereon,

1. *Reaffirms* that the Fifth Committee is the appropriate Main Committee of the General Assembly entrusted with responsibilities for administrative and budgetary matters;

2. *Also reaffirms* rule 153 of its rules of procedure;

3. *Endorses* the conclusions and recommendations of the Committee for Programme and Coordination as contained in paragraphs 61, 67 and 106 to 122 of its report;<sup>5</sup>

4. *Notes* that consideration of the programme narratives contained in the revised estimates<sup>6</sup> will follow consideration thereof by the Committee for Programme and Coordination no later than September 2006;

5. *Endorses*, subject to the provisions of the present resolution and without establishing a precedent, the recommendations of the Advisory Committee on Administrative and Budgetary Questions concerning posts and non-post resources as

contained in chapter II of its first report on the proposed programme budget for the biennium 2006-2007,<sup>7</sup> and the resource recommendations contained in its reports on revised estimates, including those on the 2005 World Summit Outcome,<sup>8</sup> and on statements of programme budget implications relating to decisions taken by the Main Committees of the General Assembly;

6. *Decides* that the staffing table for the biennium 2006-2007 shall be as set out in the annex to the present resolution;

7. *Also decides* to extend for the biennium 2006-2007 the experiment approved under paragraph 14 of General Assembly resolution 58/270, and requests the Secretary-General to report to the Assembly at its sixty-first session on the implementation of the experiment;

8. *Requests* the Secretary-General to utilize the arrangements referred to in paragraph 7 above to identify available posts to provide for the new post requests referred to in paragraphs IV.2, IV.28 and IV.29 of the first report of the Advisory Committee on Administrative and Budgetary Questions on the proposed programme budget for the biennium 2006-2007,<sup>7</sup> as well as in paragraph 5 of the second report of the Advisory Committee on the proposed programme budget for the biennium 2006-2007;<sup>9</sup>

9. *Recalls* its decision in paragraph 3 (b) of its resolution 59/313 of 12 September 2005, and endorses the proposals contained in paragraph 3 of the statement of the Secretary-General on the programme budget implications of the draft resolution entitled "A strengthened and revitalized General Assembly";<sup>10</sup>

10. *Decides* to provide resources at the level sought by the Secretary-General in his statement of programme budget implications arising in respect of the draft resolution relating to Rwanda outreach and its amendment;<sup>11</sup>

11. *Recognizes* the need for limited discretion in budgetary implementation for the Secretary-General within defined parameters to be agreed by the General Assembly along with clear accountability mechanisms to the Assembly for its use, on the basis of recommendations of the Secretary-General to be provided to the Assembly at its resumed sixtieth session;

12. *Requests* the Secretary-General to achieve further efficiencies in non-post resources, and therefore decides to adjust non-post provisions covered in paragraph 5 above by a pro rata reduction of 1.75 per cent to be applied to all sections of the programme budget;

13. *Recognizes* that amendments to the provisions of the present resolution would stem from any decisions by the General Assembly in accordance with established procedures in response to proposals of the Secretary-General relating to paragraphs 161 to 167 of its resolution 60/1;

14. *Decides* that the Development Account will be recosted for the biennium 2006-2007, and in this context requests the Secretary-General to pursue the relevant proposals contained in his report<sup>12</sup> and to provide to the General Assembly at its sixty-first session recommendations on how additional resources in the region of 5 million dollars could be added to the Development Account.

2. The Secretary-General shall be authorized to transfer credits between sections of the budget with the concurrence of the Advisory Committee on Administrative and Budgetary Questions;

3. The budget for the biennium 2006-2007 amounts to 3,799 million dollars. Expected expenditure in the course of 2006 is 1,899 million dollars. The two-year budget will permit a full assessment on all Member States for 2006, in accordance with Article 17 of the Charter of the United Nations. The Secretary-General, while adhering to the existing procedures regarding the annual assessment of Member States, is authorized to enter into expenditure of a first tranche, limited to 950 million dollars, as an exceptional measure. The General Assembly, in order to ensure the availability of resources for programme delivery, will act in response to a request from the Secretary-General, at an appropriate time, for expenditure of the remaining funds;

4. The total net provision made under the various sections of the budget for contractual printing shall be administered as a unit under the direction of the United Nations Publications Board;

5. In addition to the appropriations approved under paragraph 1 above, an amount of 75,000 dollars is appropriated for each year of the biennium 2006-2007 from the accumulated income of the Library Endowment Fund for the purchase of books, periodicals, maps and library equipment and for such other expenses of the library at the Palais des Nations in Geneva as are in accordance with the objects and provisions of the endowment.

## **B**

### **Income estimates for the biennium 2006-2007**

*Resolves that, for the biennium 2006-2007:*

1. Estimates of income other than assessments on Member States totalling 427,355,200 United States dollars are approved as follows:

Direct expenses of the United Nations Postal Administration, services to visitors, the sale of statistical products, catering operations and related services, garage operations, television services and the sale of publications not provided for under the budget appropriations shall be charged against the income derived from those activities.

## C

### Financing of appropriations for the year 2006

#### *The General Assembly*

*Resolves* that, for the year 2006:

1. Budget appropriations consisting of 1,899,456,250 United States dollars, being half of the appropriation of 3,798,912,500 dollars approved for the biennium 2006-2007 by the General Assembly in paragraph 1 of resolution A above, plus 47,626,700 dollars, being the increase in revised appropriations for the biennium 2004-2005 approved by the Assembly in its resolutions 59/282 of 13 April 2005, 59/294 of 22 June 2005, 60/244 of 23 December 2005 and 60/245 A of 23 December 2005, shall be financed in accordance with regulations 3.1 and 3.2 of the Financial Regulations of the United Nations,<sup>1</sup> as follows:

(a) 22,242,700 dollars, consisting of 12,810,200 dollars, being the net of half of the estimated income other than staff assessment approved for the biennium 2006-2007 under resolution B above, plus 9,432,500 dollars, being the increase in income other than staff assessment for the biennium 2004-2005;

(b) 1,924,840,250 dollars, being the assessment on Member States in accordance with its resolution 58/1 B of 23 December 2003;

2. There shall be set off against the assessment on Member States, in accordance with the provisions of General Assembly resolution 973 (X) of 15 December 1955, their respective share in the Tax Equalization Fund in the total amount of 218,242,100 dollars, consisting of:

(a) 200,867,400 dollars, being half of the estimated staff assessment income approved for the biennium 2006-2007 in resolution B above;

**Capital master plan**

2. *Authorizes* the Secretary-General to proceed with design work, related project management and management of pre-construction services to the extent that those activities can be implemented without prejudice to the decision to be taken by the Assembly at a later stage regarding its selection of the strategy for implementation of the capital master plan;

3. *Decides* to convert 8,198,000 United States dollars of the existing commitment authority into an appropriation with assessment for the year 2006 so as to provide for the continuation of design work and related project management and management of the pre-construction phase, including swing space requirements, as a minimum amount that would be required for capital master plan implementation

**Draft resolution IV**  
**Unforeseen and extraordinary expenses for the biennium**  
**2006-2007**

*The General Assembly*

1. *Authorizes* the Secretary-General, with the prior concurrence of the Advisory Committee on Administrative and Budgetary Questions and subject to the Financial Regulations and Rules of the United Nations<sup>1</sup> and the provisions of paragraph 3 below, to enter into commitments in the biennium 2006-2007 to meet unforeseen and extraordinary expenses arising either during or subsequent to the biennium, provided that the concurrence of the Advisory Committee shall not be necessary for:

(a) Such commitments not exceeding a total of 8 million United States dollars in any one year of the biennium 2006-2007 as the Secretary-General certifies relate to the maintenance of peace and security;

(b) Such commitments as the President of the International Court of Justice certifies relate to expenses occasioned by:

(i) The designation of ad hoc judges (Statute of the International Court of Justice, Article 31), not exceeding a total of 200,000 dollars;

(ii) The calling of witnesses and the appointment of experts (Statute, Article 50) and the appointment of assessors (Statute, Article 30), not exceeding a total of 50,000 dollars;

(iii) The maintenance in office for the completion of cases of judges who have not been re-elected (Statute, Article 13, paragraph 3), not exceeding a total of 40,000 dollars;

(iv) The payment of pensions and travel and removal expenses of retiring judges and travel and removal expenses and installation grant of members of the Court (Statute, Article 32, paragraph 7), not exceeding a total of 410,000 dollars;

(v) The work of the Court or its Chambers away from The Hague (Statute, Article 22), not exceeding a total of 25,000 dollars;

(c) Such commitments not exceeding a total of 1 million dollars in the biennium 2006-2007 as the Secretary-General certifies are required for security measures pursuant to section XI, paragraph 6, of resolution 59/276 of 23 December 2004;

2. *Resolves* that the Secretary-General shall report to the Advisory Committee and to the General Assembly at its sixty-first and sixty-second sessions all commitments made under the provisions of the present resolution, together with the circumstances relating thereto, and shall submit supplementary estimates to the Assembly in respect of such commitments;

3. *Decides* that for the biennium 2006-2007, if a decision of the Security Council results in the need for the Secretary-General to enter into commitments

relating to the maintenance of peace and security in an amount exceeding 10 million dollars in respect of the decision, that matter shall be brought to the General Assembly, or, if the Assembly is suspended or not in session, a resumed or special session of the Assembly shall be convened by the Secretary-General to consider the matter.

## **Draft resolution V**

### **Working Capital Fund for the biennium 2006-2007**

*The General Assembly*

*Resolves that:*

1. The Working Capital Fund shall be established for the biennium 2006-2007 in the amount of 100 million United States dollars;

2. Member States shall make advances to the Working Capital Fund in accordance with the scale of assessments adopted by the General Assembly for contributions of Member States to the budget for the year 2006;

3. There shall be set off against this allocation of advances:

(a) Credits to Member States resulting from transfers made in 1959 and 1960 from the surplus account to the Working Capital Fund in an adjusted amount of 1,025,092 dollars;

(b) Cash advances paid by Member States to the Working Capital Fund for the biennium 2004-2005 in accordance with General Assembly resolution 58/274 of 23 December 2003;

4. Should the credits and advances paid by any Member State to the Working Capital Fund for the biennium 2004-2005 exceed the amount of that Member State's advance under the provisions of paragraph 2 above, the excess shall be set off against the amount of the contributions payable by the Member State in respect of the biennium 2006-2007;

5. The Secretary-General is authorized to advance from the Working Capital Fund:

(a) Such sums as may be necessary to finance budgetary appropriations pending the receipt of contributions; sums so advanced shall be reimbursed as soon as receipts from contributions are available for that purpose;

(b) Such sums as may be necessary to finance commitments that may be duly authorized under the provisions of the resolutions adopted by the General Assembly, in particular resolution 60/249 of 23 December 2005 relating to unforeseen and extraordinary expenses; the Secretary-General shall make provision in the budget estimates for reimbursing the Working Capital Fund;

(c) Such sums as may be necessary to continue the revolving fund to finance miscellaneous self-liquidating purchases and activities, which, together with net sums outstanding for the same purpose, do not exceed 200,000 dollars; advances in excess of 200,000 dollars may be made with the prior concurrence of the Advisory Committee on Administrative and Budgetary Questions;

(d) With the prior concurrence of the Advisory Committee, such sums as may be required to finance payments of advance insurance premiums where the period of insurance extends beyond the end of the biennium in which payment is made; the Secretary-General shall make provision in the budget estimates of each biennium, during the life of the related policies, to cover the charges applicable to each biennium;



(e) Such sums as may be necessary to enable the Tax Equalization Fund to meet current commitments pending the accumulation of credits; such advances shall be repaid as soon as credits are available in the Tax Equalization Fund;

6. Should the provision in paragraph 1 above prove inadequate to meet the purposes normally related to the Working Capital Fund, the Secretary-General is authorized to utilize, in the biennium 2006-2007, cash from special funds and accounts in his custody, under the conditions approved by the General Assembly in its resolution 1341 (XIII) of 13 December 1958, or the proceeds of loans authorized by the Assembly.
