### Macroeconomic policy questions

#### Report of the Second Committee\*

1. At its 2nd plenary meeting, on 13 September 2006, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-first session the item entitled:

“Macroeconomic policy questions:

“(a) International trade and development;

“(b) International financial system and development;

“(c) External debt crisis and development;

“(d) Commodities”

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate jointly on sub-items (b) to (d) at its 7th and 8th meetings, on 9 October 2006, and on sub-item (a) at its 13th and 14th meetings, on 17 October. An account of the Committee’s discussion of the item is contained in the relevant summary records (A/C.2/61/SR.7, 8, 13 and 14). Attention is also drawn to the general debate held by the Committee at its 2nd to 6th meetings, from 2 to 4 October (see A/C.2/61/SR.2-6). An account of the Committee’s further consideration of the item will be given in the addenda to the present report.

At the 7th meeting, on 9 October, introductory statements were made under sub-items (b) to (d) by the Chief of the Policy Analysis and Development Branch, Financing for Development Office, Department of Economic and Social Affairs; the Chief of the Debt and Development Finance Branch, Division on Globalization and Development Strategies, UNCTAD; and the Chief of the Commodities Branch, Division on International Trade in Goods and Services and Commodities, UNCTAD (see A/C.2/61/SR.7).

5. Also at the 7th meeting, the High Representative for the Least Developed Countries, Landlocked Developing Countries and Small Island Developing States made a statement (see A/C.2/61/SR.7).

6. At the 13th meeting, on 17 October, introductory statements were made under sub-item (a) by the Secretary-General of UNCTAD and the President of the Trade and Development Board (see A/C.2/61/SR.13).

7. At the same meeting, a question was posed by the delegation of Benin, to which the Secretary-General of UNCTAD responded (see A/C.2/61/SR.13).
