

1. At its 2nd plenary meeting, on 13 September 2006, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-first session the item entitled

"Groups of countries in special situations:

- "(a) Third United Nations Conference on the Least Developed Countries;
- "(b) Specific actions related to the particular needs and problems of landlocked developing countries: outcome of the International Ministerial Conference of Landlocked and Transit Developing Countries and Donor Countries and International Financial and Development Institutions on Transit Transport Cooperation"

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 26th, 28th and 29th meetings, on 8, 10 and 14 November 2006.
