Programme budget for the biennium 2006-2007

Report of the Fifth Committee

Rapporteur: Mr. Diego **Simancas** (Mexico)

I. Introduction

1. At its 2nd plenary meeting, on 13 September 2006, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-first session the item entitled “Programme budget for the biennium 2006-2007” and to allocate it to the Fifth Committee.
2. The Fifth Committee considered the item at its 6th, 10th, 13th, 18th, 19th, 22nd, 24th, 27th, 28th, 34th, 35th, 36th and 37th meetings, on 16, 25 and 31 October, 6, 9, 17 and 22 November, and 7, 11, 18 and 20 to 22 December 2006. Statements and observations made in the course of the Committee’s consideration of the item are reflected in the relevant summary records (A/C.5/61/SR.6, 10, 13, 18, 19, 22, 24, 27, 28, 34, 35, 36 and 37).
3. Section II of the present report contains a summary of the recommendations made by the Fifth Committee during the sixty-first session of the General Assembly on the revised estimates submitted by the Secretary-General and on the programme budget implications of resolutions adopted by the Assembly, either on the recommendation of its Main Committees or in respect of items considered in plenary meeting.
4. Section III contains a summary of the special subjects considered by the Fifth Committee that led to the adoption of specific decisions to be recommended for adoption by the General Assembly.
5. The recommendations of the Fifth Committee are contained in section IV.



II. Programme budget for the biennium 2006-2007

6. In its resolutions 60/247 A and B of 23 December 2005, the General Assembly approved budget appropriations for the biennium 2006-2007 in the amount of \$3,798,912,500 and income estimates in the amount of \$427,355,200. By its resolutions 60/281 and 60/283 of 30 June 2006 and 7 July 2006, further appropriations were approved resulting in revised appropriations of \$3,829,916,200 and revised income estimates in the amount of \$434,860,100.

7. Recommendations of the Fifth Committee during the current session of the General Assembly on revised estimates submitted by the Secretary-General, as well as on the programme budget implications of resolutions adopted by the Assembly under items considered by other Main Committees or in respect of items considered in plenary meeting, have resulted in a net increase in the approved level of appropriations in the amount of \$343,979,700 and a net increase in the approved income estimates in the amount of \$51,509,800.

8. The revised estimates of expenditure and income approved by the Fifth Committee and the financial implications of resolutions recommended by other Main Committees and subsequently by the General Assembly are indicated, by expenditure and income section, in the following table:

9. At its 37th meeting, on 22 December, the Committee considered the revised estimates of expenditure and income to be recommended for approval by the General Assembly for the biennium 2006-2007, as well as the financing of the appropriations for the year 2007. The Committee took the following action:

(a) The Committee approved the revised budget appropriations for the biennium 2006-2007 (see para. 37, draft resolution II.A);

(b) The Committee approved revised income estimates for the biennium 2006-2007 (see para. 37, draft resolution II.B);

(c) The Committee approved the draft resolution on the financing of appropriations for the year 2007 (see para. 37, draft resolution II.C).

III. Consideration of questions relating to the programme budget for the biennium 2006-2007

Construction of additional conference facilities at the Vienna International Centre

10. The Committee considered this question at its 6th meeting, on 16 October. It had before it the report of the Secretary-General (A/61/166), and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/361).

11. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled "Construction of additional conference facilities at the Vienna International Centre" (A/C.5/61/L.25, sect. I), informal consultations on which had been coordinated by the representative of Côte d'Ivoire. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. I).

Construction of additional office facilities at the Economic Commission for Africa in Addis Ababa

12. The Committee considered this question at its 6th meeting, on 16 October. It had before it the report of the Secretary-General (A/61/158), and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/362).

13. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled "Construction of additional conference facilities at the Economic Commission for Africa in Addis Ababa" (A/C.5/61/L.25, sect. II), informal consultations on which had been coordinated by the representative of Côte d'Ivoire. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. II).

Contingent liability reserve for the United Nations Postal Administration

14. The Committee considered this question at its 6th meeting, on 16 October. It had before it the report of the Secretary-General (A/61/295), and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/480).

15. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled "Contingent liability reserve for the United

Nations Postal Administration” (A/C.5/61/L.25, sect. III), informal consultations on which had been coordinated by the representative of Yemen. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. III).

Identification of additional resources for the Development Account

16. The Committee considered this question at its 6th meeting, on 16 October. It had before it the report of the Secretary-General (A/61/282), and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/479).

17. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “Identification of additional resources for the Development Account” (A/C.5/61/L.25, sect. IV), informal consultations on which had been coordinated by the representative of Angola. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. IV).

Revised estimates resulting from resolutions and decisions adopted by the Human Rights Council at its first, resumed second, and third sessions and its first, second and third special sessions in 2006

18. The Committee considered this question at its 34th meeting, on 18 December. It had before it the reports of the Secretary-General (A/61/530 and A/61/530/Add.1) and the report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman (see A/C.5/61/SR.34).

19. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “Revised estimates arising out of resolutions and decisions adopted by the Human Rights Council at its first, resumed second, and third sessions and its first, second and third special sessions in 2006” (A/C.5/61/L.25, sect. V), informal consultations on which had been coordinated by the representative of Morocco. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. V).

Administrative and financial implications of the decisions and recommendations contained in the reports of the International Civil Service Commission for 2005 and 2006

20. The Committee considered this question at its 10th meeting, on 25 October. It had before it the reports of the Secretary-General (A/61/381, A/61/30 and Corr.1), and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/484).

21. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “Administrative and financial implications of the decisions and recommendations contained in the reports of the International Civil Service Commission for 2005 and 2006” (A/C.5/61/L.25, sect. VI), informal consultations on which had been coordinated by the representative of Morocco. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. VI).

Estimates in respect of special political missions, good offices and other political initiatives authorized by the General Assembly and/or the Security Council

22. The Committee considered this question at its 34th meeting, on 18 December. It had before it the reports of the Secretary-General (A/61/525 and Add.1-3 and Add.3/Corr.1 and Add.4 and Add.5), the report of the Office of Internal Oversight Services (A/61/357) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/640).

23. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “Estimates in respect of special political missions, good offices and other political initiatives authorized by the General Assembly and/or the Security Council” (A/C.5/61/L.25, sect. VII), informal consultations on which had been coordinated by the representative of Namibia. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. VII).

First performance report on the programme budget for the biennium 2006-2007

24. The Committee considered this question at its 34th meeting, on 18 December. It had before it the reports of the Secretary-General (A/61/593 and Add.1) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/635).

25. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “First performance report on the programme budget for the biennium 2006-2007” (A/C.5/61/L.25, sect. VIII), informal consultations on which had been coordinated by the representative of Bangladesh. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. VIII).

Revised estimates resulting from resolutions and decisions adopted by the Economic and Social Council at its substantive session of 2006

26. The Committee considered this question at its 34th meeting, on 18 December. It had before it the report of the Secretary-General (A/61/370 and Corr.1), and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/61/498).

27. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “Revised estimates resulting from resolutions and decisions adopted by the Economic and Social Council at its substantive session of 2006” (A/C.5/61/L.25, sect. IX), informal consultations on which had been coordinated by the representative of Morocco. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. IX).

Administrative and financial implications arising from the report of the United Nations Joint Staff Pension Board

28. The Committee considered this question at its 27th meeting, on 7 December. It had before it the report of the Secretary-General (A/61/577) and the report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman (see A/C.5/61/SR.27).

29. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “Administrative and financial implications arising from the report of the United Nations Joint Staff Pension Board” (A/C.5/61/L.25, sect. X), informal consultations on which had been coordinated by the representative of Morocco. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. X).

Strengthening the United Nations Crime Prevention and Criminal Justice Programme and the role of the Commission on Crime Prevention and Criminal Justice as its governing body

30. The Committee considered this question at its 27th meeting, on 7 December. It had before it the report of the Secretary-General (A/C.5/61/10) and the report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman (see A/C.5/61/SR.27).

31. At the 37th meeting, on 22 December, the Chairman of the Committee introduced a draft resolution entitled “Strengthening the United Nations Crime Prevention and Criminal Justice Programme and the role of the Commission on Crime Prevention and Criminal Justice as its governing body” (A/C.5/61/L.25, sect. XI), informal consultations on which had been coordinated by the representative of Morocco. At the same meeting, the Committee adopted the draft resolution without a vote (see para. 37, draft resolution I, sect. XI).

Contingency fund

32. The Committee considered this question at its 37th meeting, on 22 December. At the same meeting the Committee decided, without a vote, to recommend to the General Assembly that it note that a balance of 637,300 dollars would remain in the contingency fund (see para. 37, draft resolution I, sect. XII).

United Nations Fund for International Partnerships

33. The Committee considered this question at its 19th meeting, on 9 November. It had before it the report of the Secretary-General (A/61/189).

34. At the 19th meeting, on 9 November, the Chairman of the Committee introduced an oral draft decision entitled “United Nations Fund for International Partnerships”. At the same meeting, the Committee adopted the draft decision without a vote (see para. 38, draft decision I).

Comprehensive review of governance and oversight within the United Nations and its funds, programmes and specialized agencies

35. The Committee considered this question at its 35th meeting, on 20 December. It had before it the report of the Secretary-General (A/C.5/61/17) and the related oral report of the Advisory Committee on Administrative and Budgetary Questions (A/C.5/61/SR.35).

36. At the 35th meeting, on 20 December, the Chairman of the Committee introduced a draft decision entitled “Review of governance and oversight within the United Nations and its funds, programmes and specialized agencies”, informal consultations on which had been coordinated by the representative of Belgium. At the same meeting, the Committee adopted the draft decision without a vote (see para. 38, draft decision II).

IV. Recommendations of the Fifth Committee

37. The Fifth Committee recommends to the General Assembly the adoption of the following draft resolutions:

Draft resolution I

Questions relating to the programme budget for the biennium 2006-2007

The General Assembly,

I

Construction of additional conference facilities at the Vienna International Centre

Having considered the report of the Secretary-General¹ and the related report of the Advisory Committee on Administrative and Budgetary Questions,²

1. *Takes note with appreciation* of the efforts by the Government of Austria, as host country, to construct conference facilities at the Vienna International Centre;

2. *Takes note* of the report of the Secretary-General,¹ and endorses the related observations and recommendations of the Advisory Committee on Administrative and Budgetary Questions contained in its report;²

II

Construction of additional office facilities at the Economic Commission for Africa in Addis Ababa

Trust Fund for Social Defence²⁷ was renamed the United Nations Crime Prevention and Criminal Justice Fund and became an integral part of the Programme,

Recalling also its resolution 55/25 of 15 November 2000, in which it decided that, until the Conference of the Parties to the United Nations Convention against Transnational Organized Crime decided otherwise, the account referred to in article 30 of the Convention²⁸ would be operated within the United Nations Crime Prevention and Criminal Justice Fund,

Recalling further its resolution 58/4 of 31 October 2003, in which it decided that, until the Conference of the States Parties to the United Nations Convention against Corruption decided otherwise, the account referred to in article 62 of the Convention²⁹ would be operated within the United Nations Crime Prevention and Criminal Justice Fund,

Taking note of the Secretary-General's bulletin on the organization of the United Nations Office on Drugs and Crime,³⁰ by which the Secretary-General decided that the United Nations Office on Drugs and Crime would be established to implement the Organization's drug programme and crime programme in an integrated manner and that the Executive Director would be responsible for all the activities of the Office, as well as its administration,

Considering that, starting from the biennium 2004-2005, a consolidated budget for the United Nations Office on Drugs and Crime has been prepared, including budgets for its drug and crime programmes,

Considering also that the Commission on Crime Prevention and Criminal Justice, in accordance with the procedures established by the General Assembly in its resolution 41/213 of 19 December 1986 and relevant subsequent resolutions, already provides its views and guidance on the proposed biennial programme plan and on the crime programme, which forms the basis for the formulation of the proposed programme budget for the next biennium and whose narrative part is subsequently considered by the Commission,

Noting the delegation of authority for the management of the United Nations Crime Prevention and Criminal Justice Fund from the Secretary-General to the Director-General of the United Nations Office at Vienna,

Considering that it would be opportune to grant the Commission on Crime Prevention and Criminal Justice the same powers with respect to the United Nations Crime Prevention and Criminal Justice Fund as the Commission on Narcotic Drugs has with respect to the Fund of the United Nations International Drug Control Programme,

Having considered the letter dated 19 October 2006 from the Chairman of the Third Committee addressed to the Chairman of the Fifth Committee³¹ transmitting a draft resolution entitled "Strengthening the United Nations Crime Prevention and Criminal Justice Programme and the role of the Commission on Crime Prevention and Criminal Justice as its governing body", the relevant note by the Secretary-

General,³² and the related report of the Advisory Committee on Administrative and Budgetary Questions,³³

1. *Authorizes* the Commission on Crime Prevention and Criminal Justice, as the principal United Nations policymaking body on crime prevention and criminal justice issues, to approve, on the basis of the proposals of the Executive Director of the United Nations Office on Drugs and Crime, bearing in mind the comments and recommendations of the Advisory Committee on Administrative and Budgetary Questions, the budget of the United Nations Crime Prevention and Criminal Justice Fund, including its administrative and programme support costs budget, other than expenditures borne by the regular budget of the United Nations, without prejudice to the powers of the Conference of the Parties to the United Nations Convention against Transnational Organized Crime, as provided for in that Convention,²⁸ and to the powers of the Conference of the States Parties to the United Nations Convention against Corruption, as provided for in that Convention;²⁹

3. *Requests* the Commission on Crime Prevention and Criminal Justice to report to the General Assembly at its sixty-second session, through the Economic and Social Council, on the ways in which it plans to carry out the administrative and financial functions;

4. *Requests* the Secretary-General to promulgate financial rules for the United Nations Crime Prevention and Criminal Justice Fund, in accordance with the Financial Regulations and Rules of the United Nations,³⁴ it being understood that the references in the said financial rules to the role and functions of the Commission on Crime Prevention and Criminal Justice shall be consistent with the role of the Commission given in paragraph 1 above;

5. *Decides* that, notwithstanding regulations 6.1 and 6.5 of the Financial Regulations of the United Nations, the Executive Director of the United Nations Office on Drugs and Crime shall maintain the accounts of the Fund and shall be responsible for submitting the said accounts and related financial statements, no later than 31 March following the end of the financial period, to the Board of Auditors and for submitting financial reports to the Commission on Crime Prevention and Criminal Justice and to the General Assembly;

Draft decision II
Comprehensive review of governance and oversight within
the United Nations and its funds, programmes and
specialized agencies

The General Assembly, having considered the statement submitted by the Secretary-General¹ of programme budget implications of draft resolution A/C.5/61/L.15 and the related oral report of the Advisory Committee on Administrative and Budgetary Questions:²

(a) Notes that, should it adopt the draft resolution entitled “Comprehensive review of governance and oversight within the United Nations and its funds, programmes and specialized agencies”,³ the activities requested under the resolution would be added to the programme of work approved in resolution 60/246, under section 28, Management and support service;

(b) Also notes that resource requirements for the activities requested would amount to \$1,316,200 gross (or \$1,206,300 net) for the biennium 2006-2007 to be accommodated to the fullest extent possible from within the appropriations available under sections 28A, Office of the Under-Secretary-General for Management, 28D, Office of Central Support Services, and 35, Staff assessment, to be offset by an equivalent amount under income section 1, Income from staff assessment, and any additional requirements as may be necessary would be reported in the context of the second performance report for the biennium 2006-2007.
