

# Report of the Second Committee\*

- 1. At its 3rd plenary meeting, on 21 September 2007, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-second session the item entitled:
  - "Macroeconomic policy questions:
  - "(a) International trade and development;
  - "(b) International financial system and development;
  - "(c) External debt crisis and development"

and to allocate it to the Second Committee.

- 2. The Second Committee held a substantive debate jointly on sub-items (b) and (c) at its 7th and 8th meetings, on 15 October 2007, and on sub-item (a) at its 13th, 14th and 15th meetings, on 25 October, 26 October and 29 October. An account of the Committee's discussion of the item is contained in the relevant summary records (A/C.2/62/SR.7, 8, 13, 14 and 15).
