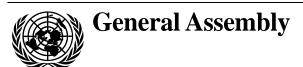

# Eradication of poverty and other development issues

## Report of the Second Committee\*

1. At its 3rd plenary meeting, on 21 September 2007, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-second session the item entitled:

"Eradication of poverty and other development issues:

- "(a) Implementation of the first United Nations Decade for the Eradication of Poverty (1997-2006);
- "(b) Women in development;
- "(c) Human resources development"

and to allocate it to the Second Committee.

- 2. The Second Committee held a substantive debate on the item at its 23rd, 24th and 25th meetings, on 6 and 8 November 2007.
