

I. Introduction

1. At its 3rd plenary meeting, on 21 September 2007, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-second session the item entitled:

"Promotion and protection of human rights:

- "(a) Implementation of human rights instruments;
- "(b) Human rights questions, including alternative approaches for improving the effective enjoyment of human rights and fundamental freedoms;
- "(c) Human rights situations and reports of special rapporteurs and representatives;
- "(d) Comprehensive implementation of and follow-up to the Vienna Declaration and Programme of Action;
- "(e) Convention on the Rights of Persons with Disabilities;
- "(f) Celebration of the sixtieth anniversary of the Universal Declaration of Human Rights";

and to allocate it to the Third Committee.
