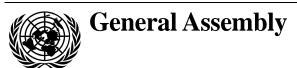

Revitalization of the work of the General Assembly

Report of the Third Committee

- 1. At its 2nd plenary meeting, on 18 September 2009, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-fourth session the item entitled "Revitalization of the work of the General Assembly" and to allocate it to all the Main Committees for the sole purpose of considering and taking action on their respective tentative programmes of work.
- 2. The Third Committee considered the item at its 47th meeting, on 24 November 2009 (see A/C.3/64/SR.47). It had before it a tentative programme of work of the Third Committee for the sixty-fifth session of the General Assembly (A/C.3/64/L.64), submitted by the Chairperson.
- 3. At its 47th meeting, the Committee approved its tentative programme of work for the sixty-fifth session, as contained in document A/C.3/64/L.64, and decided to transmit it to the General Assembly (see para. 4).

Recommendation of the Third Committee

4. The Third Committee recommends to the General Assembly the adoption of the following draft decision:
