### **International Commission against Impunity in Guatemala**

*The General Assembly,*

*Recalling* its relevant resolutions on the situation in Central America, and particularly resolution 63/19 of 10 November 2008 regarding the activities of the International Commission against Impunity in Guatemala,

*Bearing in mind* the Agreement between the United Nations and the State of Guatemala on the establishment of an International Commission against Impunity in Guatemala, which was signed on 12 December 2006, approved by the Guatemalan Congress on 1 August 2007 and entered into force on 4 September 2007 for an initial period of two years,

*Noting* that, in accordance with article 14 of the Agreement, the Commission's mandate was extended for an additional two years, starting 4 September 2009, through an exchange of letters between the Government of Guatemala and the Secretary-General of the United Nations on 20 March 2009 and 15 April 2009, respectively, and approved by the Guatemalan Congress on 16 July 2009,

*Bearing in mind* that the Commission has carried out its activities through voluntary contributions of Member States and other donors from the international community and plans to do so in the future,

*Noting* that the Government of Guatemala has provided additional budgetary allotments to State institutions to support their work in collaboration with the Commission,

*Convinced* that, pursuant to Articles 55 and 56 of its Charter, the United Nations promotes respect for human rights and fundamental freedoms for all and that Member States pledge themselves to take action in cooperation with the Organization for the achievement of that purpose,

1. *Takes note* of the report of the Secretary-General regarding the current state and activities of the International Commission against Impunity in Guatemala,<sup>1</sup> which describes the important progress achieved as well as the significant operational challenges that result from the International Commission's present status as a non-United Nations body;

2. *Requests* the Secretary-General to undertake with the Government of Guatemala the steps necessary to address these operational challenges, and to enhance the role that the United Nations plays in providing effective and efficient assistance to the Commission within the framework of its founding agreement signed on 12 December 2006;

3. *Calls upon* the Government of Guatemala to continue providing all the support necessary to consolidate the achievements and overcome the challenges outlined in the Secretary-General's report;

4. *Also calls upon* the Government of Guatemala to persist in and redouble its efforts to strengthen the institutions that buttress the rule of law and the defence of human rights, and commends it for its commitment to combat impunity;

5. *Expresses its appreciation* to those Member States and other donors that have supported the International Commission against Impunity in Guatemala, through voluntary contributions, financial and in kind, and urges them to continue their support;

6. *Requests* the Secretary-General to periodically keep the General Assembly apprised of the work of the Commission and the implementation of the present resolution.
