Report of the Second Committee*

1. At its 2nd plenary meeting, on 17 September 2010, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-fifth session the item entitled:

"Macroeconomic policy questions:

- "(a) International trade and development;
- "(b) International financial system and development;
- "(c) External debt sustainability and development"

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate jointly on sub-items (b) and (c) at its 8th and 9th meetings, on 11 October 2010, and a substantive debate on sub-item (a) at its 27th meeting, on 4 November. An account of the Committee's discussion of the item is contained in the relevant summary records (A/C.2/65/SR.8, 9 and 27). Attention is also drawn to the general debate held by the Committee at its 2nd to 6th meetings, from 4 to 6 October (see A/C.2/65/SR.2-6). An account of the Committee's further consideration of the item will be given in the addenda to the present report.
