Globalization and interdependence: role of the United Nations in promoting development in the context of globalization and interdependence

Report of the Second Committee*

Rapporteur: Mr. Paul Losoko Efambe Empole (Democratic Republic of the Congo)

I. Introduction

1. The Second Committee held a substantive debate on agenda item 22 (see A/65/438, para. 2). Action on sub-item (a) was taken at the 27th and 33rd meetings, on 4 November and 1 December 2010. An account of the Committee's consideration of the sub-item is contained in the relevant summary records (A/C.2/65/SR.27 and 33).

II. Consideration of proposals

A. Draft resolution A/C.2/65/L.15 and Rev.1

2. At the 27th meeting, on 4 November, the representative of Yemen, on behalf of the States Members of the United Nations that are members of the Group of 77 and China, introduced a draft resolution entitled "Role of the United Nations in promoting development in the context of globalization and interdependence" (A/C.2/65/L.15), which read:

"The General Assembly,

"*Recalling* its resolutions 62/199 of 19 December 2007, 63/222 of 19 December 2008 and 64/210 of 21 December 2009 on the role of the United Nations in promoting development in the context of globalization and interdependence,

"Recalling also the Monterrey Consensus of the International Conference on Financing for Development and the Doha Declaration on Financing for Development,

"Recalling further its resolution 63/303 of 9 July 2009 on the Outcome of the Conference on the World Financial and Economic Crisis and Its Impact on Development,

"Recalling the outcome document of the High-level Plenary Meeting of the sixty-fifth session of the General Assembly on the Millennium Development Goals,

"Recalling also General Assembly resolution 63/199 of 19 December 2008 on social justice for a fair globalization, in which the Assembly took note with interest of the adoption of the Declaration on Social Justice for a Fair Globalization,

"*Recalling further* the 2005 World Summit Outcome and all relevant General Assembly resolutions, in particular those that have built upon the 2005 World Summit Outcome, in the economic, social and related fields, including Assembly resolution 60/265 of 30 June 2006 entitled 'Follow-up to the development outcome of the 2005 World Summit, including the Millennium Development Goals and the other internationally agreed development goals',

"Reaffirming that the United Nations has the central and leading role in promoting international cooperation for development and in promoting policy coherence on global development issues, including in the context of globalization and interdependence,

"Reaffirming also the resolve expressed in the United Nations Millennium Declaration to ensure that globalization becomes a positive force for all,

"Recognizing that globalization and interdependence imply that the economic performance of a country is increasingly affected by factors outside its geographical borders and that maximizing in an equitable manner the benefits of globalization requires developing responses to globalization through a strengthened global partnership for development to achieve the internationally agreed development goals, including the Millennium Development Goals,

"*Reaffirming its strong support* for fair and inclusive globalization and the need to translate growth into poverty reduction and in this regard its resolve to make the goals of full and productive employment and decent work for all, including for women and young people, a central objective of relevant national and international policies as well as national development strategies, including poverty reduction strategies, as part of efforts to achieve the Millennium Development Goals,

"1. *Recognizes* that some countries have successfully adapted to the changes and have benefited from globalization but that many others, especially the least developed countries, have remained marginalized in the globalizing world economy, and recognizes also that, as stated in the United Nations Millennium Declaration the benefits are very unevenly shared, while the costs are unevenly distributed;

"2. *Reaffirms* the need for the United Nations to play a fundamental role in the promotion of international cooperation for development and the coherence, coordination and implementation of development goals and actions agreed upon by the international community, and resolves to strengthen coordination within the United Nations system in close cooperation with all other multilateral financial, trade and development institutions in order to support sustained economic growth, poverty eradication and sustainable development;

"3. *Recognizes* that the scaling up of the successful policies and approaches in the implementation and the achievement of the Millennium Development Goals needs to be complemented by a strengthened global partnership for development;

"4. *Reaffirms* the strengthening of the central role of the United Nations in enhancing partnerships for development, with a view to creating a supportive global environment for the attainment of the Millennium Development Goals, including accelerating efforts to deliver and fully implement existing Millennium Development Goal 8 commitments;

"5. *Stresses* that regional, subregional and interregional cooperation can play an important role in helping developing countries to integrate the global economy and to achieve their development objectives as well as in promoting a global partnership for development;

"6. *Reaffirms* that the increasing interdependence of national economies in a globalizing world and the emergence of rules-based regimes for international economic relations have meant that the space for national economic policy, that is, the scope for domestic policies, especially in the areas of trade, investment and international development, is now often framed by international disciplines, commitments and global market considerations and that it is for each Government to evaluate the trade-off between the benefits of accepting international rules and commitments and the constraints posed by the loss of policy space;

"7. *Expresses deep concern* regarding the continued high rates of unemployment, underemployment and employment insecurity as a consequence of the global financial and economic crisis, recognizes that decent work remains one of the best routes out of poverty, and in this regard urges Member States to promote the Global Jobs Pact as a general framework within which each country can formulate policy packages specific to its situation and national priorities in order to promote a job-intensive recovery and sustainable development, and also urges donor countries, multilateral organizations and other development partners to intensify assistance to developing countries to implement the Global Jobs Pact;

"8. *Recognizes* that policies which link economic and social development can contribute to reducing inequalities within and among countries with a view to guaranteeing that the poor and those living in the most vulnerable situations maximize their benefits from economic growth and development;

"9. Underlines the fact that, in addressing the linkages between globalization and sustainable development, particular focus should be placed

on identifying and implementing mutually reinforcing policies and practices that promote sustained economic growth, social development and environmental protection and that this requires efforts at both the national and international levels;

"10. *Stresses* the need for all countries to harness knowledge and technology and stimulate innovation if they are to improve their competitiveness, benefit from trade and investment and promote sustainable development, and in this regard underlines the importance of concrete actions to facilitate the transfer of technology under fair, transparent and mutually agreed terms to developing countries in support of the implementation of their development strategies;

"11. *Requests* the Secretary-General to submit to the General Assembly at its sixty-sixth session a report on the theme 'Globalization and interdependence: sustained, inclusive and equitable economic growth for a fair and more equitable globalization for all, including job creation';

"12. *Decides* to include in the provisional agenda of its sixty-sixth session, under the item entitled 'Globalization and interdependence', the subitem entitled 'Role of the United Nations in promoting development in the context of globalization and interdependence'."

3. At its 33rd meeting, on 1 December, the Committee had before it a revised draft resolution entitled "Role of the United Nations in promoting development in the context of globalization and interdependence" (A/C.2/65/L.15/Rev.1), submitted by Yemen, on behalf of the States Members of the United Nations that are members of the Group of 77 and China.

4. The Secretary of the Committee announced that consensus had been reached, and that the Committee would consider the text contained in document A/C.2/65/L.15/Rev.1 as a draft resolution submitted by the Vice-Chair, Jean Claudy Pierre (Haiti), on the basis of informal consultations held on draft resolution A/C.2/65/L.15.

5. At the same meeting, upon the proposal of the Chair, the Committee agreed to waive rule 120 of the rules of procedure of the General Assembly and proceed to act on draft resolution A/C.2/65/L.15/Rev.1.

6. Also at the same meeting, the Committee was informed that the draft resolution had no programme budget implications.

7. Also, at the 33rd meeting, the representative of France made corrections to the French text of the draft resolution (see A/C.2/65/SR.33).

8. At the same meeting, the Committee adopted draft resolution A/C.2/65/L.15/Rev.1 (see para. 11).

9. In the light of the adoption of draft resolution A/C.2/65/L.15/Rev.1, draft resolution A/C.2/65/L.15 was withdrawn by its sponsors.

B. Draft decision proposed by the Chair

10. At its 33rd meeting, on the proposal of the Chair, the Committee decided to recommend that the General Assembly take note of the report of the Secretary-General entitled "An overview of the major international economic and policy challenges for equitable and inclusive sustained economic growth and sustainable development, and of the role of the United Nations in addressing these issues in the light of the New International Economic Order" (A/65/272) (see para. 12).

III. Recommendations of the Second Committee

11. The Second Committee recommends to the General Assembly the adoption of the following draft resolution:

Role of the United Nations in promoting development in the context of globalization and interdependence

The General Assembly,

Recalling its resolutions 62/199 of 19 December 2007, 63/222 of 19 December 2008 and 64/210 of 21 December 2009 on the role of the United Nations in promoting development in the context of globalization and interdependence,

Recalling also the Monterrey Consensus of the International Conference on Financing for Development¹ and the Doha Declaration on Financing for Development,²

Recalling further its resolution 63/303 of 9 July 2009 on the Outcome of the Conference on the World Financial and Economic Crisis and Its Impact on Development,

Recalling the outcome document of the High-level Plenary Meeting of the sixty-fifth session of the General Assembly on the Millennium Development Goals,³

Recalling also General Assembly resolution 63/199 of 19 December 2008 on social justice for a fair globalization, in which the Assembly took note with interest of the adoption of the Declaration on Social Justice for a Fair Globalization,⁴

Recalling further the 2005 World Summit Outcome⁵ and all relevant General Assembly resolutions, in particular those that have built upon the 2005 World Summit Outcome, in the economic, social and related fields, including Assembly resolution 60/265 of 30 June 2006 entitled "Follow-up to the development outcome of the 2005 World Summit, including the Millennium Development Goals and the other internationally agreed development goals",

Reaffirming that the United Nations has the central role in promoting international cooperation for development and in promoting policy coherence on global development issues, including in the context of globalization and interdependence,

Reaffirming also the resolve expressed in the United Nations Millennium Declaration⁶ to ensure that globalization becomes a positive force for all,

Recognizing that globalization and interdependence imply that the economic performance of a country is increasingly affected by factors outside its geographical

borders and that maximizing in an equitable manner the benefits of globalization requires developing responses to globalization through a strengthened global partnership for development to achieve the internationally agreed development goals, including the Millennium Development Goals,

Reaffirming its strong support for fair and inclusive globalization and the need to translate growth into poverty reduction and in this regard its resolve to make the goals of full and productive employment and decent work for all, including for women and young people, a central objective of relevant national and international policies as well as national development strategies, including poverty reduction strategies, as part of efforts to achieve the Millennium Development Goals,

1. *Recognizes* that some countries have successfully adapted to the changes and have benefited from globalization but that many others, especially the least developed countries, have remained marginalized in the globalizing world economy, and recognizes also that, as stated in the United Nations Millennium Declaration,⁶ the benefits are unevenly shared, while the costs are unevenly distributed;

4. *Reaffirms* the need to strengthen the central role of the United Nations in enhancing the global partnership for development, with a view to creating a supportive global environment for the attainment of the Millennium Development Goals, including accelerating efforts to deliver and fully implement existing global partnership for development;

5. *Stresses* that regional, subregional and interregional cooperation plays an important role in helping developing countries to integrate into the global economy and to achieve their development objectives and the Millennium Development Goals as well as in promoting the global partnership for development;

6. *Recognizes* that the increasing interdependence of national economies in a globalizing world and the emergence of rules-based regimes for international economic relations have meant that the space for national economic policy, that is, the scope for domestic policies, especially in the areas of trade, investment and international development, is now often framed by international disciplines, commitments and global market considerations and that it is for each Government to evaluate the trade-off between the benefits of accepting international rules and commitments and the constraints posed by the loss of policy space;

7. *Notes with concern* the continuing high levels of unemployment as a consequence of the global financial and economic crisis, recognizes that decent work remains one of the best routes out of poverty, and in this regard invites donor

countries, multilateral organizations and other development partners to continue to assist Member States, especially developing countries, in adopting policies consistent with the Global Jobs Pact adopted by the International Labour Organization, as a general framework within which each country can formulate policy packages specific to its situation and national priorities in order to promote a job-intensive recovery and sustainable development;

8. *Recognizes* that policies which link economic and social development can contribute to reducing inequalities within and among countries with a view to guaranteeing that the poor and those living in the most vulnerable situations maximize their benefits from economic growth and development;

9. Underlines the fact that, in addressing the linkages between globalization and sustainable development, particular focus should be placed on identifying and implementing mutually reinforcing policies and practices that promote sustained, inclusive and equitable economic growth and sustainable development, and that this may benefit from efforts to improve policy coherence for development at the national, regional and international levels;

10. Stresses the need for all countries to harness knowledge and technology and stimulate innovation if they are to improve their competitiveness, benefit from trade and investment and promote sustainable development, and in this regard underlines the importance of concrete actions to promote the development and dissemination of appropriate, affordable and sustainable technologies and the transfer of such technologies under fair, transparent and mutually agreed terms to developing countries in support of the implementation of their development strategies;

11. *Requests* the Secretary-General to submit to the General Assembly at its sixty-sixth session a report on the theme "Globalization and interdependence: sustained, inclusive and equitable economic growth for a fair and more equitable globalization for all, including job creation";

12. *Decides* to include in the provisional agenda of its sixty-sixth session, under the item entitled "Globalization and interdependence", the sub-item entitled "Role of the United Nations in promoting development in the context of globalization and interdependence".

12. The Second Committee also recommends to the General Assembly the adoption of the following draft decision:

Report of the Secretary-General concerning the role of the United Nations in promoting development in the context of globalization and interdependence

The General Assembly decides to take note of the report of the Secretary-General entitled "An overview of the major international economic and policy challenges for equitable and inclusive sustained economic growth and sustainable development, and of the role of the United Nations in addressing these issues in the light of the New International Economic Order.¹
